### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Lake State Railway Company 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lake State Railway Company 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### **1. Description of Plan**

The following description of the Lake State Railway Company 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory, defined contribution plan with a 401(k) elective deferral arrangement, which covers substantially all full-time and part-time employees of Lake State Railway Company (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees that are age 18 or older and have completed 6 months of service are eligible to participate in the 401(k)-deferral arrangement of the Plan. Leased employees and certain employees are excluded from the Plan. Participants are automatically enrolled in the Plan at 5% of Plan compensation unless the participant opts out or selects a different deferral.

#### **Contributions**

The Plan allows participants to defer up to a maximum of 100% of their compensation, not to exceed the maximum contribution allowable by the Internal Revenue Code (IRC) adjusted annually for cost-of-living changes. There is no minimum elective deferral limit for the Plan. The Plan allows pre-tax deferrals but does not allow Roth deferrals. Rollover contributions are allowed by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. The Plan allows the Company to make a discretionary employer match and/or contribution. The Company has elected to match 50% of a participant's elective deferral to a maximum of 5% of the participants compensation.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. The participant has the responsibility to decide how his or her contribution will be invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **1. Description of Plan (continued)**

#### **Vesting**

All participants are immediately vested in employer contributions, including both matching or other discretionary contributions. Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon.

#### **Forfeitures**

Forfeitures may be used in any permissible method, such as to reduce Company contributions or pay Plan expenses. Forfeited nonvested accounts totaled \$477 as of December 31, 2024 and \$464 as of December 31, 2023. For the year ended December 31, 2024, no forfeitures were used to fund employer contributions or pay Plan expenses and \$13 of interest was earned. For the year ended December 31, 2023, no forfeitures were used to fund employer contributions, \$148 were used to pay Plan expenses, and \$10 of interest was earned.

#### **Notes Receivable from Participants**

Participants are permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Such loans are secured by the balance of the participant's account and shall be charged an annual prevailing rate of interest to be fixed by the Plan administrator. Participants are eligible to have one loan outstanding at a given time. Such loans shall be fully repaid on or before five years from the date of disbursement.

#### **Payment of Benefits**

Plan participants are eligible to receive distributions upon reaching retirement age of 65. In this instance they are eligible for a normal distribution from their account for the full value of their account balance. Early retirement distributions are available at the age of 60. Upon separation of employment, because of death, disability, or for other reasons, participants receive their benefits as a lump-sum payment.

#### **Administrative Expenses**

Certain administrative expenses were paid for by the Company. Additionally, certain administrative expenses may be paid by the Plan and are reflected in the accompanying financial statements.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis.

#### **Subsequent Events**

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrators to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy.

The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity can access as of the measurement date.

#### **Fair Value Measurements (continued)**

Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect a company’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

#### **Investment Valuation and Income Recognition**

The Plan’s investments are stated at fair market value, except the stable value fund which is stated at contract value. Shares of mutual funds are valued at quoted market prices in an active market, which represents the value of shares held by the Plan at year end. The stable value fund is an investment in a fully benefit-responsive investment contract. The fund invests in the T. Rowe Price Stable Value Fund A, which is a fund investing primarily in guaranteed investment contracts, bank investment contracts, synthetic investment contracts, and separate account contracts. These contracts are designed to potentially provide principal stability and a competitive yield. See Note 5 for more information on the stable value fund.

There are no unfunded commitments related to the stable value fund. The stable value fund has certain restrictions related to withdrawals and exchanges.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The change in aggregate fair value and the cost of investments purchased, sold, and held is reflected in the statements of changes in net assets available for benefits as net appreciation/depreciation in fair value of investments.

#### **Payment of Benefits**

Benefits are recorded when paid.

### 3. Financial Data Certified by the Trustee – Unaudited

The Plan's financial information and data was certified by Ascensus Trust Company (Ascensus) as of and for the year ended December 31, 2024 and Ascensus as of and for the period of June 26, 2023 through December 31, 2023 and Newport Trust Company (Newport) as of and for the period of January 1, 2023 through June 25, 2023, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the participant directed investments, notes receivable from participants, interest and dividends, and net appreciation/depreciation in fair value of investments included in the financial statements and supplemental schedule were obtained from data that has been prepared and certified as complete and accurate by Ascensus and Newport. This certified information has not been audited by independent auditors.

### 5. Stable Value Fund

Participants in the Plan have a stable value investment option that invests in the T. Rowe Price Stable Value Fund A, which is composed primarily of fully benefit-responsive synthetic investment contracts (SICs) held directly. The contract value of the investment contracts represents contributions made under the contract and related earnings offset by participant withdrawals. Investments underlying a synthetic structure are owned by a benefit plan or collective trust fund. SICs consist of a portfolio of underlying assets (which may include units of fixed income commingled or common trust funds) owned by a benefit plan or collective trust fund and a wrap contract issued by a financially responsible third party, typically an insurance company,

bank, or other financial services institution. The issuer of the wrap contract provides for unscheduled withdrawals from the contract at contract value, regardless of the value of the underlying assets, in order to fund routine permitted participant-initiated withdrawals from a stable value fund.

SICs provide for a variable crediting rate, which typically resets at least quarterly, and the issuer of the wrap contract provides assurance that future adjustments to the crediting rate cannot result in a crediting rate less than zero.

The crediting rate is based, in part, on the relationship between the contract value and the market value of the underlying assets, as well as previously realized gains and losses on underlying assets. The crediting rate will generally reflect, over time, movements in prevailing interest rates. However, at times the crediting rate may be more or less than prevailing rates or the actual income earned on the underlying assets. In most cases, realized and unrealized gains and losses on the underlying investments are not reflected immediately in the net assets of a stable value fund, but rather are amortized either over the time to maturity or the duration of the underlying investments, through adjustments to the future interest crediting rate.

The existence of certain conditions can limit a benefit plan's or collective trust fund's ability to transact at contract value with the issuers of its investment contracts. Specifically, any event outside the normal operation of a benefit plan or collective trust which causes a withdrawal from an investment contract may result in a contract value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, partial or complete legal termination of the plan or collective trust fund, tax disqualification, and certain plan or trust amendments if issuer consent is not obtained. The Company does not believe the occurrence of any such event is probable.

In addition to the limitations noted above, issuers of investment contracts have certain rights to terminate a contract and settle at an amount that differs from contract value. For example, certain breaches by a benefit plan or the investment manager of their obligations, representations, or warranties under the terms of an investment contract can result in its termination at market value, which may differ from contract value. Investment contracts may also provide for termination with no payment obligation from the issuer if the performance of the contract constitutes a prohibited transaction under ERISA or other applicable law. SICs may also provide issuers with the right to reduce contract value in the event an underlying security suffers a credit event or terminate the contract in the event certain investment guidelines are materially breached and not cured.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. At termination, participant accounts would become fully vested.

### **7. Income Tax Status**

The Company adopted a volume submitter plan, which received a favorable opinion letter from the IRS dated September 21, 2017. The letter states the Plan is designed in accordance with the applicable section of the Internal Revenue Code (IRC) and is qualified for federal income tax exempt status. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust exempt.

Generally, tax years from 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

### **8. Party-in-Interest Transactions**

Ascensus, as the recordkeeper and custodian, qualifies as a party-in-interest. Notes receivable from participants are also considered party-in-interest transactions. PNC Institutional Asset Management also qualifies as a party-in-interest, as an advisor to the Plan.

### **9. Risk and Uncertainties**

The Plan's investments consist of mutual funds and a stable value fund. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and long-term and that such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.
