### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **Clever Care 401(k) Plan Notes to Financial Statements**

### **1. DESCRIPTION OF PLAN**

The following description of Clever Care 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan effective January 1, 2020, established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of Clever Care Health Plan, Inc. (the Company, Plan Sponsor or Employer) and subsidiaries Clever Care of New York, Inc., Clever Care of Golden State, Inc., and Socium Health, LLC, as participating employers. The Plan was amended in September 25, 2024, to include reimbursements or other expense allowances, fringe benefits (cash and noncash), moving expenses, deferred compensation, and welfare benefits in eligible income. All employees who have completed one month of service are eligible to enroll in the Plan. Seasonal temporary employees are excluded from the Plan. After meeting the eligibility requirements, employees may enroll in the Plan on the first day of each plan quarter coincident with or next following the time on which such eligible employee satisfied such requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may elect to reduce their compensation, as defined by the Plan, by a certain amount and have that amount contributed to the Plan as a pre-tax or roth salary deferral. Participants who have attained age 50 before the Plan year-end are also eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans in which participants have previously participated. The Company provides a Safe Harbor match up to 4% of a participant's annual compensation on 100% of the participant's elective deferrals (including catch-up contributions). The Company may also provide a discretionary matching contribution at the election of the Company. The Company did not make a discretionary matching contribution for the year ended December 31, 2024. Contributions are subject to certain limitations.

#### Participant Accounts

Participants direct the investment of their accounts into various investment funds offered by the Plan. Each participant's account is credited with the participant's contribution, employer's matching contributions, and an allocation of the plan earnings and expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are always fully vested in their own elective deferral account, rollover contribution account, discretionary matching contribution account and safe harbor matching contribution account.

## **Clever Care 401(k) Plan Notes to Financial Statements**

### **1. DESCRIPTION OF PLAN (Continued)**

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts were \$2,891 and \$1,254, respectively. Forfeited nonvested accounts, if any, will be allocated in any manner at the discretion of the Plan Administrator. In 2024, no forfeitures were used to offset plan expenses or employer contributions.

#### Payments of Benefits

On termination of employment, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance. Under certain conditions, in-service withdrawals are allowed.

#### Plan Termination

Although it has not expressed any intent to do so, the Company is under no obligation or liability to continue its contributions and may discontinue such contributions or terminate the Plan subject to the provisions of ERISA.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES**

#### Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, which approximates when interest is received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)**

Payment of Benefits

Benefit are recorded when paid or upon distribution.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company, at its option, and are excluded from these financial statements. Fees related to specific participant transactions, such as for benefit payments, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**3. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, which includes investments at December 31, 2024 and 2023, interest, dividends and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the trustee of the Plan, in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.

Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.

Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Mutual Funds

Mutual funds are valued at their quoted market prices.

Money Market Accounts

Money market accounts are valued at the daily closing net asset value of the respective fund.

**5. PARTY-IN-INTEREST TRANSACTIONS**

Fees paid by the Plan to Matrix Trust Company for administrative services amounted to \$1,120 for the year ended December 31, 2024. These transactions qualify as allowable party-in-interest transactions for which there are statutory exemptions. Some administrative expenses of the Plan are paid directly by the Company.

**6. INCOME TAX STATUS**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service on June 30, 2020, stating that the written form of the underlying pre-approved plan is qualified under section 401(a) of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. Therefore, the related plan is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires the plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. SUBSEQUENT EVENTS**

In preparing these financial statements, the plan administrator has evaluated subsequent events and transactions for potential recognition or disclosure through September 11, 2025, the date the financial statements were available to be issued.
