Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Save the Children Federation, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Save the Children Federation, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the financial statements referred to above of Save the Children Federation, Inc. Retirement Savings Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Save the Children Federation, Inc. Retirement Savings Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements referred to above may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Save the Children Federation, Inc. Retirement Savings Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statements of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the financial statements referred to above.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Save the Children Federation, Inc. Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Save the Children Federation, Inc. Retirement Savings Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Save the Children Federation, Inc. Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit.

(1) Plan Description

The following description of Save the Children Federation, Inc. Retirement Savings Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

(a) General

The Plan is a defined contribution plan established by Save the Children Federation, Inc., (the Agency or the Plan Sponsor) under the provisions of Section 403(b) of the Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement, for the benefit of eligible employees of the Plan Sponsor. The effective date of the Plan was July 1, 1987. The Plan was restated January 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

(b) Plan Administration

The Retirement Plan Committee, which consists of the Plan Sponsor's senior management and other select employees of the Plan Sponsor, oversees the administration of the Plan.

Fidelity Management Trust Company (Fidelity), Prudential Retirement Insurance and Annuity Company (Prudential), and Empower Annuity Insurance Company of America (Empower) are the custodians of the Plan. Fidelity Workplace Services LLC, Prudential Retirement, Inc. and Empower Retirement, LLC are record keepers of the Plan.

In 2022, Empower acquired the retirement business of Prudential Financial, Inc. Prudential remained custodian of certain plan assets through October 20, 2023, at which time those assets transferred to Empower. Going forward, Empower maintains only accounts of participants who retired or separated from the Agency prior to October 1, 1996.

(c) Eligibility

Employees are eligible to participate in the Plan immediately after their date of hire, as long as they are considered either a regular full-time- employee or an employee working 20 hours or more per week.

Temporary employees, consultants, certain nonresident aliens, student employees, noncore fixed contract employees, participants/members in an Americorps National Service Network Program and part-time employees working less than 20 hours per week are not eligible to participate in the Plan.

An eligible employee must complete one year of service in order to receive the Agency's automatic and matching contributions. Employees are credited with a year of service for each 12-month- period during which they complete 1,000 or more hours of service. The Plan credits service for prior employment with other member organizations of Save the Children.

(d) Contributions

Participants may make pre-tax contributions or after-tax- contributions as defined by the Plan, subject to the limitations of the IRS. Additionally, participants age 50 or older or who will attain age 50 during

the Plan year, may make a “catch-up” contribution as defined by the IRS. Participants having 15 years of service are permitted to make special “catch up” contributions as defined by IRS.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to change their contribution amount or choose not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of compensation and their contributions invested in the Plan’s Qualified Default Investment Alternative, which are the Life Cycle Funds, until changed by the participant.

After one year of service, the Plan Sponsor makes a discretionary (automatic) contribution to the Plan equal to 4% of participants’ eligible compensation (as defined and capped at \$345,000 in 2024 and \$330,000 in 2023), which includes salary, and overtime. Also, after one year of service, the Plan Sponsor matches participant contributions through an additional discretionary contribution dollar for dollar up to 4% of eligible compensation. The Plan Sponsor does not match participants’ catch-up contributions.

(e) Vesting

Participants are fully and immediately vested in the benefits arising from all contributions made under this Plan.

(f) Participant Accounts

The participant accounts are valued daily. Participants may transfer amounts between funds anytime or change their investment elections daily as allowed by their prior investment choices.

(g) Benefits

Participants may receive all or a portion of their account balance resulting from participant elective contributions upon termination of employment, becoming disabled, or reaching 59½ years of age or due to hardship. Benefits are payable under the following options:

If a participant is married on the date benefits are to begin, they will automatically receive a joint and 50% survivor annuity, unless the participant (and spouse, if married) elects an alternative form of payment. This means that they will receive payments for life, and upon death, the surviving spouse will receive a monthly benefit for the remainder of his or her life equal to 50% of the benefit the participant was receiving at the time of death. Alternatively, participants may select a joint and 75% survivor annuity.

If participants are not married on the date benefits are to begin, they will automatically receive a life annuity, which means they will receive payments for as long as they live.

However, regardless of the preceding, if a participant’s balance in the Plan does not exceed \$7,000, then benefits may only be distributed in a single lump-sum payment.

If a participant’s balance in the Plan exceeds \$7,000, and the participant wants the distribution to be in a form other than an annuity payment, the participant (and spouse, if married) must first waive the annuity form of payment.

(h) Hardship Withdrawals

The Plan allows for hardship withdrawals under certain conditions on balances that include deferrals, employer match amounts, employer automatic contributions, and earnings, as well as any rollover distributions from previous qualified plans.

These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence, or to prevent eviction or foreclosure from the participant's principal residence.

(i) Notes Receivable From Participants

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000. The maximum number of loans at any one time is three. The loan interest rate is a fixed rate of prime plus 2%. All loans are paid back through payroll deductions. Personal loans may be repaid over 60 months and home purchase loans may be repaid back over 120 months. The interest rates on outstanding loans ranged from 5.25% to 10.50% and mature through 2033 as of December 31, 2024 and 2023.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting. Benefits are recorded when paid.

The Plan was established in 1987 and was historically viewed as an amalgamation of individual annuity and custodial accounts. The Plan administrator and its service providers did not maintain historical financial information at a Plan level. As such, the Plan may have excluded from the accompanying statements of net assets available for benefits certain annuity and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009. In recognition of these recordkeeping matters, the Department of Labor released Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (FAB 2009-02), as transitional relief, to address situations where a plan's management is not able to obtain historical records. If the FAB 2009-02 is implemented, the DOL has indicated that they will not reject Form 5500 where contracts are excluded as long as certain conditions were met. Further, FAB 2009-02 suggests that plan administrators make good faith efforts to include known contracts. While the Plan administrator has, in good faith, included all known contracts, because of certain incomplete records, there is uncertainty that all contracts have been included. However, the Plan administrator believes that excluded annuities or custodial accounts, if any, would meet the conditions of FAB 2009-02.

(b) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments include a money market fund, shares in registered investment companies, and pooled separate accounts that are recorded at fair value, and a stable value fund that is recorded at contract value. The Plan also offers a self-directed brokerage account option. A further description of the valuation of these assets recorded at fair value is provided in Note 4. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in fair value of investments represents the change in fair value of investments from one period to the next and realized gains and losses.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

(e) Administrative Expenses

Administrative expenses related to investment management are allocated amongst various funds and are expensed as incurred. Certain fees and expenses assessed by the investment vehicle are charged against participants' accounts.

The Plan permits the payment of Plan expenses to be made from the Plan's assets, if available. If there are no available assets, then the Plan Sponsor generally pays for all of the Plan expenses. During the years ended December 31, 2024 and 2023, Plan expenses paid by the Plan amounted to \$200,431 and \$177,603 respectively. Administrative expenses paid by the Plan Sponsor are not included in these financial statements.

(f) Stable Value Fund

The Prudential Guaranteed Interest Account (GIA) Fund is one of the investment options offered by the Plan and is a stable value fund which guarantees principal and a contractually specified interest rate to account participants. The GIA Fund's objective is to credit interest on contributions at competitive rates that generally exceed the returns available from money market instruments. The GIA Fund simultaneously minimizes the volatility of returns, provides safety of principal and allows for a level of liquidity.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. The contract value of the GIA Fund equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. The GIA Fund is not available for sale or transfer on any securities exchange. Accordingly, transactions are not observable. Investment income is recorded at stable value fund level.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination

or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the schedule maturity date.

(3) Information Certified by the Plan's Custodians

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity Management Trust Company, Prudential Retirement Insurance and Annuity Company, and Empower Annuity Insurance Company of America, as custodians of the Plan, have certified as being complete and accurate the investments and notes receivable from participants on the statements of net assets available for benefits, the related activity reflected in the statements of changes in net assets available for benefits, and the information included in the supplemental schedule of the financial statements as of and for the years ended December 31, 2024 and 2023. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodians.

(4) Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Money Market Fund: Valued at the quoted market price at year end.

Registered Investment Companies: Valued at the quoted market prices at year end.

Pooled separate accounts: Valued at the unit value at year end as determined by the issuer. These pooled separate accounts can be traded daily and are considered to have a readily determinable fair value.

Self-directed brokerage accounts: Consist of money market funds, mutual funds and exchange traded funds. All investments held within self-directed brokerage accounts are valued at quoted market prices at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in methodologies used at December 31, 2024 and 2023 and there were no transfers among levels during the year ended December 31, 2024 and 2023.

(5) Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to amend or discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA.

(6) Related-Party Transactions

Certain Plan investments are managed by the Plan's custodians and therefore qualify as party-in-interest transactions. Recordkeeping fees paid to affiliates of the Plan's custodians also qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Certain employees of the Plan Sponsor perform administrative services to the Plan, at no cost to the Plan.

(7) Risk and Uncertainties

The Plan assets are invested in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits. The Plan may invest indirectly in securities with contractual cash flows, such as asset-backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate values, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

(8) Tax Status

The Plan is placing reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Reconciliation of Financial Statements to Form 5500
