### **INDEPENDENT AUDITOR'S REPORT**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Columbus Equipment Company Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Columbus Equipment Company Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### NOTE A - DESCRIPTION OF PLAN

The following description of the Columbus Equipment Company (the Company) Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a 401(k) profit sharing plan that was formed for the purpose of providing retirement benefits to employees of the Company and employees of Starr Parts & Equipment, LLC, CEC Turf & Tractor, LLC, CEC Smart Positioning, LLC, and WFE Holdings, Inc., who have attained age 18. The Plan document was amended to include the employees of CEC Turf & Tractor, LLC, CEC Smart Positioning, LLC, and WFE Holdings, Inc. as of January 1, 2024. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may elect to contribute a portion of their pretax and after tax annual compensation, as defined by the Plan. Participants may contribute employee deferrals and Roth deferrals to the Plan up to the maximum amount allowed by law. The Plan has an automatic enrollment provision (4% salary deferral with a 1% automatic increase annually on July 1 until reaching a maximum of 8%) whereby employees must elect out of the Plan if they do not wish to participate. The Plan allows participants who attained age 50 by the end of the Plan year to make catch-up contributions in accordance with Code Section 414. Participants may also contribute amounts representing distributions from other qualified plans. The Company can elect to make an employer matching contribution on behalf of each eligible participant. The employer matching contribution is equal to 50% of each participant's deferrals up to \$3,000 of deferrals in 2024 and 2023. The Plan excludes employees covered by the collective bargaining agreement between the Company and the International Union of Operating Engineers from sharing in employer matching contributions and employer discretionary contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Administration Expenses

Plan fees and expenses, including fees and expenses connected with the providing of administrative services by external service providers, are paid by the Plan and the Plan Sponsor.

#### Investment Options

Each participant may direct his or her contributions in any of the investment options available under the Plan. They primarily include mutual funds with varying fund objectives and degrees of investment risk. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility.

Vesting

Participants are immediately vested in their voluntary contributions, rollovers, and employer safe-harbor matching contributions, plus actual earnings thereon. Vesting in the employer non-safe harbor matching and non-safe harbor non-elective contributions plus earnings thereon are based on years of credited service according to the following schedule:

Payment of Benefits

On termination of service due to disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in his or her account. A participant is entitled to 100% of his or her account balance upon death or disability, regardless of years of service. A participant who has not terminated employment can withdraw up to 100% of their vested account balance once they reach the age 59 ½. There is a mandatory cashout distribution provision for those participants whose vested terminated account balance is below \$7,000 at the time of termination.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or a reasonable period of time longer than 5 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Trustees. Principal and interest are paid ratably through payroll deductions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. The Plan is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2025.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed in the preparation of these financial statements. These policies conform to accounting principles generally accepted in the United States of America and have been applied on a consistent basis.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments consists of both realized gains and losses on investments sold during the year and the unrealized appreciation (depreciation) on investments held at year-end.

##### Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with U.S. generally accepted accounting principles. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported additions and deductions.

##### Note Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### Administrative Fees

The Plan's administrative fees are paid by both the Plan and the Plan Sponsor, as provided in the Plan agreement. The amount paid by the Plan was \$58,609 for the year ended December 31, 2024.

##### Payment of Benefits

Benefits are recorded when paid.

##### Forfeited Accounts

Forfeitures represent that part of the participant's account that is not vested. Forfeited nonvested accounts totaled \$65,961 and \$29,842 for the years ended December 31, 2024 and 2023, respectively. During 2024, \$47,848 of Company matching contributions were transferred from participant accounts to the forfeiture account because the matching contributions were not vested on the dates the distributions were processed. As a result of the forfeiture additions, during 2024, \$281 of forfeited funds were used to reduce Company matching contributions. During 2024, \$13,906 of forfeited funds were used to pay Plan expenses.

##### Subsequent Events

Management evaluated all activity of the Plan through October 6, 2025, the date the financial statements were available to be issued and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

### NOTE C - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan's Trustee, Charles Schwab Trust Bank, holds the Plan's investments and executes all investment transactions. All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2024 and 2023, interest income, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator. The Plan Administrator has obtained certification from the Trustee that the information provided to the Plan Administrator by the Trustee is complete and accurate in accordance with 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE D - FAIR VALUE

FASB ASC 820 establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described in the table below:

**Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access:**

- market data by correlation or other means.

**Level 2 – Inputs to the valuation methodology include:**

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable

If the asset or liability has a specified (contractual) term, level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE D - FAIR VALUE (CONTINUED)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. (Level 1)
- *Collective investment trusts*: The Plan holds investments in a collective trust fund that is valued at fair value using the net asset value (NAV) as a practical expedient. The NAV is based on the fair value of the underlying assets held by the fund, less its liabilities, and is provided by the trustee or fund manager. There were no unfunded commitments related to this investment as of December 31, 2024 and 2023. The Plan may redeem its investment in the collective trust fund on a daily basis with no advance notice required. There were no significant restrictions on the ability to sell the investment at the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fees paid by the Plan for the Trustees and recordkeeping services amounted to \$58,609 for the year ended December 31, 2024. All other administrative fees are paid by the Company on behalf of the Plan.

Certain Plan investments are units of mutual funds or collective investment trusts managed by Charles Schwab. Charles Schwab Bank and Charles Schwab Trust Bank are part of Charles Schwab and are Trustees as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Certain Plan investments are managed by Schwab Retirement Plan Services. Transactions in these investments qualify as party-in-interest transactions.

#### NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### NOTE G - INCOME TAX STATUS

The Plan was established using the Schwab Retirement Plan Services, Inc. Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan, which, according to an opinion letter dated September 21, 2020 from the Internal Revenue Service, may be relied upon by an employer to adopt and qualify as an approved plan under the applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
