We have performed audits of the accompanying financial statements of DC Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of DC Group, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF PLAN

The following description of the DC Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan. DC Group, Inc. (the Company) is the administrator and sponsor of the Plan. The Plan was established January 1, 2012 and uses John Hancock Life Insurance Company as the plan trustee (custodian). The Plan was most recently restated March 1, 2024. The participants are responsible for the direction of their account balances into specific investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective March 1, 2024, the Plan changed third-party administrator service providers from FuturePlan to DWC – The 401(k) Experts (DWC). The Plan has been restated effective March 1, 2024 under DWC's plan documents. The Plan was restated using provisions from the SECURE Act effective March 1, 2024 to allow Qualified Birth/Adoption Distributions (QBADs). QBADs follow the same restrictions as existing hardship and other withdrawals.

Eligibility:

Employees of the Company who have attained twenty-one years of age and have completed two months of service are eligible to participate in the plan and receive non-elective matching contributions. Plan entry dates are the first day of each month after employees satisfy eligibility requirements.

Contributions:

Each year, participants may contribute, through salary reduction, up to 90% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to make rollover contributions from other qualifying plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The Company has a flexible discretionary match and prior to July 1, 2024, the Company contributed 25% of eligible compensation that a participant contributed to the Plan, with a maximum contribution of 6%. Effective July 1, 2024, the Company contributes a flexible discretionary match of 50% of the eligible compensation that a participant contributes to the Plan, with a maximum contribution of 4%. The Company may make discretionary qualified non-elective contributions. No discretionary qualified non-elective contributions were made during the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

NOTE 1. (CONTINUED)

Participant accounts:

Each participant's account is credited with participant pre-tax deferrals, participant post-tax Roth contributions, Company matching contributions, any other discretionary contributions made by the Company and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are valued at the end of each business day. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is 100% vested after 5 years of service. Participant accounts become 100% vested if the participant becomes disabled or dies, regardless of years of vested service.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period or 50% of their vested account balance. All notes receivable shall bear a reasonable rate of interest as determined by the Plan Administrator. Interest rates on outstanding participant notes receivable were between 4.25% and 9.50%. Loans must be repaid within five years, except a loan used to build or purchase a principal home which may be repaid over a thirty-year period. Principal and interest are paid ratably through biweekly payroll deductions.

Payments of benefits:

Distributions to terminated or retired participants are made in a single lump-sum payment to the participant (or in the case of death, the participant's beneficiary) or periodic installments over a period specified by the Plan. Effective January 1, 2025, if terminated/retired participants do not voluntarily elect to move their funds out of the plan, vested account balances less than \$7,000 (previously \$5,000) are paid out in lump-sums to participants. If a participant terminates employment and the participant's account balance does not exceed \$7,000 (previously \$5,000), the Plan Administrator can authorize the benefit payment without the Participant's consent.

Active (not terminated/retired) participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan and withdrawals are limited pursuant to the Plan.

NOTE 1. (CONTINUED)

Forfeited accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,553 and \$1,875, respectively. These accounts will be used to reduce Plan administrative expenses and employer contributions. During the years ended December 31, 2024 and 2023, employer contributions and Plan administrative expenses were reduced by \$10,000 and \$10,000 from forfeited non-vested accounts, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are maintained on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

NOTE 2. (CONTINUED)

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to the deadlines set by the IRS.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 16, 2025, the date the financial statements were available to be issued.

Effective March 3, 2025, the Plan changed the plan trustee (custodian) from John Hancock Life Insurance Company to Voya Retirement Insurance and Annuity Company. At that time the Plan transferred all of the Plan assets to Voya Retirement Insurance and Annuity Company.

NOTE 3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. John Hancock Life Insurance Company, the trustee (custodian) of the Plan, has certified as to the completeness and accuracy of all investment and notes receivable information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ending December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets and liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Investments consist of pooled separate accounts made up of sub-accounts. Each sub-account invests solely in shares of a mutual fund ("the underlying fund") which is stated at fair value based on the last quoted market prices obtained by John Hancock Life Insurance Company. Investments are valued at the net asset value (NAV) of units of participation held by the plan at year-end with indirectly observable prices for the underlying funds. Fair value of shares of an underlying fund equals the number of share of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company which is the trustee (custodian) and record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. PLAN TAX STATUS

The Plan is placing reliance on an advisory opinion letter dated June 30, 2020 received from the Internal Revenue Service (IRS) on the DC Group, Inc. 401(K) Plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under the current income tax law. The Plan has been amended since receiving the advisory opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 7. (CONTINUED)

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9. SECURE ACT 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and administratively adopted an increase to the force out limit for terminated participants (See Note 1, Payments of benefits subnote). Plan management will determine the optional provisions to elect in the future.
