Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Equinox Gold Corp., U.S. OPS 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Equinox Gold Corp., U.S. OPS 401(k) Plan (the Plan) provides only general information. More complete information regarding the Plan's provisions can be found in the Plan documents.

General: The Plan is a defined contribution plan covering all United States employees of Western Mesquite Mines, Inc. (the Company or Employer) who have completed one month of service. The Plan is a defined contribution plan and is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Western Mesquite Mines, Inc. acts as the Administrator of the Plan. John Hancock Life Insurance Company (U.S.A.) (John Hancock) is the trustee of the Plan.

The Plan excludes employees who are covered by collective bargaining agreements and covered employees acquired in an asset or stock acquisition, merger, or similar transaction described in code section 401(b)(6)(c) until such time as the Employer extends coverage to such employees. The Plan allows entry to the Plan on the first day of the month following the date the participant satisfies the eligibility condition.

Contributions: Eligible employees may elect to make pre-tax 401(k) contributions and/or Roth 401(k) contributions as defined in the Plan. The Employer may make matching contributions of up to 6% of the employee wages for participating employees. For the Plan year 2024 and 2023, the Employer matching contributions were \$1,866,063 and \$1,825,117, respectively, to eligible participants who were employed on December 31, 2024 and 2023. The maximum employee deferral permitted by the Internal Revenue Service (IRS) was \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions of up to \$7,500 for 2024 and 2023.

Participant Accounts: Each participant's interest in the Plan is maintained in four sub-accounts within one main account. These sub-accounts are: an employee pre-tax contribution, an employee Roth contribution, an Employer matching contribution, and rollover contribution from an employee's previous plan(s). The sub-accounts are credited or charged with the appropriate contributions and any earnings and/or losses resulting from the investment of those contributions.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their account plus actual earnings thereon are based on years of continuous service and at least 1,000 hours of service per year and is vested as follows:

Years of Service	Vested Percentage
Less than 1 year	0%
1 year but less than 2	50%
2 years or more	100%

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies, or (3) terminates employment by reason of permanent disability, the Employer contribution amounts become 100% vested without regard to years of service.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Loans: Through July 2021, participants could borrow from the Plan the lesser of \$50,000 or 50% of the participant's vested account balance. Effective July 2021, the Plan was amended to limit participant loan amounts to a maximum of \$5,000. The loans are secured by the balance in the participant's account and bear interest at the prevailing market rate as mutually determined quarterly by the Plan. Principal and interest is paid ratably through payroll deductions. Loans taken out before July 2021 must be repaid over a period not to exceed 5 years, unless the loan is taken for the purchase of a primary residence. Effective July 2021, loan repayment period changed to two years for non-principal residence purchases.

Payment of Benefits: On termination of service due to death, disability or retirement, if the participant's vested account balance does not exceed \$1,000, distribution is made in a lump sum. If the participant's vested account balance exceeds \$1,000, the participant or beneficiary may elect to receive a lump sum payment or defer the receipt of payment according to Plan provisions.

An in-service distribution can also be made to participants who have attained the age of 59-1/2, upon disability or when experiencing financial hardship.

Forfeiture: Participants who are not 100% vested will forfeit the non-vested portion of the Employer matching contribution upon termination of employment. Forfeitures may be used to either pay Plan expenses or offset Employer's contributions. Forfeitures used to reduce Employer contributions were \$0 and \$7,514 for the years ended December 31, 2024 and 2023, respectively. Forfeitures available for future use were \$114,201 and \$24,951 at December 31, 2024 and 2023, respectively.

Administrative Expenses: The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Special expenses like distribution fees, loan fees, hardship withdrawal fees, etc., are charged directly to the particular participant using the service.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Accounting for Fully Benefit-Responsive Investments: Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Risks and Uncertainties: The Plan provides for various investment options in mutual funds and other investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income (Loss) Recognition: The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, for which contract value is the relevant measurement attribute). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

The Plan presents in the statements of changes in net assets the net appreciation/depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

NOTE 3. CERTIFIED FINANCIAL INFORMATION

The Plan Administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, notes receivable from participants, investment transactions, investment income, and the schedule of assets held at the end of year have been derived from information certified as complete and accurate by John Hancock, the trustee of the Plan. This information was not audited in accordance with the Plan Administrator's instructions, and as permitted by Section 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4. FAIR VALUE MEASUREMENTS

Accounting guidance establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts and Mutual Funds: The underlying investments of the pooled separate accounts are principally mutual funds. Mutual funds are valued using quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

NOTE 4. FAIR VALUE MEASUREMENTS (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. INVESTMENT CONTRACTS

The Plan has a fully benefit-responsive investment contract with John Hancock. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting interest rates are based on an agreed-upon formula with the issuer, and are guaranteed for an agreed-upon period, usually quarterly.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, the contract issuer may terminate the contract with 75 days advance notice to the contract owner for reasonable cause, which includes the contract owner's failure to render performance necessary to comply with the terms of the contract. Upon termination by the contract issuer, a market value adjustment or other withdrawal restrictions may apply.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

At December 31, 2024 and 2023, certain Plan investments are invested in American Funds managed by John Hancock, the Plan's Trustee. As such, transactions with John Hancock qualify as party-in-interest transactions under ERISA. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

NOTE 7. FEDERAL INCOME TAX-EXEMPT STATUS

The Plan has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was acceptable under section 401(k) of the IRC. The Plan has since been amended. However, the Plan Administrator and the Plan's management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the taxing authority. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their employer contribution accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

NOTE 9. DELINQUENT CONTRIBUTIONS

During the year ended December 31, 2023, the Employer inadvertently failed to deposit participant deferrals timely in the amount of \$109,508. The DOL considers late deposits to be prohibited transactions. The Company has self-corrected the delinquencies during the year ended December 31, 2024.

NOTE 10. SUBSEQUENT EVENTS

The Plan's Management has evaluated subsequent events for recognition and disclosure through October 3, 2025, the date the financial statements were available to be issued.
