Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Hamilton Health Care, Inc. RSVP Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2023 and 2024, the related statements of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

NOTE A--DESCRIPTION OF THE PLAN

The following description of the Hamilton Health Care, Inc. RSVP Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees of Hamilton Health Care, Inc. and certain affiliates (collectively, the Company) are eligible to participate in the Plan as of the first Entry Date, which is the first day of the Plan Year or the first day of the seventh month of the Plan Year coinciding with or next following the date the participant satisfies the eligibility conditions. Participants must satisfy the minimum age of twenty-one years of age and service requirements of one year to participate in the Plan. A year of service is defined as at least 1,000 hours during the twelve-month period immediately following the participant's date of hire or at least 1,000 hours during any Plan Year beginning after date of hire.

Contributions: Effective October 28, 2021, the Plan was frozen; therefore, no contributions may be made to the Plan, including rollovers from qualified plans. Employees may participate in the Company's Matching Dollar Plan.

Participant Accounts: Each participant's account is credited with the participant's rollover contributions, an allocation of Plan earnings, and charged with an allocation of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants became 100% vested in the Plan's contributions as of October 28, 2021, the effective date the Plan became frozen.

Payment of Benefits: Upon termination of service, including due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance or substantially equal installments over a specified period. Participants may also request in-service withdrawals due to hardship or upon reaching age 59½. The Plan makes involuntary distributions to terminated participants with account balances of \$5,000 or less in the form of a lump-sum payment or, at the participant's election, as a rollover to another qualified retirement plan or to an individual retirement account.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Notes to Financial Statements - Continued

Year Ended September 30, 2024

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments in shares of registered investment companies are reported at fair value based on the quoted market values of the shares held by the Plan.

The investment contracts held by the Plan are reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments: Benefit payments are recorded when paid.

Administrative Expenses: Administrative expenses related to maintaining participant accounts and third-party administration are paid by the Plan and deducted from participant funds. Plan expenses related to legal and accounting fees may be paid by the Company or the Plan.

NOTE C--INFORMATION CERTIFIED BY THE CUSTODIAN AND TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by The Variable Annuity Life Insurance Co. (VALIC), the custodian of the Plan, and The Lincoln National Life Insurance Company (Lincoln), the trustee of the Plan, and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

- The investments shown in the accompanying Statements of Net Assets Available for Benefits of \$19,248,306 and \$18,454,881 as of September 30, 2024 and 2023, respectively.
- Net appreciation in fair value of investments of \$1,367,150 and interest, dividends, and other income of \$613,706 as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended September 30, 2024.

NOTE D--CONTRACT WITH INSURANCE COMPANIES

The Plan has entered into fully benefit-responsive investment contracts with VALIC and Lincoln. VALIC and Lincoln maintain the contributions in general accounts. VALIC and Lincoln are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Such rates are determined monthly and are credited on a daily basis at an annual effective rate of at least 1%. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Management believes no events are probable to occur that might limit the ability of the Plan to transact at contract value with the contract issuer, and that would also limit the ability of the Plan to transact at contract value with the participants.

NOTE E--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets and liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at September 30, 2024 and 2023.

NOTE F--RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's contracts are secured by the general assets of VALIC and Lincoln. VALIC is a custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Lincoln serves as third-party administrator and trustee as defined by the Plan, and therefore, these transactions also qualify as party-in-interest transactions. Commissions and fees paid to VALIC by the Plan were not significant during the year ended September 30, 2024. Fees paid by the Plan directly to Lincoln for administrative services totaled approximately \$11,700 during the year ending September 30, 2024.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their account balance.

NOTE H--INCOME TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the applicable authorities. The Plan Administrator has evaluated the tax positions taken by the Plan and determined there are no uncertain tax positions as of September 30, 2024, that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE J--SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any additional material recognizable subsequent events that required recognition or disclosure in the financial statements.
