We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the Scaled Composites, LLC Incentive Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General: The Plan is a defined contribution plan covering all active employees of Scaled Composites, LLC (the Employer or Company) who have completed two months of service. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). Additionally, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Fidelity Management Trust Company (Fidelity) is the trustee, and Fidelity Workplace Services LLC is the recordkeeper of the Plan.

Contributions: Participants may elect to contribute up to 75% of their annual compensation, as defined in the Plan, through payroll deductions, as pre-tax compensation deferrals or after-tax Roth contributions. The Plan's automatic deferral provisions are set at a deferral rate of 4% of compensation. The maximum participant contributions permitted by the Internal Revenue Service (IRS) was \$23,000 and \$22,500 for the years ended December 31, 2024, and 2023, respectively. Catch-up contributions of \$7,500 were available to participants who had attained age 50 or older by December 31, 2024, and 2023, and had not exceeded the contribution limit for the Plan year. Participants may also contribute amounts representing distributions from other qualified plans.

Effective January 1, 2023, the Employer will make safe harbor matching contributions equal to 100% of the first 6% of employee's eligible compensation. For the years ended December 31, 2024, and 2023, the Employer safe harbor matching contributions amounted to \$1,282,316 and \$1,362,762, respectively.

The Employer may also make discretionary profit sharing contribution at the end of each Plan year. There was no discretionary profit-sharing contribution for the years ended December 31, 2024, and 2023.

Participants' Accounts: Each participant's account is credited with the participant's contributions, Employer's contributions and allocation of Plan earnings or losses. Allocations of Plan earnings or losses for investments are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits: Upon termination of service, death, disability or retirement, a participant or beneficiary may elect to receive a distribution in either a lump-sum payment or in annual installments paid over a period not to exceed his or her assumed life expectancy at the time of distribution. Payment is generally made when a participant or beneficiary submits a written request for distribution. If the vested account balance of a participant is \$1,000 or less, the participant will receive a lump-sum payment whether or not requested. In-service distributions are allowed upon either attaining age 59-1/2 or experiencing a financial hardship as defined by the IRC. Such withdrawals are subject to applicable excise and income taxes and may only be made with the approval of the Plan Administrator.

Vesting: Participants are 100% vested in their employee contribution and rollover account balances plus actual earnings thereon. Vesting in the Employer's contribution portions of their account plus actual earnings thereon is based on years of continuous service. Years of service for vesting purposes shall be based upon the completion of 1,000 hours of service within the Plan year. Participant vesting for the Employer's discretionary matching and non-elective contribution is as follows:

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies, (3) becomes permanently and totally disabled or (4) becomes eligible for early retirement, the Employer match amounts become 100% vested without regard to years of service.

Forfeitures: Participants who are not 100% vested will forfeit the non-vested portion of the Employer contributions upon termination of employment. Such forfeitures may be applied to reduce future Employer contributions or Plan expenses.

Forfeitures of \$233,555 and \$86,711 were applied to reduce Employer matching contributions during the year ended December 31, 2024, and 2023, respectively. Additional forfeitures of \$12,902 were used during the year ended December 31, 2023, for Employer Qualified Non-elective Contributions. A total of \$114,910 and \$258,435 was available in the forfeiture accounts at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The minimum loan is \$1,000. The loans are secured by the vested balance in the participant's account and bear interest at the Prime rate of interest plus 1%. The term of loans shall not exceed five years except for loans used to purchase the participant's principal residence where the term cannot exceed 15 years.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in their accounts.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are reported on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income (Loss) Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Realized and unrealized appreciation (depreciation) is based on the market value of the assets at end of the Plan year compared to the market value of the assets at the beginning of the Plan year, or at the time of purchase for assets purchased/exchanged during the Plan year.

Valuation of Notes Receivable from Participants: Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest.

Contributions Receivable: Contributions receivable are recognized when amounts are due to the Plan from employers, participants, or other sources as of the reporting date. Recognition is based on a demonstrated commitment, such as a formal resolution, a consistent funding policy, a tax deduction taken by the employer, or the employer's recording of a liability.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Expenses of maintaining the Plan which includes recordkeeping fees, investment advisory fees and certain trustee fees are paid by the Plan, unless otherwise paid by the Company.

NOTE 3. CERTIFIED FINANCIAL INFORMATION

The Plan Administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income, notes receivable from participants, and the schedule of assets held at end of year has been derived from information certified as complete and accurate by Fidelity, the current Plan Trustee, and Schwab, the former Plan trustee, in accordance with Section 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of a mutual funds managed by Fidelity and Schwab. Therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan for recordkeeping, trustee and investment services during the years ended December 31, 2024 and 2023 amounted to \$130,270 and \$25,452, respectively.

NOTE 5. TAX-EXEMPT STATUS

The Company adopted a volume submitter 401(k) profit sharing plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the form of the plan was acceptable under the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan's investments primarily consist of mutual funds and a collective trust fund. Investment securities within the funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7. EXCESS CONTRIBUTIONS

There were no amounts payable to participants for contributions in excess of amounts allowed by the IRS as of December 31, 2024, and 2023.

NOTE 8. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1* Observable quoted prices in active markets for identical assets and liabilities.
- Level 2* Observable quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar instruments in markets that are not active and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3* Model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods and assumptions were used to estimate the fair value of each class of assets that are recognized at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued using quoted market prices which represent the net assets value (NAV) of shares held by the Plan at year end.

Collective Trust Fund: Valued at its respective NAV as reported by the trustee. The NAV is used as a practical expedient to estimate fair value. The collective trust fund consists of the Invesco Stable Value Trust which holds fully benefit-responsive investment contracts. The Invesco Stable Value Trust invests in a highly diversified portfolio of investment grade, fixed and floating rate securities.

Self-Directed Brokerage Accounts: Accounts primarily consist of cash and cash equivalents where carrying value approximates fair value and investment securities that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participant-directed redemptions will be distributed within 30 days at contract value; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund at contract value or it may receive the fair value of its proportionate share of the fund upon earlier distribution.

NOTE 9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During the years ended December 31, 2024, and 2023, certain employee deferrals and loan payments totaling \$479,461, and \$516,545, respectively, were not remitted to the Plan within the timeframe required by the DOL. The Company has corrected the 2023 late contribution remittances in September 2025 and is in the process of correcting the 2024 late contribution remittances by restoring lost earnings using the general assets of the Employer, and not the assets of the Plan.

NOTE 10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued and has determined that except as discussed in Note 9 above, no events or transactions require recognition or disclosure in these financial statements.
