INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
CMS Operations, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of CMS Operations, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CMS Operations, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CMS Operations, LLC 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF THE PLAN

The following description of CMS Operations, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for employees of CMS Operations, LLC, Intellitech, Inc., Hilltop Consultants, LogicForce Consulting LLC, and The GlasserTech, all of whom are commonly controlled by Resolve Intermediate Holdings, Inc and Subsidiaries ("the Company" or "Employer"), who have completed one month of service. The Plan is a salary reduction plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. CMS Operations, LLC, the Plan Sponsor, has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Contributions

Each year, participants may contribute pretax annual compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are invested based upon the investment options selected by the participant. The Company may match each participant's contributions.

Employees must complete one month of eligible service and are fully vested after one year of credited services in their employer matching contributions. Additionally, employees first hired prior to April 24, 2022 are immediately vested in discretionary employer matching contribution amounts.

After one year of service, all employees of the Company are eligible for an additional employer non-discretionary match of 50% of the first 3% of compensation deferred.

The Company signed an amendment effective August 1, 2024 to increase the automatic enrollment feature for employee contributions from 2% to 3%. Additionally, the amendment applies an automatic contribution increase of 1% annually with a maximum increase of 10%, effective on May 1 of each Plan year for all eligible employees that have not opted out of the feature.

Contributions (continued)

Eligible employees include (1) Newly eligible Employees on each such Employee's Entry Date (2) Active Participants (who are not suspended from making Deferral Contributions) that are without a deferral election and were hired on or after February 1, 2021 and (3) each Eligible Employee having a reemployment commencement date shall be automatically enrolled later of 30 days from date of rehire or Entry Date.

Participant investment account options

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, and a stable value common collective trust fund as investment options for participants. Participants may change their investment options at any time.

Participant accounts

Each month the participant's account is credited with the participant's deferral contribution and allocations of the Company's matching contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The participant's account is reduced by any distributions or withdrawals made to the participant.

Notes receivable from participants

New loans are not allowed to be processed under the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. All employees first hired prior to April 24, 2022 are immediately vested in discretionary employer matching contributions plus actual earnings thereon. For employees hired after April 24, 2022, vesting in the Company's contribution portion of their accounts is based on years of continuous service as well as Company division. Participants are 100% vested in discretionary employer matching contributions plus actual earnings thereon after 1 year of service. Non-discretionary matching contributions 100% vested after six years of credited service at the rate of 20% each year after two years of service.

Payment of benefits

On termination of service or an in-service withdrawal, a participant may elect to receive the value of the participant's vested interest in their account. The Plan allows for hardship withdrawals, as defined in the Plan, which are limited to the amount needed to meet financial needs. These withdrawals may not be reconstituted to the Plan and may be subject to income tax and penalties.

The Plan contains an automatic cash out provision for terminated employees who have account balances less than \$5,000.

Forfeited accounts

Forfeitures result from a participant's withdrawal, retirement or termination before the participant is 100% vested in discretionary contributions. Upon a participant's termination of employment, the nonvested portion of the participant's account related to employer contributions is applied to reduce future employer contributions to the Plan. There were forfeited non-vested accounts of \$1,522 and \$26,920 at December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, employer contributions were reduced by \$43,190 and \$0.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates in financial statement preparation

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect reported amounts of net assets available for benefits and changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses related to the Plan are paid by the Plan sponsor. The expenses paid directly by the Plan are allocated to participants in proportion to their percentage of Plan assets.

3. CERTIFICATION

The Plan has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for assets arising from employer contributions. Accordingly, as permitted under such election, the Plan has obtained certification from Fidelity Management Trust Company (the "trustee"), that all of the investment information provided by the trustee and included in the accompanying financial statements and supplemental schedule of assets (held at end of year), is complete and accurate.

Information as to the investments in the account of the trustee, investment income, and all investment related information as of and for the years ended December 31, 2024 and 2023 appearing in the accompanying statements and supplemental schedule of assets (held at end of year) as of December 31, 2024 are presented in reliance solely upon these certifications.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The fair value hierarchy is described as follows:

Level 1: Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.

4. FAIR VALUE MEASUREMENTS (continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the NAV of the units of a collective trust. The NAV, as provided by the Fidelity, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. PARTY-IN-INTEREST TRANSACTIONS

Fidelity Investments Institutional is the recordkeeper as defined by the Plan and CBIZ Investment Advisory Services is the investment advisor, and, therefore, these transactions qualify as permitted party-in-interest transactions. Fees paid by the Plan for investment and advisor fees are reflected in administrative expenses.

7. PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts. No part of the assets of the Plan will revert or be diverted to the Company at any time.

8. TAX STATUS

On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as then designed, qualifies under the Internal Revenue Code ("IRC") Section 401(a). The Plan has not received a determination letter specific to the Plan itself. The Plan Administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events through August 22, 2025, the date the financial statements were available to be issued.

10. DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company remitted participant contributions totaling \$57,916 late during 2023. These delinquent contributions and related lost earnings were corrected by the Company in 2025. There were no late remittances during 2024.
