Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Froedtert South, Inc. 401(a) Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1: Description of Plan

The following description of Froedtert South, Inc. 401(a) Defined Contribution Retirement Plan (the "Plan"), provides only general information. The Plan was formerly known as United Hospital System, Inc. 401(a) Defined Contribution Retirement Plan, and was changed effective October 1, 2017, when United Hospital System, Inc. changed its legal name to Froedtert South, Inc. Participants should refer to the Plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

General

The Plan is a qualified defined contribution plan sponsored by Froedtert South, Inc. (the "Sponsor"). The Sponsor is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC").

Eligibility

Participants are eligible to receive matching contributions based on the participant's contribution to the Froedtert South, Inc. Matched 403(b) Retirement Savings Plan. Participants are eligible to receive Sponsor matching contributions on the first of the month coinciding with or immediately upon attaining the age of 21 and completing 1,000 hours of service within the 12-month period following employment.

Contributions

Participants may not make pre-tax or after-tax contributions to the Plan. Participants may contribute amounts representing distributions from other qualified plans ("rollovers"). Matching contributions were made equal to 100% of participant's contribution to the Froedtert South, Inc. Matched 403(b) Retirement Savings Plan up to 5% of the participant's eligible compensation for 2024.

Vesting

Participants are immediately vested in the Sponsor contributions plus actual earnings (losses) thereon.

Participant Accounts

Each participant's account is credited with the Sponsor's matching contributions, rollover contributions, and allocations of Plan net earnings (losses) thereon and charged with transactional expenses. Allocations are based on participant earnings (losses), account balances, or specific participants transactions as defined in the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination of employment equal to the value of the participant's interest in their account in installment distributions, unless the value of the account is \$7,000 or less, in which case the participant can only receive a lump-sum distribution.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investments contracts ("FBRICS")). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

FBRICS are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transitions under the terms of the plan.

Excess Contributions Payable

At December 31, 2024 and 2023 amounts payable to participants totaling \$470 and \$1,388, respectively, for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Sponsor has put measures in place to limit contributions allowable by the IRS on a going forward basis.

Note 2: Summary of Significant Accounting Policies (Continued)

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Fees directly attributable to a participant's transaction are deducted from that participant's account. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balance and are included in total investment income.

Subsequent Events

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Note 3: Guaranteed Fund (FBRIC)

The Plan has entered into a FBRIC with New York Life Insurance Company ("NYL"). NYL maintains the contributions in a general or separate account. The account is credited with a guaranteed rate of interest and charged for participant withdrawals and administrative expenses. The guaranteed fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on an annual basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Personal choice account: Valued by pricing the underlying investments primarily from closing prices reported on active markets or observable market data for the same or similar investments. The underlying investments are primarily mutual funds, stocks, and bonds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Information Prepared and Certified by Plan Custodians

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, Inc. (custodians of the Plan).

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan document to terminate or partially terminate the Plan subject to the provisions of ERISA.

Note 7: Tax Status

The IRS has determined and informed the Sponsor by a letter that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-in-Interest Transactions

The Plan holds units in a guaranteed pooled fund managed by Transamerica Financial Life Insurance Company, Inc., the Plan's custodian. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules of ERISA.
