REPORT OF INDEPENDENT AUDITORS

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tate Ornamental 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. 1. DESCRIPTION OF THE PLAN

The following brief description of the Tate Ornamental 401k Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 1997 by Tate Ornamental, Inc. ("Employer"), that includes salary deferral features of Section 401(k) of the Internal Revenue Code. The Plan is intended to meet the requirements of a qualified plan under section 401(a) of the Internal Revenue Code. The Plan provides for retirement benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. All employees of the Employer who have attained the age of 19 and have completed 1 year of service are eligible for the Plan upon meeting those requirements.

Contributions

The Plan permits eligible employees through a salary reduction deferral election to make annual Roth and pre-tax contributions up to the current Internal Revenue Service deferral limits. Employee rollover contributions are also permitted. The salary reduction deferrals of all employees are eligible for Employer matching contributions, which are 100 percent of employee contributions up to 3 percent of the employee's eligible compensation, plus 50 percent of the employee contribution up to the next 2 percent of the employee's eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Employer contributions, Plan earnings and administrative expenses. Allocations are based on participant's earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants can direct investments in their account into several investment options and are allowed to change investment selections on a daily basis.

Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000, up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The loan term may not exceed 60 months, unless it is to be used for the purchase of principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 2 percent, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. The participant is limited to three active loans at any given time.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employees who hired on or before December 31, 2019, are 100 percent vested in Employer contributions and related earnings. For employees who hired after December 31, 2019, employer contributions plus actual earnings thereon are fully vested at the end of five years with partial vesting as follows:

Forfeited Accounts

Forfeited non-vested accounts may be used to reduce future Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, the forfeited account balance was \$1,657 and \$551 respectively. During the year ended December 31, 2024, no forfeitures were used.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, participants can elect to receive a lump-sum amount equal to the value of their accounts. Upon reaching the age of 59 ½, a participant whose account is fully vested is entitled to receive a lump-sum payment equal to the value of the participant's account. A participant can make a hardship withdrawal, as defined in the Plan agreement.

Administrative Expenses

Administrative expenses could be paid by the Employer or the Plan at the Employer's discretion. The Employer provided significant administrative services at no expense to the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. As such, contributions are recorded when received and benefit payments, corrective distributions and expenses are recorded when paid. The modified cash basis differs from the cash basis in that investments are recorded at fair value and notes receivable from participants are recognized. Although the modified cash basis of accounting represents a departure from

accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment strategies for the pooled separate accounts and common collective trust vary based on the degree of investment risk chosen by the fund manager and the criteria of the fund or security's investment goals.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as a distribution based upon the terms of the plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Plan Tax Status

The Plan is based on a Non-Standardized Defined Contribution Pre-Approved Plan which has received a favorable opinion letter dated November 30, 2020, in which Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and therefore exempt from federal income taxes. The Plan has not separately applied for an opinion letter from the IRS. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan is qualified and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions. However, as of the date the financial statements were available to be issued, there were no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the Statement of Net Assets Available for Benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 3, 2025.

3. INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company ("John Hancock"), the custodian, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits and the schedule of assets (held at end of year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year then ended.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). However, in accordance with Subtopic 821-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled separate accounts:* Investments in pooled separate accounts are credited with earnings and gains or losses on the pooled investments. The separate accounts are stated at fair value as reported to the Plan by John Hancock Life Insurance Company, based on the quoted market prices of the underlying mutual funds. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. The investment strategies for the pooled separate accounts vary based on the degree of risk chosen by the participants.
- *Common/Collective trust:* Valued at the net asset value (NAV) of units of the John Hancock Stable Value Trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right

to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

6. PARTY-IN-INTEREST TRANSACTIONS AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Professional fees and certain other administration expenses of the Plan were paid by the Employer.

John Hancock Life Insurance Company is the custodian of the Plan and John Hancock Retirement Services is the recordkeeper of the Plan, July Business Services is the third-party administrator of the Plan, and Edward Jones is the investment advisor for the Plan. These services were paid by the Plan. Blue & Co., LLC is the independent auditor of the Plan and is paid by the Employer.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Employer contributions.
