## **1. Description of the Plan**

The following description of the Klehr Harrison Harvey Branzburg LLP Employee Health Insurance Plan (the Plan) is provided only for general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### **General**

The Plan provides health benefits as defined in the plan document, covering eligible employees of Klehr Harrison Harvey Branzburg LLP (the Firm), and their covered dependents. All full-time employees working at least 21 hours per week are eligible for all benefits. Eligibility for enrollment in the Firm's medical insurance plan for all partners and employees is the first of the month following 30 days of employment. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

Effective June 1, 2018, the Plan established a trust to hold the Plan assets. The trust received funding beginning July 18, 2018. Prior to the funding of the trust, all insurance premium payments were paid out of the general assets of the Firm.

### **Benefits**

The Plan provides health benefits (medical and prescription drugs) to all full-time employees and their covered dependents, as defined in the plan document; and, provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

### **Self-Insured Benefits**

The Plan self-insures all medical and prescription drug benefits. Claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative services only (ASO) arrangement. The claims processor pays claims directly or on behalf of participants and is then reimbursed by the Plan's trust. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan. Self-insured benefits are paid from assets of the trust.

### **Stop-Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement that limits its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

### **Contributions**

In addition to deductibles and co-payments, participants are generally required to contribute to the Plan to fund the cost of their benefits on a bi-weekly or semi-monthly basis through payroll deductions. Amounts required to be contributed by participants are determined annually by the Firm in accordance with the plan document and are based on current rate premium costs. The Firm makes contributions to the Plan as needed to fund claims in excess of participants' contributions, where such claims are not already covered under stop-loss insurance arrangements.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported; claims payable; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Payment of Benefits**

Premiums paid by the trust are recorded as insurance premiums paid in the accompanying Statement of Changes in Benefit Obligations and of Changes in Net Assets Available for Benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims and insurance premiums payable in the accompanying Statements of Benefit Obligations and of Net Assets Available for Benefits.

### **Claims Reimbursement**

Claims reimbursements, which are recorded as a reduction in self-insured claims paid in the accompanying Statement of Changes in Benefit Obligations and of Changes in Net Assets Available for Benefits totaled \$715,714 during the year ended December 31, 2024.

### **Stop-Loss Reimbursement Receivable**

Premiums for stop-loss insurance are included in insurance premiums paid in the Statement of Changes in Benefit Obligations and of Changes in Net Assets Available for Benefits. Stop-loss receivables represent amounts recoverable from the insurer for specific individual participant claims exceeding \$75,000, and are recorded as a reduction to self-insured claims paid. Stop-loss receivables totaled \$259,281 and \$0 as of December 31, 2024 and 2023, respectively.

Pursuant to the agreement with the stop-loss insurer, overall claims exceeding an annual aggregate self-insured limit established by the insurer at the beginning of the coverage year are reimbursed by the insurer. Settlement occurs at the end of the coverage period which runs from July 1 through June 30. No receivable has been recorded by the Plan as of December 31, 2024 or 2023 to reflect the settlement of aggregate excess claims.

### **Claims Incurred but Not Reported**

The Plan is self-insured for health claims up to \$75,000 per participant. Stop-loss insurance coverage is maintained for claims in excess of this amount. The Plan's liability for claims incurred, but not reported is estimated by the Plan's consultant, Benecon, using actuarial data provided by the insurance providers who have been retained by the Firm. Such estimated amounts are reported on the accompanying Statements of Benefit Obligations and of Net Assets Available for Benefits.

### **Administration of Plan Assets**

The Plan pays administrative expenses that consist primarily of administrative fees to third-party claims administrators and the consultant. These expenses are reported on the Statement of Changes in Benefit Obligations and of Changes in Net Assets Available for Benefits as administrative expenses. All other administrative expenses are paid by the Firm on behalf of the Plan and are excluded from these financial statements.

## **Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

## **3. Related-Party and Party in Interest Transactions**

As described in Notes 1 and 2, the Plan has several arrangements with service providers, these transactions are party in interest transactions under ERISA. Certain administrative functions are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

## **4. Plan Termination**

Although it has not expressed any intention to do so, the Firm has the right under the Plan to modify benefits provided to, and contributions required of, participants, or to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Firm or be used for purposes other than for the exclusive benefit of the Plan's participants.

## **5. Tax Status**

The plan administrator believes the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code (IRC). The trust established to fund the benefits of the Plan may be subject to income taxes. No federal income taxes have been recorded in 2024.

The trust is subject to unrelated business income tax as defined in IRC Sections 511 and 512. The unrelated business income tax is based on net investment income, allowing deductions for direct costs incurred in generating the investment income, and is computed at the tax rate of the trust. Due to the nature of the Plan's investments, unrelated business income tax is insignificant in 2024 and expected to be insignificant in subsequent years.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **6. Risks and Uncertainties**

Claims incurred but not reported are calculated based on historical trends of claims reported but not settled and claims that have been incurred but not reported. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
