Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hawthorne CAT 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Hawthorne CAT 401(k) Retirement Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Hawthorne CAT 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established and sponsored by Hawthorne Machinery Co. (the Company, Plan administrator) to provide employees with an opportunity to accumulate funds for their retirement. The Plan is administered by the Company's Investment Committee (Investment Committee), which has overall responsibility for the operation and administration of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to Delaware Charter Guarantee and Trust Company dba Principal Trust Company, the Plan's trustee (Trustee). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – The Plan covers substantially all employees of the Company, who have reached age 18 and have completed one month of service. Employees are eligible to participate in the Plan on the earliest quarterly date (January 1, April 1, July 1, and October 1) following eligibility.

Contributions

Participant contributions – Each participant may contribute between 1% and 100% of their annual pre-tax compensation subject to an annual limitation imposed by Internal Revenue Service (IRS) regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants who are age 50 or older are allowed to make catch up contributions, as defined in the Plan Document. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase annually by 1% each July 1 up to a maximum of 10% of eligible compensation.

Employer matching contributions – The Company may make discretionary matching contributions to the Plan. Employees subject to a collective bargaining agreement (CBA) receive an additional CBA contribution, as defined in the Plan Document, and are not eligible to receive discretionary matching contributions. The Company makes matching contributions of 50% of the first 6% of eligible compensation that a participant contributes to the Plan. For the year ended December 31, 2024, the Company made matching contributions totaling \$1,336,685.

Contributions are subject to regulatory limitations.

Participant accounts and allocations – Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and may be charged with an allocation of the Plan's administrative expenses.

Allocations of the Company's contribution are based on participant deferrals and compensation, as defined in the Plan Document. The benefit to, which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting – The portions of the participant's account attributable to elective deferral contributions, rollover contributions, and additional CBA contributions are 100% vested and non-forfeitable.

Matching contributions vest 20% after two complete years of service, as defined in the Plan Document, and an additional 20% for each complete year of service thereafter until fully vested.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan may be used to pay expenses related to the Plan, to offset future Company's matching contributions, or to offset future CBA contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51 and \$1,250, respectively. For the year ended December 31, 2024, Company matching contributions were reduced by \$109,908 from forfeited nonvested accounts and \$28,162 was used for payment of administrative expenses.

Notes receivable from participants – Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at a rate based on the rates available for similar notes from commercial lending institutions, as determined by the Plan administrator. Note repayment periods may not exceed five years except notes used to purchase a principal residence. In such case, a reasonable repayment period shall be established based on periods currently in effect for a commercial home loan. Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan Document. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.25% to 8.5%, with various maturities through May 2057.

Benefit payments – Upon termination of service for any reason, a participant may receive a lump sum distribution equal to the value of the participant's vested interest in his or her account, cash payments over a specified time period, or a fixed monthly benefit for life. Participants may withdraw from their vested account balances upon either attaining the age of 59-1/2 or experiencing a financial hardship, as defined in the Plan Document.

Such withdrawals are subject to applicable excise and income taxes and may only be made with the approval of the Plan administrator.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with standards generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expense during the reporting period. Actual results could differ from estimates.

Investment valuation and income recognition – Investments are reported at fair value. The Plan's trustee, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, certifies the fair value of all investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurement

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Units held in pooled separate accounts (PSA) are valued using the net asset value practical expedient (NAV practical expedient) of PSA as reported by the account managers. The NAV expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Collective trust: Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax Status

The Plan Document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain plan investments are managed by Principal Financial Group. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the Trustee of the Plan and an affiliate of Principal Financial Group and, therefore, transactions with these entities qualify as exempt party-in-interest transactions. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
