INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Motor Werks 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Motor Werks 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Motor Werks 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Merger

As discussed in Note 1A, on December 2, 2024, Plan management approved the merger of the Plan into the Murgado Automotive Group 401(k) Plan (f/k/a Miami Automotive Retail, Inc. 401(k) Plan), effective December 16, 2024 (or as soon as administratively feasible). As a result, all assets were transferred from the Plan into Murgado Automotive Group 401(k) Plan on December 13, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Motor Werks 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Motor Werks 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A) GENERAL

The Plan was established on July 1, 1990 under the name of Motor Werks of Barrington, Inc. 401(k) Plan, and is a defined contribution plan as defined by Section 401 of the Internal Revenue Code (the "Code"). Effective March 16, 2023, the plan was amended and restated, and the Plan name was changed to Motor Werks 401(k) Plan. As of the effective date of the name change, the plan covers all eligible employees of Murgado Motor Werks LLC (the "Plan Sponsor" or the "Company"). Prior to the name change, the Plan covered the eligible employees of Motor Werks of Barrington, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

On December 2, 2024, Plan management approved the merger of this Plan into the Murgado Automotive Group 401(k) Plan (f/k/a Miami Automotive Retail, Inc. 401(k) Plan and "surviving plan"), effective December 16, 2024 (or as soon as administratively feasible). As a result, 89% of the Plan's assets were transferred from the Plan into Murgado Automotive Group 401(k) Plan on December 13, 2024. Additionally, as a result of an advance by the custodian and record-keeper of the surviving plan, all participant account balances invested in the Plan's guaranteed investment contract ("GIC") were funded into the surviving plan and the custodian will be reimbursed when the GIC is redeemed (Note 4). The advance is included in other liabilities in the accompanying statements of net assets available for benefits.

B) ELIGIBILITY

Employees are eligible to participate in the Plan upon reaching the age of 21 and completing three months of service, as defined, prior to the entry date. Effective March 16, 2023, the Plan was amended to include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. Contributions are automatically invested in a designated fund until changed by the participant. The Plan entry date is semi-annually after meeting the above requirements.

C) CONTRIBUTIONS

Eligible employees can contribute up to 100% of pre-tax or after-tax (Roth option) annual eligible compensation, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contribution). Contributions are subject to certain limitations under the Code. In accordance with the Code, the total maximum allowable contribution to the Plan directly from the participant was \$23,000 for 2024, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

C) CONTRIBUTIONS (CONTINUED)

The Company may make discretionary employer matching and non-elective contributions as determined by the Company's management. There were no discretionary or non-elective contributions for the year ended December 31, 2024.

D) VESTING

Participants are immediately vested in their contributions, employer matching and qualified non-elective contributions, plus actual earnings thereon. The Plan includes a 3-year cliff vesting schedule for other employer contributions and any other special contributions, as defined in the Plan document.

Participants are 100% vested, regardless of years of service, when they reach normal retirement age, are totally and permanently disabled, or death occurs.

E) PAYMENT OF BENEFITS

Benefits are payable on termination of service due to retirement, termination, disability or death. Participants or their beneficiaries may elect to receive a lump-sum distribution, partial withdrawals, or distributions in kind as defined in the Plan document. Eligible participants may also make hardship withdrawals, as defined.

F) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's compensation deferral contributions, the Company's discretionary matching and non-elective contributions, if any, and an allocation of the investment earnings, based upon each participant's election. The benefit to which a participant is entitled upon withdrawal from the Plan, as defined above, is the vested benefit in the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

G) INVESTMENT OPTIONS

Participants are allowed to invest their elective 401(k) contributions, rollovers, if any, as well as Company matching and non-elective contributions to the Plan in a variety of investment options as more fully described in the Plan document. Participants may change their investment options and deferral percentages quarterly.

H) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (a) 50 percent of their vested account balance, or (b) \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. Participants are permitted to have two loans outstanding at any given time. The notes are secured by the vested balance in the participant's account. Notes bear interest at a fixed rate based on rates available for similar loans from commercial lending institutions at origination.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

H) NOTES RECEIVABLE FROM PARTICIPANTS (CONTINUED)

Principal and interest is repaid through payroll deductions over a period of no more than five years, unless the loan is used for the purchase of a primary residence.

I) FORFEITED ACCOUNTS

Pursuant to the Plan, forfeited non-vested accounts may be used to pay Plan expenses or reduce future employer contributions. At December 31, 2024 and 2023, there were no forfeited non-vested accounts and no forfeitures were utilized to pay Plan expenses or offset employer contributions during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

A) BASIS OF ACCOUNTING

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America for employee benefit plans.

B) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

C) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividend and interest income are recorded by the trustee in the period earned. Net realized and unrealized appreciation or depreciation in fair value of investments consists of the change in unrealized appreciation or depreciation and the realized gain or loss on the sales of investments during the year. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Investments are self-directed by the individual Plan participants.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

D) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

E) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

F) PAYMENT OF BENEFITS

Benefits are recorded when paid.

G) ADMINISTRATIVE EXPENSES

The Plan agreement allows for the Company to absorb the majority of the Plan's administrative expenses. Investment related expenses are included in net appreciation of fair value of investments through revenue sharing arrangements. During the year ended December 31, 2024, the Plan incurred approximately \$11,000 in administrative expenses.

H) RECENT ACCOUNTING PRONOUNCEMENTS

The Company evaluates new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

I) MANAGEMENT REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 3, 2025, the date when the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Certain Plan investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 inputs were available and therefore used. No level 2 and 3 inputs were used by the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - The mutual funds have observable Level 1 pricing inputs, including quoted prices for identical assets in active markets. Mutual funds are valued at the quoted net asset value ("NAV") of shares held by the Plan at year-end.

Collective Investment Trusts - The collective investment trusts invest in collective trust funds as well as a variety of separate accounts and mutual funds. Collective investment trusts are valued using the NAV as a practical expedient.

The input levels used by investment category are as follows:

All of these investments valued at NAV have no unfunded commitments or redemption restrictions and can be redeemed daily.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the fiscal year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE 4 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a traditional fully benefit-responsive investment contract with Principal Life Insurance Company with a contract value of \$1,880,578 and \$1,803,147 as of December 31, 2024 and 2023. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reset semi-annually. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 4 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan, (2) the establishment or activation, or material change in, any Plan investment fund, or (3) an amendment to the Plan or change in the administration or operation of the Plan, including the removal of a group of employees from the Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. As discussed in Notes 1A and 5, the Plan will subsequently terminate after the merger and as such, contract value is equivalent to fair value for the investment as of December 31, 2024.

Due to redemption restrictions of the contract, the investment could not be liquidated at the date of the merger. Therefore, the record-keeper for the surviving plan advanced approximately \$1,879,000 to the Plan to facilitate the merger in a timely manner. These funds will be repaid to the record-keeper upon liquidation. The advance is reported as other liabilities in the accompanying statements of net assets available for benefits.

NOTE 5 - PLAN TERMINATION

The Company has the right to suspend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. In accordance with the Plan merger (Note 1A), the Plan will subsequently terminate after the merger is finalized.

NOTE 6 - TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds, collective investment trusts, and guaranteed investment contract are managed by Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation or depreciation in fair value of the investment as they are paid through revenue sharing, rather than direct payment. During the year ended December 31, 2024, Voya Retirement Insurance and Annuity Company (“Voya”) advanced approximately \$1,879,000 to the Plan to facilitate the plan merger. Voya is the record-keeper and custodian of the surviving plan, and therefore, this transaction qualifies as a party-in-interest transaction. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. During 2024 and 2023, the Plan Sponsor paid certain administration and other operating expenses of the Plan.

NOTE 8 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, the trustee and qualified institution, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

The Company maintains a fidelity bond of \$500,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.
