## INDEPENDENT AUDITORS' REPORT

To the Trustee, Plan Administrator and Participants of  
the JRN, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of JRN, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the JRN, Inc., 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have six months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Eligible employees may contribute to the Plan through payroll deductions any amount between 1% to 90% of their annual compensation, not to exceed the Internal Revenue Code of 1986 contributions limit. The Company will match \$0.25 for each \$1.00, up to 4% of employee's compensation.

Participants' Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. All safe harbor enhanced matching contributions will at all times be 100% vested. A participant is vested in the employer contributions and related earnings as follows:

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

Investment Options

Participants may choose to direct their investments in certain shares of registered investment companies.

Participants can modify their salary deferral election on the first day of any payroll period. The participants are permitted to revoke their salary deferral election any time during the Plan year. Participants may change the investment direction of future contributions online or through a toll-free voice response system daily.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, direct rollover to another qualified plan, or combination of cash distribution and partial direct rollover to another qualified plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in any of the forms previously mentioned.

Operating Expenses

Certain operating and administrative expenses incurred by the Plan are absorbed by the Sponsor.

Forfeited Accounts

Forfeited, nonvested account balances may be used to reduce the Company's contributions and pay plan expenses. The accumulated balance is maintained in several funds until applied to the Company contributions or plan expenses. The amount in the forfeiture account, including investment earnings was \$13,836 and \$9,690 as of December 31, 2024 and 2023, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

General

The Plan administrator is JRN, Inc. The trustee of the Plan is Fidelity Management Trust Company as of December 31, 2024 and 2023. Certain administrative expenses of the plan are paid by the Company. The following companies participate in the plan and are collectively referred to in this financial statement as the "Company": JRN, Inc. and Neal Auction Company.

Basis of Accounting

The Plan's financial statements are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Except for the common/collective trust fund described below, the Plan's investments are stated at fair value as reported by Fidelity Management Trust. Shares of common/collective trust fund investments are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Galliard Stable Return Fund is a common/collective trust that is fully invested in the Galliard Stable Return Fund Core, of which the majority is invested in fixed income portfolios that are wrapped by stable value contracts. The Plan reports its investment in the Galliard Stable Return Fund at fair value using the net asset value of the units held by the fund at year end as a practical expedient. The Galliard Stable Return Fund does not invest directly in fully benefit-responsive contracts, and there the Plan is not required to include in the financial statements the disclosure requirements for investments in fully benefit-responsive contracts or stable value funds. Redemptions from the Galliard Stable Return Fund are permitted at current net asset value following a 12-month notice period. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

There were no changes in the valuation methodologies used at December 31, 2024 and 2023 compared to prior year.

Payment of Benefits

Benefits are recorded when paid.

Events Occurring After Reporting Date

Plan management has evaluated events and transactions that occurred after December 31, 2024 through October 7, 2025. During the period, there were no material recognizable subsequent events that required recognition in our disclosures to the financial statements.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 5 - TAX STATUS**

The Plan obtained its latest determination letter in June 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - FAIR VALUE HIERARCHY**

The fair value hierarchy established by the standard on fair value measurements includes three levels which are based on priority of inputs to the valuation technique, along with net asset value. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If inputs used to measure the financial instruments fall within different levels of the hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument. In accordance with the standard on fair value, the Plan's financial assets and liabilities that are recorded on the Statements of Net Assets Available for Benefits are categorized based on the inputs to the valuation techniques as follows:

Level 1: Assets and liabilities whose values are based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan can access.

Level 2: Assets and liabilities whose values are based on the following:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in markets that are not active; or
- (c) Valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

Level 3: Assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Unobservable inputs reflect the Plan's estimates of the assumptions that market participants would use in valuing the assets and liabilities.

Net Asset Value ("NAV"): Assets measured at net asset value as a practical expedient in determining fair value.

The Plan provides for various investment options in several investment securities and instruments. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks and values in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.
