Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Goodheart 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF THE PLAN

Bluebonnet Foods, L.P. DBA GoodHeart Brand Specialty Foods (the “Company” or “Plan Sponsor”) established the Goodheart 401(k) Plan (the “Plan”) effective January 1, 2009. As required by the Internal Revenue Service (“IRS”), the plan document was restated effective June 9, 2022 to comply with certain IRS regulations. The following description of the Plan provides only general information. Plan participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan is a safe-harbor, volume submitter, defined contribution plan covering most full-time employees of the Company aged 21 or older and who have completed one year of continuous service (1,000 hours). The Plan excludes those covered under a collective bargaining agreement, nonresident aliens, and part-time employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Participants may contribute certain amounts of their pre-tax annual compensation, as defined in the Plan, not to exceed certain limits defined by applicable Internal Revenue Service (“IRS”) regulations. Participants may also make Roth (post-tax) contributions to the Plan, subject to applicable IRS guidelines. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the applicable tax year are eligible to make catch-up contributions.

The Company shall contribute 100 percent of the first 3 percent of compensation contributed by the participant, and then 50 percent of those amounts contributed greater than 3 percent of compensation, but no more than 5 percent of compensation. The Company may also make non-elective contributions, which are determined at the discretion of the Board of Directors and allocated in an amount equal to a percentage of the participants’ eligible compensation. The Company allocates its contributions into the investment options equal to the percentages specified by the participant. All contributions are subject to certain limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participant accounts are invested in accordance with investment directions provided by each participant.

Payment of Benefits – Upon retirement age, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments. Upon termination, a Participant’s vested balance may be rolled into a qualified plan or distributed in a lump sum payment. Any balance under \$1,000 is automatically paid out as soon as administratively possible. Hardship withdrawals are available subject to certain limitations.

1. DESCRIPTION OF THE PLAN (continued)

Forfeited Accounts – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. Forfeited balances of terminated participants’ non-vested accounts are used to reduce future employer contributions. No forfeitures were used during 2024 or 2023 to offset employer contributions to the Plan.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon as well as all mandatory Company matching contributions. Vesting in the Company’s non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service without regard to number of hours worked as follows:

Parties-in-Interest Transactions – Certain Plan investments are shares of separate accounts managed by John Hancock Life Insurance Company (“John Hancock”). John Hancock is the Recordkeeper and Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid for legal, accounting, and other services rendered by parties-in-interest are based on customary and reasonable rates and, if paid by the Plan Sponsor, are excluded from these financial statements.

Plan Expenses – Plan administrative fees, including investment management fees, recordkeeping fees and advisor fees are allocated to individual participant accounts. Other fees incurred by the Plan are paid by the Plan Sponsor.

Plan Termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Recognition of Income – The basis of investments held by the Plan is adjusted annually to closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using this adjusted basis. Security transaction expenses are considered in computing realized gains and losses on investments.

Investments – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Risks and Uncertainties – Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the near-term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Accounting Estimates – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from these estimates.

New Accounting Pronouncements – Management is not aware of any new accounting pronouncements that have been released, and are not yet effective, which will have a significant impact on its financial position or results of operations in future periods.

3. INFORMATION CERTIFIED BY THIRD PARTY (UNAUDITED)

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations, information prepared and certified by a bank or insurance company, which is regulated, supervised and subject to periodic examination by a state or federal agency, need not be audited. The Plan Administrator has received certification from John Hancock Life Insurance Company ("Custodian") of the market value of the Plan's portfolio as of December 31, 2024 and 2023, and the related net appreciation in fair value of investments for the years then ended. 5. INCOME TAX STATUS

The Plan has adopted a volume submitter plan document that has received a favorable advisory letter from the IRS dated June 30, 2020, which states that it is approved by the IRS for use with the Plan. Accordingly, the Plan relies on the favorable advisory letter as evidence that the Plan is qualified to the extent prescribed by the IRS under Code Section 401(a). Although the Plan has been amended since receiving the volume submitter plan advisory letter, in the opinion of the Plan Sponsor, the Plan is currently designed and being operated in all material respects in compliance with the applicable requirements of the Code and, therefore, the Plan is qualified, and the related trust is tax-exempt.

5. INCOME TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Sponsor has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021.

6. FIDELITY COVERAGE

The Plan is covered under a fiduciary insurance policy for the years ended December 31, 2024 and 2023, which meets the ERISA coverage requirement for the plan years.

7. FAIR VALUE OF FINANCIAL INSTRUMENTS

FASB Accounting Standards Codification 820 (“FASB ASC 820”), “*Fair Value Measurements and Disclosures*”, provides the framework for measuring fair value for financial assets and liabilities. The Plan does not have any nonfinancial assets or liabilities. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs – Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the plan has the ability to access.

Level 2 Inputs – Inputs to the valuation methodology are other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability (for example, interest rates, volatilities, prepayment speeds, loss severities, credit risks and default rates) or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs – Significant unobservable inputs that reflect an entity’s own assumptions that market participants would use in pricing the assets or liabilities.

A description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Custodian determines fair value based on quoted market prices, where available. If quoted prices are not available, fair value is estimated based upon other observable inputs. The Custodian uses unobservable inputs when observable inputs are not available. Adjustments may be made to reflect the assumptions that market participants would use in pricing the asset or liability.

Registered Investment Companies – The Plan’s investments in Registered Investment Companies are Level 1 instruments. The Level 1 assets are valued at the closing price reported in the active market in which the investment is traded.
