## INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Participants of  
Pan American Grain Retirement and Savings Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Pan American Grain Retirement and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements .

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2024 and 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters**

##### *Supplemental Schedule Required by ERISA*

The supplemental Schedule H, line 4i – Schedule of Assets held at end of year at December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. DESCRIPTION OF THE PLAN**

The following description of the Pan American Grain Retirement & Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**Plan Description** – The Plan is a defined contribution plan established by Pan American Grain Co. Inc., Pan American Grain MFG. Co. Inc., and Pan American Properties Corp. (the “Sponsors”) to encourage among employees a team working relationship and a genuine interest and loyalty to the Company. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s investments are principally held in mutual funds administered on a discretionary basis by the Trust Division of Banco Popular de Puerto Rico (the “Trustee”) (a party-in-interest). The Plan and the Trust were established on February 1, 2001.

**Eligibility** – Employees of Pan American Grain Co. Inc., Pan American Grain MFG. Co. Inc., and Pan American Properties Corp. who have completed at least one year of service as determined in accordance with the Plan’s rules and are 18 years of age or older are eligible to participate in the Plan.

**Contributions to the Plan** – Participants may contribute a pre-tax annual contribution up to the maximum amount in accordance with the provisions of the Puerto Rico Income Tax Code (\$15,000 for the years ended December 31, 2024 and 2023). After-Tax contributions may not exceed 10% of the aggregate compensation paid to the participant. The employer will make a matching contribution equal to \$0.50 cents of each dollar of a participant's pre-tax contributions. However, the employer will not make matching contributions above 10% of the participant’s eligible compensation, as defined for matching and profit-sharing contribution. Employees contributions and Plan Sponsors matching contributions are recorded in the plan year period in which the Plan Sponsors make payroll deductions from the Plan participants' earnings.

A participant that had attained an age of fifty (50) by the end of the Plan’s year can make an additional pre-tax contribution as approved by the Puerto Rico Income Taxes Code. This additional contribution is not eligible for matching.

Effective May 2017, the Plan amended employer matching contributions to be contributed to the Plan annually. Matching contributions for each plan year shall be allocated as of the last day of such plan year. A participant will be required to be an employee on the last day of such plan year or to have left employment during the plan year because of retirement, death or disability in order to receive matching contributions during such plan year.

**Participant Individual Accounts** – Each participant account is credited with the participant’s contribution and allocations of (a) the Sponsors’ contribution and, (b) Plan earnings and (c) at the discretion of the Plan Sponsors, forfeitures of terminated participants’ non-vested accounts. The benefits to which the employee has rights are limited to the amount of his/her individual account.

**Forfeited Accounts** – The portion of a participant’s account not vested at the date of his/her termination of employment is forfeited immediately. Forfeitures under the Plan will be either allocated to Participant's accounts during the Plan Year, to reduce the amount the Employer must contribute to the Plan or used to reduce related Plan costs and expenses. For the years ended December 31, 2024 and 2023, the balance in the forfeitures account amounted to \$0, respectively.

**Vested Benefits** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsors’ contribution portion is based on years of continuous service. Vesting is earned 100% upon reaching 3 years of service.

**Plan Expenses and Administration** – Banco Popular de Puerto Rico Trust Division (“BPPR”) serves as record keeper, trustee, and custodian for the Plan. The Plan Sponsors are responsible for the general administration of the Plan and for carrying out the provisions thereof. The Plan Sponsors have established a committee to discharge the administration and fiduciary duties under the Plan. Administrative expenses such as, specialists, and all costs of administering the plan are borne by the Plan Sponsors. In addition, certain investments related expenses are included in the net (depreciation)/ appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Investment Options** – Upon enrollment in the Plan, a participant may make direct contributions into various investment options offered by the Plan. Contributions to a participant account that has not chosen an investment option are invested in a default portfolio of funds. Participants may change their contributions at any time thereafter. The Plan also allows participants to change their investment options daily.

**Payment of Benefits** – Immediate distributions may be made at participants’ election upon termination of employment in lump sum payment or in monthly installments over a period up to ten (10) years. The normal retirement age is the date a participant attains their sixty fifth (65th) birthday. Early retirement is permitted at the participant's election if the participant has reached the age of fifty-five (55) years and five (5) years of service. A participant may withdraw amounts at any time from their salary after-tax contributions account, subject to uniform and nondiscriminatory standards established by the Plan Administrator. In the case of a participant termination because of death, the entire vested amount is paid to the person or persons legally entitled thereto.

Effective May 2017, the Plan amended participants in service withdrawals, after age 59.5, to allow withdrawals from the vested portion of the matching contribution accounts under the Plan. Therefore, participants will be allowed to make withdrawals after age 59.5 from their pretax, catch up, qualified matching and qualified non-elective contribution accounts, and vested portion of the matching contribution accounts.

**Hardship Withdrawals** – Under the provisions of the Plan, participants are permitted to make hardship withdrawals out from the participant's pre-tax, catch-up, match and rollover contributions. Such withdrawal is only permitted if: a) financial hardship is demonstrated, b) the withdrawal is approved by the Plan Administrator and c) such withdrawal is allowable under the Puerto Rico Income Tax Code.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies used by the Plan follows:

**Basis of Accounting** – The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting periods. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 to the Financial Statements for additional disclosures related to fair value measurements.

The Plan investment return includes interest income, gains and losses on sale of investments and unrealized appreciation or depreciation of investments. The financial statements reflect the net appreciation or depreciation in the fair value of the Plan's investments. This net appreciation or depreciation consists of realized gains and losses calculated as the difference between proceeds from a sales transaction and cost, and unrealized gains and losses calculated as the change in the fair value between beginning of the year (or purchase date if later) and the end of the year.

**Payment of Benefits** – Benefits are recorded when paid. There were no benefits payable to terminated participants as of December 31, 2024 and 2023.

**3. FAIR VALUE MEASUREMENTS**

The Plan uses a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

***Interest Bearing Deposit*** – The carrying amount of interest-bearing deposits are reasonable estimates of the fair value due to its short-term maturity. These interest-bearing deposits are available upon demand, hence, classified as Level 1.

***Mutual Funds*** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

A major portion of the cash and cash equivalents is invested in a fund that invests primarily in short-term U.S. Treasury and government securities.

**4. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Banco Popular, the trustee of the Plan, has certified as to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the Supplemental Schedule H, Part IV, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Each investment is subject to market risk. The degree of market risk varies by investment type based upon the nature of the applicable underlying net assets. The Plan's maximum exposure to accounting loss from such investments is represented by the amounts appearing in the statements of net assets available for benefits.

**5. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsors have the right under the Plan to reduce, suspend or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan terminates, the interest of each participating employee in the Plan shall be fully vested and such termination shall not reduce the interest of any participating employee, or their beneficiaries accrued under the Plan up to the date of such termination.

**6. RISK AND UNCERTAINTIES**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and level of uncertainty related to changes in the values of investments, it is possible that changes in market values in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits. Individual participants' accounts bear the risk of loss resulting from fluctuations in fund values.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

**7. PARTIES-IN-INTEREST**

Certain Plan investments consist of funds administered by an affiliate of Popular Fiduciary Services and affiliates, the Plan's custodian and record keeper and therefore, these transactions qualify as allowable party-in-interest transactions. Other related parties consist of Pan American Grain Co. Inc., Pan American Grain MFG. Co., and Pan American Properties Corp., as employers, directors, officers and employees of Pan American Grain Co. Inc., Pan American Grain MFG. Co., and Pan American Properties Corp., and affiliates.

There were no prohibited party-in-interest investments or transactions as of December 31, 2024 and 2023, respectively.

**8. NON-DISCRIMINATION TEST**

For the years ended December 31, 2024 and 2023, the Plan failed the non-discrimination test. To correct the excess contribution corresponding to 2024 and 2023, the Plan opted to reimburse, and to disclose as a liability, the excess contributions amounting to \$7,025 and \$31,517, respectively, to certain highly compensated participants.

**9. TAX STATUS**

The Puerto Rico Treasury Department (the “Department”) has determined and informed in a letter dated April 23, 2018, that the Plan and related trust are designed in accordance with applicable sections entitling them to exemption of income taxes under the Puerto Rico income tax laws. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. In Puerto Rico, the tax laws permit examination of the Plan Sponsor’s income tax returns for up to four years after the initial return is filed. The tax years of the Plan Sponsor with respect to the Plan that remain open for examination are from 2020 to 2023.

**10. SUBSEQUENT EVENTS**

The Plan Administrator evaluated subsequent events through October 2, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that would require further disclosure in the Plan’s financial statements.
