## Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of US Grid Services 401(k) Plan (formerly SunGrid 401(k) Plan) (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). ## A. Description of Plan

The following description of the US Grid Services 401(k) Plan (formerly SunGrid 401(k) Plan) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan sponsored by TruGrid Holdco, LLC (formerly SunGrid US LP) (the Plan Sponsor) and was formed on January 1, 2024. The Plan Sponsor is a member of a controlled group, which includes the following participating employers (collectively, the Company or Employer):

Black Electric  
TruGrid Intermediate Holdings  
TruGrid US LLC

The Plan covers substantially all employees of the Company other than union and leased employees, nonresident aliens, and interns who are 18 years of age or older and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

During 2024, participant account balances, previously part of the Company's PEO plan, were transferred into the Plan. The amounts transferred in are recorded as Transfer in from other qualified plans in the statement of changes in net assets available for benefits.

2. *Contributions.* Each year, participants may contribute up to 100% percent of pretax and after-tax annual eligible compensation, as defined in the Plan, or the annual limit defined by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an automatic elective deferral provision starting at 3%, which will increase annually by 1% up to a maximum of 10%. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions of 100% of contributed compensation up to 4%. The Company may also make discretionary profit sharing contributions and qualified nonelective contributions, although this was not elected for the year ended December 31, 2024. A participant must be employed on the last day of the Plan year in order to be eligible for discretionary profit sharing contributions. Highly compensated employees are not eligible to receive qualified nonelective contributions.

Contributions are subject to certain IRS limitations.

3. *Participant accounts.* Each participant's account is credited with the participant's contributions, Employer contributions, rollovers, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are immediately vested in their contributions, Employer contributions, and actual earnings thereon.
5. *Payment of benefits.* On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. For distributions of amounts of \$5,000 or less, no participant consent is required. In addition, the Plan allows for hardship distributions if certain criteria are met.
6. *Forfeited accounts.* These accounts will be used to pay Plan expenses, to restore participant accounts, or reduce future Employer contributions. For the year ended December 31, 2024, no available forfeitures were used nor were there material forfeiture balances as of December 31, 2024, available for use.

## B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and custodian. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Payment of benefits.* Benefits are recorded when paid.
5. *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to withdrawals are included with benefits paid to participants in the statement of changes in net assets available for benefits. Fees related to recordkeeping and investment advisory services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.
6. *Subsequent events.* The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended and the Plan name was changed to US Grid Services 401(k) Plan (formerly SunGrid 401(k) Plan). The amendment also reflected the name change of the Plan Sponsor to TruGrid Holdco, LLC (formerly SunGrid US LP).

## C. Certified Investments

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations under ERISA. Accordingly, the Plan trustee, Ascensus as agent for Ascensus Trust Company (Ascensus), has certified that the following data included in the Plan's financial statements as of and for the year ended December 31, 2024, and supplemental schedules is complete and accurate.

## D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV of underlying investments of participant units held by the Plan as of the last trading day of the period, as reported by the managers of the trust.

*Money market account:* Valued at the daily closing price as reported on the active market on which the individual fund is traded.

## E. Party in Interest Transactions

Plan investments are managed by Ascensus; therefore, these transactions qualify as party in interest transactions. The Plan also paid fees to parties in interest for recordkeeping (The Vanguard Group, Inc. serves as recordkeeper to the Plan), administration, and investment advisory services during the year ended December 31, 2024, which qualify as party in interest transactions.

## F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

## G. Tax Status

The Plan adopted a non-standardized profit-sharing plan with CODA that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## I. Prohibited Transaction

During 2024, the Company inadvertently failed to deposit \$85,172 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Company intends to deposit lost earnings to correct this failure in 2025 and make any required filings with the DOL. The correction and any excise taxes, if applicable, will be made from the Company's assets and not from assets of the Plan.
