Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MidOcean US Advisor LP 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the MidOcean US Advisor LP (the “Company”) 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The MidOcean US Advisor LP 401k Plan is a defined contribution employee benefit plan including 401(k) and profit sharing. The Plan was established effective January 1, 2004. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversees governance of the Plan, determines the appropriateness of Plan’s investment offerings, and monitors investment performance.

Participation

Generally, all full-time employees of MidOcean US Advisor LP and participating employer ATL Advisor LP over the age of 21 are eligible to participate with exclusions for interns, leased employees, nonresident aliens who do not receive United States source income, and employees covered under a collective bargaining agreement unless specifically included by the agreement. The entry date for initial participation is the first calendar day of the month following the employee’s hire date.

Contributions

The Plan is funded through contributions by participants and the Company. An employee may designate multiples of 1% or a flat dollar amount, up to a maximum of 90% of earnings, as pre-tax or Roth 401(k) contributions, or a combination of the two. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes Non-elective Safe Harbor contributions equal to 3% of eligible compensation. The Company may also make a discretionary employer contribution with each eligible participant considered to be their own allocation group. A participant is eligible for a discretionary employer contribution if they have worked at least 501 hours during the Plan year or be employed as of the last day of the Plan year. Discretionary employer contributions totaling \$778,492 were authorized for the year ended December 31, 2024.

Vesting

Participants are immediately vested in both their employee deferral contributions and Non-elective Safe Harbor contributions, plus actual earnings thereon. Discretionary employer contributions vest on the following 6 year graded schedule.

Investment Options

Participants may invest in a variety of separate investment funds in proportions elected by the participant. The Company's Non-elective Safe Harbor and discretionary employer contributions are invested as selected by the participant. If no contribution investment election is made by the participant, the contributions are invested in one of the Fidelity Freedom funds based on the participant's date of birth and are available for immediate reallocation by the participant.

Participant Accounts

Separate accounts are maintained for each investment option: pre-tax contributions, Roth contributions, rollovers and transfers, and Company contributions and accumulated earnings thereon. Earnings or losses are allocated daily to each participant's account in the ratio of the participant's account balance to total participants' account balances. Distributions and withdrawals are charged to participant accounts.

Benefits paid to participants

Participants may withdraw all or a portion of their vested funds upon retirement, disability, death, or termination of employment, subject to the IRC's required minimum distribution rules. Participants may elect to postpone distribution unless the vested balance is below the de minimis cash out threshold. If the participant's account balance is between \$1,000 and \$7,000, the Plan administrator makes an automatic rollover of the account balance to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan administrator directs the Trustee to make a lump sum distribution. Participants may elect to receive in service distributions upon meeting age and service requirements. Distributions of a participant 401k balance may be authorized at any time by the Plan administrator under certain hardship conditions. Effective November 12, 2024, the plan elected to allow withdrawals for emergency expenses, declared disasters, domestic abuse, and qualified birth or adoption.

Notes Receivable from participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Such notes bear interest at a reasonable rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money as determined by the Plan administrator. Principal and interest is paid ratably through semi-monthly payroll deductions.

Forfeitures

Forfeited non-vested accounts are used to reduce administrative expenses or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,308 and \$26, respectively. During 2024, \$91,603 was used to reduce employer contributions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates and Risks and Uncertainties

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based upon the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable expenses for administration of the Plan may be paid out of the Plan's trust unless paid by the Company. Certain additional expenses relating to specific participant transactions such as loan fees or distribution processing fees are charged directly to the participant's account.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan classifies its investments into a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels. The following is a brief description of these three levels:

Level 1 — Quoted prices in active markets for identical assets or liabilities

Level 2 — Inputs that are derived principally from or corroborated by observable market data

Level 3 — Inputs that are unobservable and significant to the overall fair value measurement

Following as a description of the valuation methodology used for assets measured at fair value. There has been no change in the valuation methodology used at December 31, 2024 and 2023.

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Assets measured at fair value are comprised of Level 1 mutual funds at December 31, 2024 and 2023, totaling \$44,421,777 and \$36,416,416, respectively.

NOTE 4: CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan.

NOTE 5: PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth under ERISA. In the event of termination, participants will become 100% vested in their employer contributions and the net assets of the Plan will be distributed in accordance with ERISA.

NOTE 6: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7: TAX STATUS

The Internal Revenue Service has determined and informed FMR LLC on behalf of the Company (most recently by letter dated June 30, 2020) that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Company and Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and that the Plan and the related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities with occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
