### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cedar Valley Bankshares, Ltd. Profit Sharing and 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cedar Valley Bankshares, Ltd. ### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

---

#### 1. PLAN DESCRIPTION

The following brief description of the Cedar Valley Bankshares, Ltd. Profit Sharing and 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

The Plan is a defined contribution plan sponsored by Cedar Valley Bankshares, Ltd. and its wholly owned subsidiary First Security Bank and Trust Company, Charles City, Iowa (collectively, the “Company”).

An employee is eligible to participate on the first day of the plan quarter following the attainment of age 20. In order to be eligible for the employer matching contribution and profit-sharing contribution, the employee must complete 1,000 hours and one year of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code of 1986, as amended.

401(k) Contributions - Participants are allowed to contribute an amount up to 80% of their annual compensation for the Plan year. The Company contributes a matching contribution equal to 50% of the participant’s contributions to the Plan up to 8% of the employee's eligible compensation. The Plan allows participants to designate contributions as Roth 401(k) contributions.

The plan includes an automatic deferral contribution arrangement whereby newly eligible employees hired after January 1, 2020, are automatically enrolled in the Plan at a rate of 3% of the employee’s eligible compensation, unless the employee elects a different deferral percentage. Such contributions are directed by the Goal Manager Target Date Funds based on the employee’s date of birth and when the Plan’s normal retirement date will be reached unless another election is made by the employee. Additionally, the Plan includes an automatic deferral contribution increase provision whereby employee deferral contributions automatically increase 1% for automatically enrolled employees every first payroll period of January, up to 8%, unless another election is made by the employee.

Profit Sharing Contribution - For each Plan year, the Company may, at its sole discretion, contribute an additional amount to the Plan that is allocated to the participants based upon an individual's eligible compensation compared to total eligible compensation for all participating employees.

Rollover Contributions - Participants may rollover account balances from other qualified plans.

Investment Options and Participant Accounts - Participants select the investment direction of their account balance among various investment options including a self-directed option which allows participants to invest their account balance among an unlimited choice of investments. Participants may change their investment options daily.

Each participant's account is credited with the participant's contribution, the Company's contribution, allocations of the Plan's earnings and charged with an allocation of administrative expenses.

Vesting - Participants are 100% vested in their contribution plus actual earnings thereon. Vesting in the Company contributions portion of their accounts is based upon years of service. A participant is 100% vested after six years of service.

Vesting is based on years of credited services as set forth in the following table:

Payment of Benefits - Upon termination of service, benefits are paid to the participant or their beneficiary as a lump sum payment.

A terminated participant with a balance less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$7,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

Forfeited Accounts - Under the terms of the Plan agreement, forfeitures are used to reduce Company contributions. In the years ended December 31, 2024, and 2023 employer contributions were reduced by \$0, and \$23,600, respectively, from forfeited nonvested account balances.

Notes Receivable from Participants - Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. The interest rate, determined on the day the loan is requested, is set at 2% above the prime rate. Principal and interest

is paid ratably through payroll deductions over a period not to exceed five years. A participant may have no more than one general purpose and one residential outstanding note at any one time.

Plan Termination - Although they have not expressed any intention to do so, the Company may discontinue the Plan at any time in accordance with the provisions of the Plan and ERISA. In the event of termination of the Plan, the participants would become fully vested in their account balances.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the plan are maintained on the accrual basis of accounting.

Contributions – Participant contributions and the related Company matching contributions are recorded in the year which the employee contributions are withheld from compensation.

Investments - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Expenses - Administrative costs of the Plan are generally paid by the Company with certain expenses paid by Plan participants, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits. These transactions are exempt party-in-interest transactions under ERISA. The Company provides management services to the Plan. No fees are charged to the Plan for these services.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payments of Benefits – Benefit payments to participants are recorded upon distribution. Amounts

allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$0 and \$0 at December 31, 2024 and 2023, respectively.

### 3. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Bank of America, N.A., the trustee.

### 4. FAIR VALUE MEASUREMENTS

Investments are grouped at fair value in three levels, based on the markets in which the investments are traded and the reliability of the assumptions used to determine fair value. These levels are:

- Level 1 - valuation is based upon quoted prices for identical instruments traded in active markets.
- Level 2 - valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3 - valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobservable assumptions reflect Plan estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/Collective Trust Fund - Valued at fair value based on the net asset value (NAV) of observable market prices of the underlying assets within that account less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Mutual Funds (including money market mutual funds) - Valued at fair value based upon the quoted NAV of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

The plan administrator determines the Plan's valuation policies utilizing information provided by

the investment advisers, trustees, and other third parties.

## 5. INCOME TAX STATUS

The Plan uses a pre-approved plan document sponsored by Merrill Lynch Pierce Fenner & Smith Inc., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 6. RISK AND UNCERTAINTIES

The Plan’s investments are exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the statements of net assets available for benefits.

7. EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service or for nondiscrimination provisions are recorded as a liability with a corresponding reduction to contributions. The amount of excess contributions was \$2,346 and \$19,406 as of December 31, 2024 and 2023, respectively.
