NOTE 1 - DESCRIPTION OF PLAN

The following description of The Ensono 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan maintained for the benefit of eligible employees of Ensono LP (the Company). The Plan is subject to the provisions for the Employee Retirement Income Security Act (“ERISA”) of 1974, as amended.

Contributions: Each year, participants may contribute up to 30% of eligible compensation, as defined in the Plan. Employees are automatically enrolled at a 6% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. The deferral rate is increased annually by 1% until the participant deferral amount reaches 15% of their eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans, in the form of rollovers.

Annually, the Company makes matching contributions to the account of each eligible employee equal to 50% of the first 6% of eligible compensation that a participant contributes to the Plan. The Company may, at its discretion, make additional qualified non-elective contributions to the Plan on an annual basis. There were no non-elective contributions for the Plan year ended December 31, 2024. Contributions are subject to certain limitations.

Administration of the Plan: The Company uses T. Rowe Price Trust Company as the trustee and third-party administrator of the Plan.

Participant Accounts: Each participant’s account is credited with an allocation of (a) the participant’s contribution, (b) the Company’s contributions, and (c) the Plan’s earnings/(loss) and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Investments: All contributions, including employer matching contributions and employee discretionary contributions, are participant-directed into various investment options offered by the Plan.

Payment of Benefits: Participants may make withdrawals from their accounts upon reaching the age of 59½ or by determining that a financial hardship, as defined, has been incurred. Payments of benefits are made to participants, or their beneficiaries, upon death, retirement, disability, or termination. Benefits are payable in a lump sum or by other methods as described in the Plan.

Vesting: Participants are fully vested in their elective cash deferral contributions. Vesting of employer matching contributions and employer discretionary contributions occurs at a rate of 50% per year of service, starting with the second year of service. Participants are fully vested after three years, or upon normal or early retirement, death, or permanent disability. In the event of termination of employment before full vesting has occurred, the non-vested portion of the employer contribution shall be used to reduce the Plan's ordinary and necessary administrative expenses or shall be used to reduce the employer's contribution for the Plan year.

Administrative Expenses: The Plan's recordkeeping and custodial expenses are paid by the Plan. Audit fees and other administrative expenses are paid directly by the Company.

Notes Receivable from Participants: Notes receivables from participants are made in accordance with the Plan provisions and ERISA regulations whereby interest is calculated and charged to the individual participant. All notes are to be repaid over a maximum period of 60 months through employee payroll deductions. However, if the loan qualifies as a primary residence loan, the term may be longer than 5 years. Notes bear interest at the prime rate plus 1% of interest and are secured by the participants' account balance. Participants may borrow from accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. A participant can have no more than one outstanding note at any time.

Forfeitures: As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$326,118 and \$211,918, respectively. These amounts may be used to offset future employer matching contributions or administrative expenses of the Plan. In 2024, forfeitures used to offset employer contributions was \$326,852.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. Effective October 1, 2018, only one loan will be permitted outstanding at a time. Participants with additional loans outstanding as of October 1, 2018, will be permitted to continue payments until the loan(s) is/are paid in full.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan. This information has not been audited by independent accountants.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. All of the collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

For the portion of the Collective Trusts that relates to Stable Value Collective Trusts, the Plan may redeem units of the fund at the reported net asset value per share for the purpose of funding a bona fide benefit payment, making a participant loan, honoring a participant-directed transfer of the participant's interest in the Plan to another investment election, or paying administrative fees on a daily basis with no advance notice requirement. The Plan may make withdrawals from the fund for other purposes generally only upon 12 months' advance written notice to the fund trustee.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated August 19, 2020 indicating that the volume submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original volume submitter plan, Plan management believes that the Plan is designed and being operated in compliance with requirement of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes all years since 2021 are still subject to income tax examinations.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain plan investments at December 31, 2024 and 2023 were managed by T. Rowe Price Trust Company, the trustee and third-party administrator of the Plan, and therefore these investments qualify as party-in-interest investments. Certain professional and administrative fees related to the operation of the Plan were paid by the Company. Investment management fees of approximately \$376,005 were paid by the Plan to T. Rowe Price Trust Company for the year ended December 31, 2024, and thus qualify as a party-in-interest transaction. Notes receivable from participants also reflects party-in-interest transactions.
