Note 1 - Plan Description

The following description of RockSol Consulting Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2008, which was last amended in 2022. Effective June 6, 2022, the Plan covers all employees of RockSol Consulting Group, Inc. (the "Company") who are age 18 or older. Prior to June 6, 2022, the Plan covered all employees of the Company who were age 21 or older. The entry date for eligible participants is the first day of the month following the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company (Fidelity) serves as trustee, manages plan assets, and maintains the Plan's records.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 60 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make non-post-tax contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company is required to make matching contributions of 100 percent of the first 3 percent of eligible compensation. The Company has the right to designate all or a portion of the matching safe harbor contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½. The Company's safe harbor contributions totaled \$731,738 for the year ended December 31, 2024, all of which was qualified.

The Plan also provides for discretionary matching contributions for participants 18 years or older in an amount to be determined by the employer, as well as a nonelective discretionary secondary match. The Company elected not to make any discretionary matching contributions during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, the employer match contribution, and the employer discretionary and nonelective discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participants' highest outstanding loan balance during the prior 12-month period or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account; bear interest at rates that range from 6.3 percent to 7.0 percent, which are commensurate with local prevailing rates determined by the plan administrator at loan origination; and mature at various dates through December 2029. Principal and interest are paid ratably through monthly payroll deductions.

In the event a participant defaults on their loan the outstanding balance is deemed a distribution from the participants account. Deemed distributions in 2024 were \$32,293.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account. If a participant's vested account balance is equal to or less than \$1,000, the total vested account balance will be distributed in a lump sum within an administratively reasonable period of time after termination of employment if the participant does not elect a distribution or a rollover. The Plan also allows for terminated participant balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account.

Participants may request that all or a portion of their accounts, but not the earnings thereon, be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals. Participants are also permitted to request an in-service withdrawal of employee contributions and rollover contributions at any time.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for participant notes receivable, which are also party-in-interest transactions. The aforementioned party-in-interest transactions are exempt from the prohibited transaction rules.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Investments in money market and mutual funds are reported at the last reported sale price at the end of the respective periods using quoted market values.

The net realized and unrealized investment gain or loss (net appreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Contributions Receivable and Contributions from Employers

Contributions receivable of the Plan include amounts to be collected from the employer for hours worked prior to December 31. There were no contributions receivable at December 31, 2024 or 2023.

Contributions from the employer are recognized in the plan year in which members provide services, except where collection is doubtful, in which case they are recorded upon receipt of the contribution.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 1, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The notes receivable are secured by the balance in the participant's account; bear interest at rates that range from 6.3 percent to 7.0 percent, which are commensurate with local prevailing rates determined by the plan administrator at loan origination; and mature at various dates through December 2029. Principal and interest are paid ratably through monthly payroll deductions.

Note 1 - Plan Description (Continued)

In the event a participant defaults on their loan the outstanding balance is deemed a distribution from the participants account. Deemed distributions in 2024 were \$32,293.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account. If a participant's vested account balance is equal to or less than \$1,000, the total vested account balance will be distributed in a lump sum within an administratively reasonable period of time after termination of employment if the participant does not elect a distribution or a rollover. The Plan also allows for terminated participant balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account.

Participants may request that all or a portion of their accounts, but not the earnings thereon, be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals. Participants are also permitted to request an in-service withdrawal of employee contributions and rollover contributions at any time.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for participant notes receivable, which are also party-in-interest transactions. The aforementioned party-in-interest transactions are exempt from the prohibited transaction rules.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Investments in money market and mutual funds are reported at the last reported sale price at the end of the respective periods using quoted market values.

The net realized and unrealized investment gain or loss (net appreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Contributions Receivable and Contributions from Employers

Contributions receivable of the Plan include amounts to be collected from the employer for hours worked prior to December 31. There were no contributions receivable at December 31, 2024 or 2023.

Contributions from the employer are recognized in the plan year in which members provide services, except where collection is doubtful, in which case they are recorded upon receipt of the contribution.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 1, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 4 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
