## INDEPENDENT AUDITORS' REPORT

DECEMBER 31, 2024

**Note A - Description of the Plan**

The following description of the 403(b) Thrift Plan of VIP Services, Inc. (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of VIP Services, Inc. (the "Organization"). There is no minimum age or service requirements that must be satisfied prior to enrollment and deduction of salary reduction contributions to the Plan. Employees must satisfy an eligibility requirement of at least 1,000 hours of service to the Organization in the preceding twelve months in order to qualify for employer base contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a portion of their pretax annual compensation to the Plan, as defined in the Plan document and governed by existing law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans as long as the distributions are not from a governmental 457(b) plan.

The Organization contributes employer matching contributions at an amount equal to 50% of employee salary deferrals that does not exceed 6 percent of the annual compensation. Additional amounts may be contributed at the option of the Organization's Board of Directors. No additional amounts were contributed for the year ended December 31, 2024.

Participants' accounts

Each participant's account is credited with the participant's contribution and an allocation of the Plan earnings. Administrative fees are charged on a per account basis with variables such as account balance affecting the amount of the administrative charge. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations between these accounts are participant directed though each underlying fund has reserved the right to reject any aggregate purchase of Fund shares that it determines to be inconsistent with their Fund's policies and procedures related to market timing.

Vesting

Participants are 100% vested in the account balances of their salary deferral and rollover contributions. In the event of termination of employment, a participant is entitled to receive a percentage of the amount in their employer base contributions based on the number of years of service prior to such termination. A participant is 100% vested in Organization contributions after four years of credited service.

Payment of benefits

On termination of service, death, or disability, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account, an IRA rollover, or other qualified plan rollover. Vested balances less than \$1,000 are automatically paid in a lump-sum to the participant. The Plan also allows for hardship withdrawals due to reasons listed in the Plan document.

**Note A - Description of the Plan (Continued)**

Notes Receivable from Participants

The Plan administrator may direct the custodian of the Plan to make loans to active participants. The minimum loan amount is \$1,000 and the maximum loan amount is limited to 50% of the participant's vested account balance or \$50,000, whichever is less. Loans are secured by the balance in the participant's account and the loan interest rate is equal to the Interest Accumulation Account interest rate plus 3%. Rates are variable and reviewed for adjustment quarterly. Loan terms may not exceed 5 years unless the loan is for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions. All payments of principal and interest will be credited to the participant's account.

Forfeited Accounts

Forfeitures are the non-vested employer contributed amounts in the accounts of participants who terminate employment. Forfeitures will be used to reduce the Organization's future contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,702 and \$5,545, respectively. During the year ended December 31, 2024, \$1,075 of forfeitures were applied to participant accounts as part of employer contributions.

**Note B - Summary of Significant Accounting Policies**

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully-benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the reinvestment date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held throughout the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Certain administrative expenses of the Plan are paid by the Plan and totaled \$739 for the year ended December 31, 2024. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events as of September 30, 2025, the date the financial statements were available to be issued.

**Note C - Information Prepared and Certified by the Plan's Insurance Company**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company (the "insurance company" of the Plan). The contract value of the guaranteed investment contract was certified by the insurance company.

**Note D - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Pooled separate accounts (PSA) are similar to mutual funds except they are issued by insurance companies and are not publicly traded like mutual funds. Each plan's share of a PSA is determined on a participation-unit or variable-unit basis. The plan's equity account provides a cumulative record of the number of participation units credited to the account and the number of units allocated or withdrawn from the account. The balance of participation units credited to the account, multiplied by the current participation-unit value equals the amount of equity account assets held on behalf of the policy holder at any given time. The participation-unit value is adjusted periodically, usually each business day, to reflect investment results under the PSA.

(a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are not intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statement of Net Assets Available for Benefits.

This category includes pooled separate accounts that are designed to provide growth in capital by replicating benchmark indices and includes primarily equity and debt investments. The life cycle funds that are within this category are invested in highly diversified funds designed to remain appropriate for investors in terms of risk throughout a variety of life circumstances. There are currently no redemption restrictions or unfunded commitments on these investments. The fair values of the investments in this class have been estimated based upon the NAV per share.

**Note E - Mutual of America General Account**

The Plan has balances in the Mutual of America Interest Accumulation Account. The concept of benefit responsiveness does not apply to the General Account. This concept generally applies to guaranteed investment contracts (GICs), whereby the employer enters into the contract with a set amount of money, and the interest rate is guaranteed for a set period of time. The employer agrees not to withdraw the funds early; however, if funds are needed to pay retirement claims, they can be withdrawn from the GIC without penalty (i.e., they are "benefit responsive"). The funds in a defined contribution plan are allocated to individual plan participants; therefore, the funds are always available to pay benefits, subject to the plan's vesting schedule. Since the employer does not control participant assets, the need for the plan to be benefit responsive is not relevant.

The General Account includes the outstanding balances of participant loans as the loans are collateralized by funds held in the General Account. Participant loans are segregated from other amounts in the General Account in the Statement of Net Assets Available for Benefits as a transparency measure in these financial statements.

The methodology used to calculate the interest crediting rate is completely discretionary to Mutual of America. Mutual of America does ensure that the interest rate will never fall below the guaranteed minimum rate of 1.00%. The average yield with adjustment to reflect rate credited to participants for the General Account was 2.85% for the year ended December 31, 2024.

**Note F - Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer accounts.

**Note G - Tax Status**

The Plan has not requested a determination letter from the Internal Revenue Service, nor is a determination letter required for 403(b) plans. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management is not aware of any uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note I - Party-in-Interest Transactions**

The Plan sponsor, participants, and the insurance company have all been identified as parties-in-interest. The Plan invests in pooled separate accounts and interest accumulation accounts with the insurance company. Transactions in these investments qualify as parties-in-interest transactions. Participant loans also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Certain administrative expenses of the plan are paid for by the Plan sponsor and qualify as party-in-interest transactions. Expenses paid to the insurance company totaled \$739 for the year ended December 31, 2024.
