### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

### **1. Description of the Plan**

The following description of Birmingham Hematology and Oncology Associates, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of Birmingham Hematology and Oncology Associates, LLC and its affiliates (collectively, the Company) upon completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Eligible employees may elect to contribute up to 100 percent of their eligible annual compensation (as defined in the Plan document) as pretax and/or Roth deferrals, not to exceed federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for automatic enrollment of participants hired or rehired on or after January 1, 2017, equal to three percent of pretax annual compensation. The Plan also provides for automatic escalation of one percent each year, up to a maximum of six percent. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In 2024, the Company contributed the equivalent of three percent of each participant's eligible annual compensation to the Plan as a safe harbor non-elective contribution. An additional discretionary profit-sharing contribution (to the extent net profit permits) was also made to eligible participants who were employed as of the last day of the year. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's safe harbor non-elective contribution, Plan earnings or losses from that account's investment activities, and an allocation of the Company's discretionary profit-sharing contribution. Allocations are based on participant earnings, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements (continued)

### **1. Description of the Plan (continued)**

#### **Benefit Payments**

On termination of service due to separation, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals/installments or annuity payments not to exceed the life expectancy of the participant. In-service withdrawals, including hardship withdrawals, may be available as defined in the Plan document. The Plan was amended to allow in-Plan Roth conversions.

#### **Vesting**

Participants are immediately vested in their deferral contributions and Company safe harbor non-elective contributions, plus actual earnings thereon. Vesting in the Company discretionary profit-sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

#### **Forfeitures**

Forfeitures of terminated, nonvested participant accounts are used to reduce future Company contributions.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company discretionary profit-sharing contributions.

#### **Administrative Expenses**

Certain administrative expenses of the Plan, including trustee and a portion of accounting fees, have been paid by the Company. Participant initiated distribution fees, including self-directed brokerage account expenses, are charged directly to the participant's account. All other administrative expenses and investment transaction fees (including investment-related expenses which are included in net appreciation in fair value of investments) are paid by the Plan.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Presentation**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the investment adviser, brokers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and any investment-related expenses.

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **3. Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the trustee.

#### 3. Investment Information (continued)

The following information was not certified as complete and accurate and was subjected to auditing procedures:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$8,070,089 and \$7,265,769 as of December 31, 2024 and 2023, respectively.
- b. Net investment gain as shown in the accompanying statement of changes in net assets available for benefits of \$595,990 for the year ended December 31, 2024.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed brokerage accounts: accounts consist primarily of mutual funds, exchange traded funds and common stock that are valued on the basis of readily determinable market prices as well as cash equivalents that are stated at cost, which approximates fair value.

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust: primarily invested in guaranteed investment contracts and synthetic investment contracts and is designed to deliver safety and stability by preserving principal and accumulating earnings. The fair value of this fund has been estimated based on the fair value of the underlying investment contracts in the fund as reported by the issuer of the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated April 24, 2015, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

**6. Subsequent Events**

Management of the Company evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
