## Independent Auditor's Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of LivaNova US Employee Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

### ***Opinion***

#### **Note 1 – Plan Description**

The following description of the LivaNova US Employee Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution employee benefit plan that provides retirement savings benefits to eligible employees of LivaNova USA, Inc. (the “Company” or “Employer”) and the following participating employers: ALung Technologies, Inc.; Caisson Interventional LLC; CardiacAssist, Inc. dba TandemLife; ImThera Medical, Inc.; and LivaNova, Inc. The Plan commenced effective January 1, 2017, and was amended and restated effective December 1, 2021, to comply with the latest rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

##### ***Plan Custodian and Trustee***

Fidelity Management Trust Company (“Fidelity,” the “Trustee,” or “Custodian”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, Fidelity Management Trust Company receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

##### ***Eligibility and Plan Entrance Date***

Certain employees are not eligible to participate in the Plan, including those under collective bargaining agreements, nonresident aliens who receive no United States source income, and leased employees. All other employees become eligible to participate in and may enter the Plan on the first day of the month following their date of hire.

##### ***Participant Contributions***

Participants may elect to contribute, on a before-tax or Roth basis, up to 75% of their annual compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

##### ***Employer Contributions***

The Plan provides for Safe Harbor Employer matching contributions equal to 100% of the first 3% of the participant’s eligible compensation contributed to the Plan, and 50% of the next 2% of the participant’s eligible compensation. The Plan uses a year end true-up matching contribution feature to allow participants to receive the maximum matching contribution available by making up for any loss in matching contributions resulting from the participant’s individual savings strategies.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Safe Harbor Employer matching contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in their contributions, Safe Harbor Employer matching contributions, rollover contributions, and any earnings thereon.

For participants who merged into the Plan from the Cyberonics, Inc. Employee Retirement Savings Plan, the portion of their account attributable to employer matching contributions and profit-sharing contributions made prior to January 1, 2017, as well as any earnings on all such contributions, vests at a rate of 20% per year, reaching full vesting after 5 years of credited service.

#### ***Participant-Directed Investments***

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may designate the allocation of their account balances to one or more of these options. The options vary in types of investments, rates of return, and investment risk.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above Prime, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

#### ***Payment of Benefits***

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant receives a lump sum distribution of the vested portion of their account balance. In the case of death, distributions are made to the participant's beneficiary. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. In the event of a financial hardship, as defined by the Plan, a participant may withdraw all or a portion of their vested account balance. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

#### ***Forfeited Accounts***

Forfeited nonvested accounts totaled \$34,234 and \$107,909 as of December 31, 2024 and 2023, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative fees. During the year ended December 31, 2024, forfeitures of \$85,024 were used to reduce Employer contributions.

### Note 2 – Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

#### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### ***Notes Receivable from Participants***

Note receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

#### ***Payments of Benefits***

Benefit payments to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses incurred by, or attributable to, a specific participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. Funds held by the Plan are deemed to be actively traded.

**Money Market Funds** – Valued at cost, which approximates fair value and are classified within level 1 of the valuation hierarchy.

**Self-Directed Brokerage Accounts** – These accounts are managed by the individual participants and offer the option of investing in funds both within and outside the Plan investment options. Accounts primarily consist of mutual funds, money market funds, common stocks, and United States government securities that are valued based on readily determinable market prices. All expenses and income associated with participant elections and activity are recorded at the individual participant level.

**Stable Value Common Trust Fund** – A fully benefit-responsive investment contract that is valued at the NAV of units of the collective trust. NAV is used as a practical expedient to estimate fair value; however, the practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly manner.

#### **Note 5 – Related Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity, which is the Plan's Custodian, Trustee, recordkeeper, and provides securities brokerage services for the self-directed brokerage account for the Plan. Such transactions qualify as party-in-interest transactions as defined by ERISA; however, these transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each participant's account are net of investment management fees charged by each investment fund under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### **Note 7 – Tax Status**

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by FMR, LLC. The Internal Revenue Service ("IRS") has determined and informed FMR, LLC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

## Independent Auditor's Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of LivaNova US Employee Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### **Note 1 – Plan Description**

The following description of the LivaNova US Employee Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution employee benefit plan that provides retirement savings benefits to eligible employees of LivaNova USA, Inc. (the “Company” or “Employer”) and the following participating employers: ALung Technologies, Inc.; Caisson Interventional LLC; CardiacAssist, Inc. dba TandemLife; ImThera Medical, Inc.; and LivaNova, Inc. The Plan commenced effective January 1, 2017, and was amended and restated effective December 1, 2021, to comply with the latest rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

##### ***Plan Custodian and Trustee***

Fidelity Management Trust Company (“Fidelity,” the “Trustee,” or “Custodian”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, Fidelity Management Trust Company receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

##### ***Eligibility and Plan Entrance Date***

Certain employees are not eligible to participate in the Plan, including those under collective bargaining agreements, nonresident aliens who receive no United States source income, and leased employees. All other employees become eligible to participate in and may enter the Plan on the first day of the month following their date of hire.

##### ***Participant Contributions***

Participants may elect to contribute, on a before-tax or Roth basis, up to 75% of their annual compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

##### ***Employer Contributions***

The Plan provides for Safe Harbor Employer matching contributions equal to 100% of the first 3% of the participant’s eligible compensation contributed to the Plan, and 50% of the next 2% of the participant’s eligible compensation. The Plan uses a year end true-up matching contribution feature to allow participants to receive the maximum matching contribution available by making up for any loss in matching contributions resulting from the participant’s individual savings strategies.

### Note 1 – Plan Description (continued)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Safe Harbor Employer matching contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in their contributions, Safe Harbor Employer matching contributions, rollover contributions, and any earnings thereon.

For participants who merged into the Plan from the Cyberonics, Inc. Employee Retirement Savings Plan, the portion of their account attributable to employer matching contributions and profit-sharing contributions made prior to January 1, 2017, as well as any earnings on all such contributions, vests at a rate of 20% per year, reaching full vesting after 5 years of credited service.

#### ***Participant-Directed Investments***

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may designate the allocation of their account balances to one or more of these options. The options vary in types of investments, rates of return, and investment risk.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above Prime, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

#### ***Payment of Benefits***

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant receives a lump sum distribution of the vested portion of their account balance. In the case of death, distributions are made to the participant's beneficiary. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. In the event of a financial hardship, as defined by the Plan, a participant may withdraw all or a portion of their vested account balance. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

#### ***Forfeited Accounts***

Forfeited nonvested accounts totaled \$34,234 and \$107,909 as of December 31, 2024 and 2023, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative fees. During the year ended December 31, 2024, forfeitures of \$85,024 were used to reduce Employer contributions.

#### **Note 2 – Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

##### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### ***Notes Receivable from Participants***

Note receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### ***Payments of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Administrative Expenses***

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses incurred by, or attributable to, a specific participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

#### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

**Money Market Funds** – Valued at cost, which approximates fair value and are classified within level 1 of the valuation hierarchy.

**Self-Directed Brokerage Accounts** – These accounts are managed by the individual participants and offer the option of investing in funds both within and outside the Plan investment options. Accounts primarily consist of mutual funds, money market funds, common stocks, and United States government securities that are valued based on readily determinable market prices. All expenses and income associated with participant elections and activity are recorded at the individual participant level.

**Stable Value Common Trust Fund** – A fully benefit-responsive investment contract that is valued at the NAV of units of the collective trust. NAV is used as a practical expedient to estimate fair value; however, the practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly manner.

#### **Note 5 – Related Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity, which is the Plan's Custodian, Trustee, recordkeeper, and provides securities brokerage services for the self-directed brokerage account for the Plan. Such transactions qualify as party-in-interest transactions as defined by ERISA; however, these transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each participant's account are net of investment management fees charged by each investment fund under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### **Note 7 – Tax Status**

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by FMR, LLC. The Internal Revenue Service ("IRS") has determined and informed FMR, LLC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
