Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hendricks Community Hospital Association 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: Description of Plan

The following description of the Hendricks Community Hospital Association 403(b) Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Hendricks Community Hospital Association (the Company). Employees of the Company who are age 18 or older are eligible to participate in the salary deferral portion of the plan and receive employer matching immediately coinciding with or following their date of hire. The Plan excludes employees that normally work less than 20 hours per week, PRNs, part-time no benefits employees, and personal care assistants from employer contributions.

Contributions

Each year, participants may elect to contribute a percentage of eligible compensation, as defined by the Plan and subject to various regulatory limitations. These contributions may be made on either a pre-tax or after-tax basis (through Roth contributions). The Plan allows participants aged 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, also known as rollover contributions. Participants direct the investment of all contributions through various investment options offered by the Plan.

The Company makes a matching contribution of 100% of the participant's elective deferrals, not to exceed 4% of eligible compensation. The Company may also make discretionary non-elective contributions. There were no discretionary non-elective contributions for the year ended December 31, 2024.

All contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions, investment earnings, changes in market values, and certain plan expenses. Allocations are based on account balances or compensation as defined by the Plan. Investment earnings and changes in market values are allocated daily based on the number of units in the participant's account. Plan expenses are allocated either directly to a participant's account for certain transactions affecting only the participant or proportionally to all participants for certain administrative expenses charged to the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Eligible participants may direct the investment of 100% of their employee and employer contributions, choosing from several available investment options. A participant may change their investment direction with respect to future contributions or redirect the investment of their account balances at any time.

Retirement

A participant's normal retirement date is at age 59.5. A participant who retires will be entitled to the full value of their account, calculated as of the trust valuation date coinciding with or following the retirement date.

Vesting and Forfeitures

Participants are immediately vested in their salary deferrals, including pretax and Roth contributions, catch-up contributions, and rollover contributions, plus earnings thereon. Vesting in matching contributions, plus actual earnings, is based on years of continuous service, as defined by the Plan, and according to the following schedule:

Forfeited non-vested amounts are used to reduce matching or nonelective contributions into the Plan or to pay reasonable Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,998 and \$2,944, respectively. During the year ended December 31, 2024, there were no forfeitures of non-vested accounts used to offset matching contributions.

Benefit Payments

Upon termination of employment, death, disability, or normal retirement, the participant will receive the value of the vested interest in their account in the form of a lump sum distribution or installments if the participant is subject to lifetime required minimum distributions. The Plan also permits in-service and hardship distributions, provided certain conditions are met. If the participant terminates employment and the participant's vested account balance does not exceed \$5,000, the plan administrator will authorize the benefit payment without the participant's consent. For forced payouts of account balances that exceed \$1.00, the Plan will automatically roll the balance into a qualified individual retirement account if no other election is made.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Loan terms are determined by the Plan administrator and may not exceed 5 years, unless for the purchase of the participant's principal residence. Loans are secured by the balance in the participant's account. The loans bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant notes receivable to be in default, the participant note receivable balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees related to the administration of the Plan are charged directly to the participants' accounts and are included in administrative expenses.

Subsequent Events

Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

On February 1, 2025, the Plan documents were restated in their entirety to comply with the latest laws and regulations. There were no significant changes to the Plan's provisions as a result of the restatement.

Note 3: Fair Value Measurements

The established framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets

- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Tax Status

The Plan obtained its latest opinion letter dated November 28, 2022, which states the IRS has determined that the volume submitter plan adopted by the Company is qualified and the trust established under the Plan is tax exempt under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken a significant uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and accordingly, account balances of participants in the Plan.

Note 6: Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TD Ameritrade Trust as of December 31, 2023 and Charles Schwab Trust Bank as of December 31, 2024 and for the year ended December 31, 2024 (the Trustees of the Plan).

Note 7: Concentrations

Two investment balances accounted for 33 and 29 percent of total investments as of December 31, 2024 and 2023, respectively.

Note 8: Related Party and Party-in-Interest Transactions

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$39,976 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Note 9: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would automatically become 100% vested in their account balances.

Note 10: SECURE Act 2.0

In December 2022, securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

The following mandatory provision set forth by Secure 2.0 was effective and implemented by the Plan as of January 1, 2024:

- Section 602 under Secure 2.0 allows hardship withdrawals of earnings attributable to employee elective deferrals as well as distributions from non-elective and matching contribution sources.

Formal amendments reflecting these provisions have not been executed as of the date the financial statements were available to be issued. However, the Plan sponsor intends to make all necessary amendments by the applicable deadline of December 31, 2026, in accordance with IRS Notice 2024-2.
