To the Trustees and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Devens Treatment & Recovery Center, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Devens Treatment & Recovery Center, LLC 401(k) Plan (“the Plan”) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan for the benefit of the employees of the Devens Treatment & Recovery Center, LLC D/B/A Tara Vista Behavioral Health Center and Mira Vista Behavioral Health Center (the “Company” or the “Employer”) and their beneficiaries, enabling participants to save and invest in accordance with the terms of the Plan. The Plan was established under provisions of Sections 401(a) and 401(k) of the Internal Revenue Code (the “IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants of the Plan can elect to participate in a tax-deferred savings program offered under the Plan whereby contributions are made through salary deductions.

Plan administration – The Company is the Plan Administrator and has the authority to appoint persons or entities to carry out the operation of the Plan. Officers of the Company serve as the Plan’s Trustees. The Plan’s Trustees are responsible for overseeing the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. Plan expenses not covered by forfeitures are paid by the Company.

Eligibility – Employees are eligible to join the Plan on the first day of the following month after attaining the age of 21 and completion of 90 days of service.

Contributions – Participants may defer up to 100% of their gross compensation each year, as defined by the Plan, subject to IRS limitations. Participants who will attain age 50 by year-end may also make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan.

Matching contributions are discretionary and are based on eligible compensation contributed to the Plan each Plan year. Matching contributions are 50% of the first 3% of employee deferrals. An employee becomes eligible for matching contributions when they begin contributing to the Plan. The Company made employer matching contributions of \$218,114 in 2024 and \$436,028 in 2023.

Participants’ accounts – A separate account is established for each participant at the time of enrollment in the Plan. Each participant’s account is credited with the participant’s contribution, related discretionary employer matching contribution, and the Plan’s investment earnings and charged with participant loan fees and distribution fees (if applicable). The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Withdrawals and distributions – Lump sum payments are permitted. Hardship withdrawals are not permitted. In addition, in-service withdrawals from the participant’s total vested account balance are permitted upon the later of reaching age 65 or 5 years after participation in the Plan. Participants are entitled to a lump-sum amount equal to their total vested account balance upon death, disability, retirement or termination of employment.

1. DESCRIPTION OF PLAN (CONTINUED)

Vesting – Participants are vested in the Company's matching contributions and related earnings based upon years of continuous service. A year of service is determined by 1,000 hours of service in a Plan year. Prior to July 1, 2022, a participant began vesting after one year of service and was 100% vested after five years of service. Each full year of service the participant earns 20% towards their vested balance. On July 1, 2022, the Plan's vesting schedule was amended, and a participant does not begin vesting until after three years of service. After three years of service the participant is 100% vested in the Company's matching contributions and related earnings. A participant's vested percentage shall not be less than the percentage applicable to them as of July 1, 2023 under the one to five year schedule previously in effect.

Forfeitures – A participant who leaves the employment of the Company forfeits any non-vested balance. Forfeitures may be used in any permissible method such as to restore balances, reduce Company contributions, or to pay plan expenses. At December 31, 2024 and 2023 unused forfeited balances amounted to \$43,709 and \$178,894, respectively. In 2024, \$243,337 in forfeitures were used to reduce employer contributions. In 2023 no forfeitures were used to reduce employer contributions.

Notes receivable from participants – Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years (longer for the purchase of a primary residence). Loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates for similar types of loans. The maximum number of loans outstanding at any time is one. Principal and interest are paid ratably through payroll deductions.

Termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates – The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment valuation and income recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon terms of the plan document.

Payments of benefits – Distributions to participants are recorded when paid.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (qualified institution).

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in insurance contracts and pooled separate accounts managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is also the qualified institution and recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest.

5. TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the preapproved defined contribution plan document adopted by the Plan on January 1, 2021, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be not sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. FIXED ACCOUNT

The Plan holds a guaranteed investment contract in the Voya Fixed Account that meets the criteria of a fully benefit-responsive investment contract and is therefore reported at contract value. Contract value represents contributions made under the contract plus earnings, less participant withdrawals, and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate investment accounts ("PSA") – valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the net asset value (NAV) of the PSA which is not publicly quoted. These securities are classified as Level 2. The redemption frequency of each of these PSA's is daily, and there are no redemption restrictions.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024, the Company deposited withholdings of \$1,674 related to 2023 after the time frame deemed to be within Department of Labor (DOL) regulations for timely remittances. During 2024, the Company made contributions to the affected participant accounts to compensate those participants for lost earnings due to delays.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.


