## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
BEGA North America, Inc. Salary Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of BEGA North America, Inc. Salary Savings Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### NOTE 1. PLAN DESCRIPTION

The following description of the BEGA North America, Inc. Salary Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan covering all non-leased United States resident employees of BEGA-North America, Inc. (the “Company”) who are over the age of 18 and have completed two months of service with the exception of union employees whose benefits are provided by the union. The Plan was amended on January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration of the Plan:** Empower Retirement LLC, the recordkeeper of the Plan, is responsible for executing most of the day-to-day administrative activities of the Plan. Empower Annuity Insurance Company is the trustee of the Plan.

**Contributions:** Each year, participants may contribute up to 100% of pre-tax annual compensation as defined in the Plan, subject to the annual limitation imposed by the Internal Revenue Code (IRC), which was \$23,000 for 2024. Participants who have obtained age 50 before the end of the plan year are eligible to make up to an additional \$7,500 in catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The plan allows for both pre-tax and after tax (Roth) contributions.

Participants direct contributions into any registered investment companies, common/collective trust funds and the guaranteed income fund offered under the agreement with the trustee. Participants may change their investment options daily. Participants may change their deferral percentage at the beginning of each payroll period.

The Company makes safe harbor contributions to the Plan. In addition, the Company can make discretionary and/or matching contributions to the Plan. The Company's matching policy is determined annually, prior to the beginning of each plan year. For 2024, Company safe harbor contributions were equal to 3% of participant's eligible compensation up to a maximum contribution of \$9,900. The Company made safe harbor contributions of \$445,732. For 2024, Company matching contributions were equal to 100% of the first 3% of participating employee's contributions. The Company made matching contributions of \$428,192 for 2024. The Company made discretionary contributions of \$49,435 for 2024.

**Vesting:** Participants are immediately vested in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary and matching contributions plus actual earnings thereon is based on years of service in accordance with the following schedule:

Years of Service	Vested Percentage
2 years	25%
3 years	50%
4 years	75%
5 years	100%

**Participant Accounts:** A separate account is maintained for each participant. Each participant's account is credited with the participant's contribution and the Company's contribution and is charged with certain investment and administrative expenses. Contributions are allocated in accordance with participant allocation elections.

Net appreciation or depreciation from investments in registered investment companies and common/collective trust funds are credited or charged to participant accounts based upon the increase or decrease in the market value per unit of investments held. Dividend and interest income are credited to participant accounts based on investment units held. The benefits to which a participant is entitled are the benefits that can be provided from a participant's vested account.

**Notes Receivable from Participants:** Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from one to five years or up to 20 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at the prevailing prime rate plus 1.75%. Interest rate for all loans range between 5% and 10.25%, and loan maturities extend through 2041. Principal and interest are paid ratably through weekly payroll deductions.

**Payment of Benefits:** On termination of service due to death, disability or retirement, a participant is entitled to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount payment. At December 31, 2024, all participants who elected to withdraw from the Plan and who requested a distribution of their account balance had received a distribution from the Plan.

**Forfeitures:** Forfeitures are used to reduce plan administrative expenses, and during the year ended December 31, 2024 the Company did not use forfeitures for administrative expenses of the Plan. Total forfeitures for the year ended December 31, 2024 were \$90,722. Unallocated forfeitures as of December 31, 2024 and 2023 were \$100,270 and \$8,397, respectively.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates:** The preparation of financial statements in conformity with U.S. GAAP requires the Plan's administrators to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosures. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan's investments in registered investment companies traded on a national securities exchange are stated at fair value on the basis of the closing quoted price on the last trading day of the year. The Plan's investments in common/collective trusts are stated at the net asset value based on the fair value of the assets held in the trust on the last trading day of the year. Purchases and sales of securities are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Income from other investments is recorded as earned on an accrual basis. The net appreciation or depreciation in the fair value of investments is reflected in the statement of changes in net assets available for plan benefits.

The Plan holds investments in a guaranteed income fund (the "Fund"). Generally accepted accounting principles of the United States of America require such investments to be valued at contract value if the contracts are determined to be fully benefit-responsive. The Fund is a traditional guaranteed investment contract and deemed to be fully benefit-responsive. Since the Fund is fully benefit-responsive, contract value is the relevant measurement. Contract value, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees. If a participant elects to transfer or withdraw funds from the Fund the maximum value they will receive is contract value even if fair value exceeds contract value. As of December 31, 2024 the fair value of the Fund approximated contract value. Generally, there are no events that could limit the ability of the Plan to transact at contract value paid with 90 days' notice or contract value paid over time. There are no events that allow the Fund's issuer settle at an amount different than contract value paid either with 90 days' notice or over time.

**Fair Value Measurements:** The Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements and Disclosures (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1 –** Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

**Level 2 –** Quoted prices in markets that are not considered to be active or financial instruments or which all significant inputs are observable, either directly or indirectly;

#### **Fair Value Measurements (continued):**

**Level 3 –** Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

**Investment Risk:** The Plan offers participants various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments. The Plan's provisions as well as those of ERISA and the participants' investment preference dictate the Plan's concentration of credit risk and market risk.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on an accrual basis. Delinquent participant loans are recorded as distributions to participants.

**Payment of Benefits:** Benefit payments are recorded as expenses when paid.

**Subsequent Events:** Management has evaluated subsequent events through September 30, 2025, the date that the financial statements were available to be issued.

### NOTE 4. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Trustee of the Plan certified certain information and the certified information was not audited in accordance with the plan administrator's instructions and as permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Trustee certified investments held as of December 31, 2024 and 2023 totaling \$26,875,888 and \$25,924,078, respectively, and net investment income for the year ended December 31, 2024 totaling \$3,584,009. In addition, the Trustee certified notes receivable from participants as of December 31, 2024 and 2023 totaling \$372,111 and \$451,242, respectively, and related interest income on notes receivable from participants for the year ended December 31, 2024 totaling \$29,136.

### NOTE 5. PLAN TERMINATION

Although the intention of the Company is to continue the Plan indefinitely, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

### NOTE 6. INCOME TAX STATUS

The Plan obtained a determination letter on March 31, 2014, from the Internal Revenue Services, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Uncertain Tax Positions:** U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

### **NOTE 7. PARTY-IN-INTEREST TRANSACTIONS**

As defined by the Plan, Empower Annuity Insurance Company of America serves as the trustee, and Empower Retirement LLC functions as the recordkeeper. Consequently, these transactions qualify as party-in-interest transactions. Certain plan administrative functions are performed by employees of the Company at no charge to the Plan. In addition, plan administrative expenses paid by the Company for the 2024 plan year were approximately \$52,300.

### **NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
