Opinion

We have audited the financial statements of Chiesa Shahinian & Giantomasi PC Cash Balance Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits and accumulated plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in accumulated plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our opinion is not modified with respect to this matter.

Note 1. Description of the Plan

The following description of the Chiesa Shahinian & Giantomasi PC Cash Balance Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2003 and was amended and restated effective January 1, 2020. The Plan was a noncontributory defined benefit plan covering certain members of the firm and staff employees of Chiesa Shahinian & Giantomasi PC (Company or Employer) who complete one year of service, as defined in the plan document, and are age 21 or older, unless specifically excluded as defined in the plan document. Eligible employees were able to enter the Plan on January 1st or July 1st coinciding with or next following the date on which they meet the eligibility requirements. The assets of the Plan were managed by JP Morgan until the assets were transferred to US Bank on February 14, 2024. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA").

Effective May 15, 2023, the Plan was amended to freeze the accrual of benefits. Effective December 31, 2023, the Plan was amended to unfreeze the accrual of benefits retroactive for the plan year beginning on January 1, 2023.

Effective March 20, 2024, the Plan entered into a buy-out agreement with an insurance company (Insurer), to annuitize certain benefits in pay status of \$300 per month or less. In accordance with the agreement, the Insurer assumed responsibility for the annuitized benefits effective May 1, 2024, and the annuitized individuals are no longer a participant under the Plan, with rights under the Plan, and the Plan has no further obligation to make any payment with respect to any benefit of the participant, including any survivor, beneficiary, or other person claiming any right or benefits by or through annuitized individual on or after the date the Insurer becomes responsible for the payment of benefits. The final sale took place in March 2024 for \$81,204.

Plan Termination

The Company approved to terminate the Plan effective December 31, 2023. The net assets of the Plan were distributed to participants based on priorities established in the Plan and by ERISA through a lump sum settlement payment or continued normal distributions after the purchase of annuity contract. All benefits owed to participants were distributed during 2024.

Participant Accounts

Under the provisions of the Plan, hypothetical participant accounts were maintained by the Company. Interest credits and principal credits were allocated to these accounts at the end of each plan year. The principal credits were allocated as a percentage of the participant's compensation and designated group for the year, as defined in the plan document. The principal credit for all eligible non-highly compensated employees who worked at least 1,000 hours during the plan year was equal to 2.85% of their compensation. The allocation for eligible members of the firm ranged from 6.05% of compensation to 72.60% of compensation, as defined in the plan document. The Company contributed to the Plan based on the actuarial present value of accumulated plan benefits and other minimum funding requirements.

Participant's hypothetical accounts also received interest credits as defined in the plan document at the end of each plan year calculated as a percentage of the participant's balance at the beginning of the plan year. The interest credit was 5% for the year ended December 31, 2023. There was no interest credit applied during 2024.

Benefits Payments

The Plan provided for lump sum distributions of the present value of the participant's vested accrued benefit, as defined in the plan document. In addition, single life and joint survivor annuities were available, as defined in the plan document. If a participant died before his or her benefit commencement date, a death benefit equal to his or her accrued benefit was paid to the participant's beneficiary.

The normal retirement age as defined in the plan document was the first day of the calendar month coincident or next following the normal retirement age of 65.

A participant was always 100% vested in his or her account.

Administrative Expenses

Substantially all the expenses incurred in the administration of the Plan were paid by the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Company approved to terminate the Plan effective December 31, 2023. As a result, the accompanying financial statements of the Plan are prepared under the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Interest and Dividend Income

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Funding Policy

The Company made funding contributions to the Plan in such amounts and at such times as determined by the Plan actuary to meet ERISA minimum funding requirements. The Company did not make a contribution for the year ended December 31, 2024.

Payment of Benefits

Benefits were recorded when paid.

Note 3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments that are attributable under the Plan's provisions for the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are accumulated based on employees' compensation during each year of credited service. The accumulated Plan benefits for active employees equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date (the valuation

date). Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included, to the extent they are deemed attributable to employee service rendered at the valuation date.

The actuarial present value of accumulated plan benefits is determined by an independent actuary, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The computation of the actuarial present value of accumulated plan benefits was made as of January 1, 2023.

The significant assumptions used in the final actuarial valuation were as follows:

The foregoing actuarial assumptions were based on the presumption that the Plan will continue since the Plan was not yet amended to terminate as of December 31, 2022.

Due to the termination of the Plan effective December 31, 2023 and subsequent liquidation in 2024, there were no significant assumptions used in the actuarial valuation as of December 31, 2024 and 2023.

Note 4. Tax Status

On October 16, 2017, the Internal Revenue Service (IRS) stated that the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however the Plan's management believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress. The Plan's management believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5. Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least

reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

Note 6. Related Party Transactions

The Plan engaged in transactions with parties-in-interest, including investment advisors, third-party administrators, and auditors. For the year ended December 31, 2024, the Plan incurred fees of approximately \$36,000 for investment advisory services, \$14,000 for third-party administration services, and \$15,000 for audit services.

Note 7. Plan Termination

The Company has made the decision to terminate the Plan. As part of the termination, the Company has discontinued its contributions and terminated the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, the net assets of the Plan will be distributed to the employees based on priorities established by the Plan and by ERISA. The Pension Benefit Guaranty Corporation (PBGC) guarantees the payment of certain nonforfeitable basic benefits, subject to certain limitations prescribed by ERISA. However, there is a ceiling on the amount of an individual's monthly benefit that the PBGC guarantees, which is adjusted periodically.

Note 8. Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
