Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Moxie HCH Motors, LLC - Moxie HCH Motors 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Moxie HCH Motors, LLC - Moxie HCH Motors 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. A. Description of Plan

The following description of the Moxie HCH Motors, LLC (Company) Moxie HCH Motors 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions:

General. The plan is a defined contribution plan covering all full-time employees of the company and its related employers (see below), who have one year of service and are age twenty-one or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Manager determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The Plan was previously the Harbor Chevrolet Corp. 401(k) Plan, established on August 1, 1966, effective November 15, 2021, the Company purchased Harbor Chevrolet Corp and took over administration of the Plan.

Contributions. Each year, participants may contribute up to the maximum as set by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the plan. The Plan currently offers various pooled separate accounts and insurance guaranteed fund as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. Contributions are automatically invested in a target retirement account based on age of participant until changed by the participant. The Company contributes 50 percent of the first 4 percent of base compensation that a participant contributes to the plan. The matching Company contribution is invested the same as the participants directed accounts. Additional nonelective amounts may be contributed at the option of the company's board of directors and are invested in a portfolio of investments as directed by the company. Contributions are subject to certain statutory limitations.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company matching contributions and, (b) Plan earnings (losses), and charged with a participant fee, if elected to subscribe to investment advisory service. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

Notes Receivable from Participants. Participants may not borrow from their accounts.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant with account balance between \$1,000 and \$5,000 will be subject to a lump-sum distribution of vested benefits, including rollovers as a mandatory automatic rollover to an IRA, unless other election made by participant; balances below \$1,000 are not subject to automatic rollover. Participants not subject to mandatory distributions may elect to receive either a lump-sum amount equal to the value of the participants interest in his or her account, or installments equal to or exceeding the annual require minimum distribution amount.

Forfeited Accounts. The forfeited nonvested accounts total \$31,242 at December 31, 2024, and zero at December 31, 2023. These accounts were to be used as per the Plan document as additional nonelective or match contribution, reduce nonelective or match contribution, or pay plan expenses. For 2024 forfeitures of \$4,970 were used to reduce the matching contribution for the current plan year and \$1,794 were used to pay plan expenses. For 2023 forfeitures of \$8,921 were used to reduce the matching contribution for the plan year and \$1,052 were used to pay plan expenses.

Related Employers. The Company has other business entities that are related that allow employment with to be considered as credited service to the Plan.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting. The Form 5500 has been reported on the cash basis of accounting (see note J for reconciliation).

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a define contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis: Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amount allowed by the IRS as a result of the ADP corrections made subsequent to year end are recorded as a liability with a corresponding reduction to contribution. There were no excess contributions of at the end of the current year. Also, the company match computation was recomputed after the end of the plan year, which resulted in an amount that was in excess of the allowed per the plan in the amount of \$0 and \$0, as of December 31, 2024 and 2023, respectively, and additional employer matching contributions due to participants of \$3,143 and \$5,375, as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Benefits are normally recorded when paid, accrual made for participants terminated with vested balance below \$5,000.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

C. Certified Investments

Certain information related to investments, held at December 31, 2024 disclosed in the accompanying financial statement and supplemental schedule, including investments and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Sentry Life Insurance Company for the years ended December 31, 2024 and 2023 (the Custodian of the Plan).

Sentry Life Insurance Company currently offers 38 funds to choose from. The values at December 31, 2024 utilized the same basis for tax and financial reports. The values of the investments, which were certified by Sentry Life Insurance Company, are as follows:

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs are unadjusted quoted prices in active markets for identical assets or liabilities in active markets at the measurement date.

Level 2 – Inputs to the valuation methodology include:

1. Quoted prices for similar assets or liabilities in active markets;
2. Quoted prices for identical or similar assets or liabilities in markets that are not active;
3. Observable inputs other than quoted prices for the asset or liability; and
4. Market-corroborated inputs.

Level 3 – Inputs that are unobservable inputs for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any related market activity.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024.

Group Annuity Contract: The Plan's assets are invested in a Group Annuity Contract with Sentry Life Insurance Company that allows contribution to be allocated to a Deposit Administration Fund (DA Fund) or a Separate Account Fund at the discretion of the plan sponsor.

Pooled Separate Accounts: Investments in pooled separate accounts represents ownership of units of participation (Units), rather than ownership of specific assets. The value of any one pooled separate account is determined by aggregating the value of all of the Units held by the Plan. The value of a single Unit is the total value of the pooled separate accounts underlying investments plus other assets less liabilities divided by the number of Units outstanding. Investments in the pooled separate accounts are valued at a net asset value per share method (unit pricing) which is generally determined by the quoted market price of the underlying investments.

Guaranteed Fund/Deposit Administration Fund (DA Fund): A secondary market providing the opportunity to sell the contract held by the Plan does not exist. Fair value represents contributions made under the contract, plus interest, less funds used to pay benefits and expenses. The contract is an unsecured general obligation of Sentry Life Insurance Company. Sentry Life Insurance Company is rated A+ by the A.M. Best Company.

Insurance Company Guaranteed Fund: The Guaranteed Fund is recorded at contract value in the Statement of Net Assets and is believed that the contract value is the most reasonable estimate of fair value funds based on the following information (a) The Plan's asset is not the underlying assets in the Guaranteed Fund, but rather, the contract. Therefore, the Plan does not own such underlying assets, but rather owns a series of promises or guarantees that are embedded in the contract. (b) The contract does not segregate or otherwise identify specific securities within the Guaranteed Fund and attribute them to any specific contract-holder. (c) The underlying assets are not segregated in a separate account for each contract-holder. Specific securities with the general account are not carved out and attributed to any specific contract holder. (d) Crediting rates are not based directly on the actual performance of the underlying securities in the Guaranteed Fund, but rather determined in the contract. (e) Crediting interest rates are reset at least as frequently as annually. (f) The Guaranteed Fund contains securities not only to support liabilities, but also supporting disparate insurance businesses, reserve requirements and general expense payments.

The Guaranteed Fund provided a guaranteed rate of return at the rate and for the duration that is communicated to the participant. The assets held in the Guaranteed Fund may be subject to surrender charges or a market value adjustment upon withdrawal as described in the contract.

Investment Measured Using the Net Asset Value per Share Practical Expedient: The following table summarized investments for which the fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments: the redemption notice period is applicable only to the plan.

E. Fully Benefit-Responsive Investment Contracts

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract and a portfolio of synthetic investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represent the disaggregation of contract value between types of investment contracts.

The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company to make payment to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contract, the Plan owns only the contract itself. Synthetic and traditional investment contract are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specific interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, which was 1.0% for the year ended December 31, 2024. The crediting rates are reset at least as frequently as annually.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's Investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

F. Related-Party Transactions and Party in Interest Transactions

Certain plan investments are managed by Sentry Life Insurance Company. Sentry Life Insurance is the trustee and record-keeper for the Plan at December 31, 2024 and 2023, therefore, these transactions qualify as party in interest transaction. Fees paid by the Plan Sponsor for the record-keeping services to Sentry Life Insurance was \$1,794 and commissions paid of \$6,336. Fees incurred by the plan for the investment services are included in net appreciation (depreciation) in fair value of investments because they are paid through revenue sharing rather than a direct payment. As described in note A, the plan used the forfeited accounts to pay for some of the administrative fees.

The plan is audited by Colangelo & Taber, PA, which qualifies as a party in interest transaction.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

G. Plan Termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

H. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified and the trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
