1. Description of plan

The following description of the Minnieland 401(k) Plan (the "Plan") provides only general information. The Plan agreement and summary plan description should be referred to for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor 401(k) defined contribution plan covering substantially all employees of Minnieland Private Day School, Inc. and Northern Virginia Academy of Early Learning, Inc. ("the Companies") who have been employed for twelve months and are age twenty-one or older. Entrance dates occur on the first day of every month. The Plan also covers all employers of the sponsor's controlled group of employers and affiliated services group unless specifically excluded in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a portion of their pre-tax annual compensation, as defined by the Plan, not to exceed the Internal Revenue Service defined limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan. The Companies make matching contributions based on each participant's pre-tax and Roth elective deferrals, matching 100% of contributions up to 3% of compensation plus 50% of contributions over 3% of compensation, but not over 5% of compensation. Upon credit to participants' accounts, the employer's contribution may be directed to any of the investment options available to the participants. Contributions are subject to certain limitations. Additionally, participants may contribute a portion of their post-tax annual compensation as defined by the Plan, not to exceed the Internal Revenue Service defined limits.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contribution and (b) Plan earnings, net of allocated administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Companies' matching portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100 percent vested after six years of credited service (20 percent per year beginning with the second year of credited service).

Forfeited accounts

As of December 31, 2024 and 2023, \$1,927 and \$879 remained in non-vested forfeited accounts, respectively. Forfeitures are used to reduce future employer matching contributions or administrative expenses. During 2024, no forfeitures were used to reduce employer matching contributions or administrative expenses. During 2023, \$17,725 of forfeitures were used to reduce employer matching contributions.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum equal to the value of the participant's vested interest in their account, installments over a period not to exceed the participant's lifetime or the joint lifetime of the participant and their spouse. For termination of service due to other reasons, a participant may elect to receive the value of their vested account interest as a lump-sum distribution.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from one to five years. The loans are secured by the balance in the participant's account. All new loans are assigned interest rates equal to the then existing prime rate of interest. As December 31, 2024 and 2023, interest rates ranged from 4.25 percent to 9.5 percent. Principal and interest is paid ratably through payroll deductions.

2. Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and present net assets available for benefits and changes in those assets, in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make certain estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions receivable and allowance for credit losses

Contributions receivables are determined based on the payroll paycheck date.

Investment income recognition

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participants loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Significant administration expenses of the Plan are paid directly by the plan sponsor except for fees paid to the investment managers from their respective funds and certain fees paid directly by the participants.

3. Information prepared and certified by the trustee

The plan administrator has elected the alternative method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the investment information certified by Empower Trust Company and Empower Annuity Insurance Company of America was not audited by the independent auditors except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

The Plan's financial information that was certified by Empower Trust Company and Empower Annuity Insurance Company of America is summarized as follows:

- a) Total investments as shown in the accompanying statements of net assets available for benefits of \$12,099,901 and \$11,277,878 as of December 31, 2024 and 2023, respectively.
- b) Notes receivable from participants as shown in the accompanying statements of net assets available for benefits of \$163,847 and \$171,325 as of December 31, 2024 and 2023, respectively.
- c) Net investment income as shown in the accompanying statements of changes in net assets available for benefits of \$1,686,818 and \$2,020,769 for the years ended December 31, 2024 and 2023, respectively.
- d) Interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits of \$11,488 and \$11,062 for the years ended December 31, 2024 and 2023, respectively.
- e) All investments-related information in the accompanying supplemental Schedule H, Line 4i-Schedule of Assets (Held At End of Year) as of December 31, 2024.

4. Investments at contract value

The Plan has entered into a benefit-responsive investment contract with Empower Annuity Insurance Company of America. The total value of this investment contract for December 31, 2024 and 2023 were \$585,720 and \$562,328, respectively. The Fixed Account - Series Class II is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2023 was 1.48% and for 2024 was 1.66%. The actual average yield earned by the plan for the benefit responsive fund can be derived by averaging the plan's quarterly interest rates. That average for 2023 was 1.48% and for 2024 was 1.66%

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: Fund administration amendments or changes, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the Fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the Fund, transfers to competing options without meeting the equity wash provisions of the Fund, and plan sponsor withdrawals without the appropriate notice to the Fund and /or issuer. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include management of the portfolio is not in accordance with investment guidelines, a breach of any material obligation under the wrap agreement, any representation or warranty made by the contract holder becomes untrue in any material way, a replacement of the Investment Advisor without prior consent of the issuer, the Fund is terminated or ceases to qualify as a group trust or

plans cease to meet the appropriate tax qualifications, or the wrap becomes a prohibited transaction within the meaning of Section 406 of ERISA.

5. Investments at fair value

The Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The following section describes the valuation methodologies the Plan uses to measure its assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Administrative expenses and parties in interest

The Plan invested in shares of registered investment companies managed by the trustee. A portion of the income or loss of the Plan was derived from these investments. Fees paid by the Plan to the trustee for certain investment management fees were deducted from the net asset values of the registered investment companies held by the Plan. Fees paid to Empower Trust Company and related entities totaled \$60,389 and \$52,028 during the years ended December 31, 2024 and 2023, respectively.

7. Plan termination

Although they have not expressed the intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

8. Income tax status

The Plan is operating under an adoption agreement with Empower Trust Company, LLC. The prototype plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by the Plan. The plan administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

In accordance with authoritative guidance issued by the FASB, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan is subject to income tax examinations for years ended December 31, 2021 through December 31, 2024.

9. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Delinquent participant contributions

During the Plan year ended December 31, 2023, the Companies failed to remit contributions to the Plan timely on four occasions, as reflected in the accompanying schedule of delinquent participant contributions. All contributions were remitted during the year ended December 31, 2023. Late interest has not yet been deposited, but is not expected to be material.

11. Subsequent events

The plan administrator assessed events occurring subsequent to December 31, 2024 through October 3, 2025, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements. No events have occurred that would require adjustment to or disclosure in the financial statements.
