## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Edmentum, Inc. Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Edmentum, Inc. Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **(1) Summary of Significant Accounting Policies**

The following description of the Edmentum, Inc. (the Company) Savings and Retirement Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**(a) General**

The Plan was established October 1, 1989 and is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**(b) Eligibility Requirements**

All employees of the Company are eligible to participate in the Plan upon employment provided they are at least 21 years of age.

**(c) Contributions**

Participant contributions are recorded in the period the employer makes the payroll deductions. Participants may contribute up to 60% of their pre-tax compensation, up to a maximum dollar amount, as defined, subject to certain other Internal Revenue Service (IRS) limitations. The Plan contains an automatic enrollment feature whereby employees are automatically enrolled at 4% of their pre-tax compensation. Annually, this amount is increased by 1% up to a maximum of 10% of their pre-tax compensation.

Company matching contributions are discretionary and accrued based on participant contributions. The matching contribution was 50% for every dollar of each participant contribution up to a maximum of the greater of 3% of participant eligible compensation, or \$11,500. The Company may also make additional contributions to the Plan at its discretion. Any such amount must be designated by Company resolution.

Eligible participants who have attained age 50 before the close of the calendar year may also make catch-up contributions up to the dollar amount of the catch-up permitted for the year.

**(d) Participant Accounts**

Individual participant accounts are maintained by the Plan's recordkeeper and plan administrator, Fidelity Investments Institutional Operations Company, Inc. (Fidelity). Each participant's account is credited with the participant's contribution, applicable share of Plan investment earnings or loss, net of administrative expenses, and an allocation of employer matching contributions. Plan earnings are allocated based on account balances by fund.

**(e) Vesting and Forfeitures**

Participants are immediately vested in their contributions and actual earnings thereon. Participants vest in their Company contribution account based on the following schedule:

Years of service	Vested percentage
Less than 1 year	—
1 year but less than 2	33-1/3
2 years but less than 3	66-2/3
3 years or more	100

A participant will also become fully vested upon permanent disability or attainment of normal retirement as defined in the Plan.

Forfeitures of nonvested Company contributions are invested in a common collective trust fund and can be used to pay administrative fees of the plan and/or reduce future contributions made by the Company. During 2024, approximately \$143,500 of forfeitures were incurred, of which approximately \$29,183 was used to pay administrative fees of the Plan and \$113,703 was used to reduce employer contributions. There was approximately \$68,000 in forfeited nonvested accounts at December 31, 2024.

**(f) Benefit Paid to Participants**

On termination of service due to death, disability or retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments over a specified time, or rollover the entire vested portion to a qualified plan or Individual Retirement Account (IRA). If the participant fails to notify the plan administrator of distribution options within 90 days of termination of service and the vested account balance is less than \$5,000, the vested balance is automatically rolled into a Fidelity IRA. A participant with less than \$1,000 invested benefits receives a lump sum distribution, net of tax.

**(g) Loans**

Participants may borrow from their fund accounts a minimum amount of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in the account during the prior twelve months. The term of a loan repayment may not be greater than five years unless the loan qualifies as a residential mortgage loan. The Plan administrator may fix the term of repayment of a residential mortgage loan considering the maturity dates quoted by representative lending institutions in the local area for a similar loan, but in no event greater than for a period of 10 years or such longer period as approved on a nondiscriminatory basis by the Plan administrator. The loans are collateralized by the

balance in the participant's account and bear interest at a rate equal to prime plus 1% at the date of loan origination. Principal and interest is paid ratably through biweekly payroll deductions. Participant notes receivable have interest rates ranging from 4.25% to 9.50% and are due at various dates through 2031. Repayments are generally made through payroll deductions and are invested among the various investment funds in the same manner as participant contributions.

**(h) *Investment Options***

The Plan offers thirty-four investment options: thirty-three mutual funds and one common collective trust fund. Plan participants direct the investment of their accounts among these options. Company contributions are invested in the fund options in the same manner as participant contributions.

**(i) *Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and assets of the Plan will be distributed in accordance with the Plan document.

**(2) *Summary of Significant Accounting Policies***

The following significant accounting policies were used to prepare the financial statements in accordance with accounting principles generally accepted in the United States of America.

**(a) *Basis of Accounting***

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

**(b) *Investment Valuation and Income Recognition***

Plan investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The value of shares in registered investment companies (mutual funds) is stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year-end. The net increase or decrease in market value of the investment portfolio during the year and realized gains and losses have been reported in the accompanying statement of changes in net assets available for benefits.

The Plan invests in investment contracts through a common/collective trust. Contract value for the common/collective trust is based on the net asset value of the trust as reported by the investment advisor. As required by ASU 2015-12, the statements of net assets available for benefits present the contract value of the investment in the common/collective trust. The statement of changes in net assets available for benefits is prepared on a contract value basis.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net

appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**(c) Administrative Expenses**

Administrative expenses, primarily transaction fees and professional services, are paid by the Plan. All other administration costs have been paid by the Company at its discretion.

**(d) Benefits Paid to Participants**

Benefit payments are recorded when paid.

**(e) Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make use of estimates and assumptions that affect the reported amounts of assets available for benefits at the date of the financial statements and the changes in assets available from plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**(3) Certification by the Plan Investment Manager and Trustee**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by the Trustee, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule.

The Trustee has provided the Plan administrator with certifications as to the completeness and accuracy of investment assets aggregating \$115,533,512 and \$102,727,446 as of December 31, 2024 and 2023, and the related net investment gain, including the net appreciation in fair value of such assets, of \$10,437,933 for the year ended December 31, 2024. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the Trustee as being complete and accurate.

**(4) Fair Value Measurements**

ASC Topic 820, *Fair Value Measurements and Disclosures*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements and related disclosures, ASC Topic 820

established a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value into three broad levels, which are described below:

Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities that are accessible at the measurement date for assets and liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the assets or liabilities, either directly or indirectly. These include quoted prices for identical or similar assets or liabilities in markets that are not active, that is, markets in which there are few transactions for the asset or liability, the prices are not current, or price quotations vary substantially either over time or among market makers, or in which little information is released publicly and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs developed using the Plan's estimates and assumptions, which reflect those that the market participants would use. Such inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

Determining where an asset or liability falls within the hierarchy depends on the lowest level input that is significant to the fair value measurement as a whole. In determining fair value, the Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible and considers counterparty credit risk in the assessment of fair value.

Assets measured at fair value for the Plan are as follows:

*Mutual funds* – Valued at the closing price reported on the active market on which the security is traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

For the years ended December 31, 2024 and 2023, the Plan held no assets in which significant unobservable inputs (Level 3) were used in determining fair value. The Plan did not have any significant transfers between Levels 1 and 2 during the periods.

**(5) Risks and Uncertainties**

The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in future periods.

**(6) Tax Status**

The Plan is a prototype plan. The IRS has determined and informed the Trustee by letter dated October 9, 2003, that the prototype plan and related trust are designed in accordance with applicable Sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of this letter, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, the Plan, as amended, is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2017.

**(7) Party-In-Interest**

Certain Plan investments, shares of mutual funds and the collective trust fund, are managed by Fidelity.

Fidelity is the Trustee as defined by the Plan and, therefore, these transactions qualify as related party transactions. In addition, certain administrative fees are paid by the Company.
