NOTE 1: DESCRIPTION OF PLAN

The following description of the Silver State International Trucks 401(k) Profit Sharing Plan (the Plan) provides only general information. A more complete description of the Plan's provisions can be found in the Plan agreement.

General – The Plan, which was adopted on January 1, 2008, is a 401(k) defined contribution plan covering all eligible employees of JBP, LLC dba Silver State International Trucks and Peterbilt Truck Parts & Equipment, LLC (the Companies) who have completed sixty days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Companies' annual contributions to the Plan will equal the total amount of employee deferral contributions, employee Roth deferrals, employer matching contributions, and employer discretionary match contributions. Employee deferral contributions and Roth deferral contributions under Internal Revenue Code Section 401(k) are amounts which the Companies must contribute pursuant to a salary reduction agreement. The Companies must contribute the amount by which participants have reduced their compensation for the plan year, subject to a statutory dollar limitation of \$23,000 for 2024. An additional salary deferral, up to \$7,500, may be made for the calendar year by any participant that is age 50 or over during the calendar year. Effective January 1, 2017, the Plan was amended to convert to a Safe Harbor plan intended to satisfy testing under Internal Revenue Code Sections 401(k)(12) and 401(m)(11). The Companies make employer matching contributions in the amount of 100% of the employee's salary reductions that do not exceed 4% of compensation. The Plan also permits discretionary profit-sharing contributions and discretionary matching contributions to be made as a discretionary amount and percentage of matched employee contributions. For the plan years ended December 31, 2024 and 2023, the employer safe harbor matching contributions were \$418,519 and \$400,933, respectively.

Participant Accounts – Each participant's account is credited with an allocation of the employer's nonelective contribution, plan earnings, actual employee deferral contributions, employer matching contributions, and rollover contributions, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting and Forfeitures – Participants are 100% vested in their employee deferrals and employer contributions. Therefore, no forfeitures are available to be allocated.

Investment Options – Upon enrollment in the Plan, a participant may direct employee deferrals, employer matching contributions and nonelective contributions in any of the investment funds John Hancock Life Insurance Company USA offers. Participants may change their investment options daily through a toll-free number with John Hancock or via the Internet on the John Hancock website.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from one to five years, or longer if the loan is used to acquire a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the advisory committee. The interest rates on the current loans outstanding range from 4.25% to 9.5%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits – Upon termination of employment, a participant will be paid as soon as administratively feasible following termination of employment. However, if the vested benefit does not exceed \$7,000, a lump-sum distribution will be made within a reasonable time after termination of employment regardless of whether the participant elects to receive it. Normal retirement age is defined as 65. The benefit obligations payable to terminated participants were \$1,607,328 on December 31, 2024.

Hardship Distributions – Under certain circumstances, a participant may qualify for certain hardship distributions if a participant has an immediate and significant financial need. The participant may receive a lump sum payment equal to the elective deferral, including Roth deferrals, and rollovers.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting, except for benefits payable to participants.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held at John Hancock are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest is recognized over the term of the loan and is calculated using the simple-interest method on principal amounts outstanding.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

NOTE 4: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the assets or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds and exchange traded funds are valued at the net asset value (NAV) of shares held by the plan at year end. Guaranteed interest accounts are valued at fair value based on daily published rates on which interest is paid for the specified terms.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

NOTE 5: INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into an unallocated retirement account group annuity contract with John Hancock Life Insurance Company (John Hancock). This guaranteed interest account is an account through which contributions can be accumulated with interest. As long as money is kept invested until it matures, John Hancock USA guarantees the return of both the principal investment and interest earned according to the terms of the contract. The contract is included in the financial statements at fair value. Fair value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The investment contract is not fully benefit-responsive.

NOTE 6: TAX STATUS

The Plan is not required to obtain an Internal Revenue Service determination letter, as it is written to conform to a pre-approved volume submitter plan for which the Internal Revenue Service has issued an opinion letter on which the Plan may rely. Although the Plan has been amended since its inception and restated, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: PLAN AMENDMENTS

The Internal Revenue Service and Department of Labor require all qualified retirement plan to encompass certain provisions in order to satisfy applicable Internal Revenue Code laws. As a general rule, plan sponsors using a pre-approved plan document must restate their plan every six years to incorporate law changes, procedural changes and discretionary amendments that have been adopted since the last restatement. The Plan was restated effective January 1, 2022 under the Cycle 3 restatement process to ensure that Plan remains in compliance with its tax-favored status. Additional amendments encompass hardship distributions, SECURE Act regulations and CARES Act regulations.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 9: RISKS AND UNCERTAINTIES

Plan participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 10: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of registered investment companies (mutual funds) and exchange traded funds managed by fund companies. Fees paid to these companies by the Plan are deducted from the net asset values of the registered investment companies held by the Plan. Fees paid to John Hancock are likewise deducted from net asset values. John Hancock Life Insurance Company (U.S.A.) is the contract administrator of the Plan, and as such, receives fees from the plan for recordkeeping and executing investment transactions. These fees, and fees paid to Bidwell Consulting Services, Inc. as third-party administrator, are included in administration expenses on the statement of changes in net assets available for benefits.

NOTE 11: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Department of Labor considers participant loans to be classified as an investment for purposes of Form 5500, while generally accepted accounting principles consider participant loans to be receivables. The following is a reconciliation of investments per the financial statements:
