### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of SA Recycling, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.



**1. THE PLAN**

The following description of the SA Recycling, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan commenced in October of 2007 as a defined contribution plan covering all employees of SA Recycling (the "Company") employed for 6 months who have attained age 18. The Plan has since been amended in January of 2012, September of 2013, November of 2015, September of 2017, February of 2020, June of 2021, March of 2022, May of 2022, June of 2023, and most recently in July of 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute part of their pretax annual compensation as defined by the Plan, up to the maximum allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into a benefit responsive investment contract. The contract currently offers various mutual funds and a money market account as investment options for participants.

In November of 2015, the Company amended the Plan to include matching contributions equal to 100% of each participant's deferred compensation up to 3% of their total pay, plus 50% of each participant's deferred compensation up to 6% of pay above the first 3%. Additional amounts could be contributed at the discretion of the Company.

In August of 2017, the Company transferred to a new recordkeeper and trustee and amended the Plan to include various provisions including an annual automatic increase of 1% for employee deferrals and the option of Roth Deferrals. Also, the Company elected not to contribute discretionary contributions during the plan years ended December 31, 2024 and 2023.

**1. THE PLAN (CONTINUED)**

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, an allocation of the Company's discretionary contributions, if any, and an allocation of Plan earnings within the designated specified investment funds. Each participant's account is charged with an allocation of management fees. Allocations are based on participant earnings or account balances, as defined. The Company pays administrative expenses incurred on behalf of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions, along with employer qualified nonelective contributions, plus actual earnings thereon. The Company shall make additional employer contributions which are subject to a vesting percentage scale as defined in the Plan agreement. Participants who become totally disabled or die before normal retirement age become fully vested in their accrued benefits.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to 10 years or a repayment period consistent with commercial home loan practices. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Interest rates range from 3.25% to 10.5%. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or as an annuity described in the Plan agreement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**1. THE PLAN (CONTINUED)**

Forfeitures

Forfeited non-vested accounts are used to reduce the Company's contribution for the next plan year. For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$165 and \$6,809, respectively. For the years ended December 31, 2024 and 2023, respectively, \$6,994 and \$0, of forfeitures were used to fund employer contributions.

Hardship withdrawal

A participant may be permitted to withdraw a portion or all of the balance of their individual account that is attributable to their tax-deferred contributions (without earnings) for the reasons specified by and to the extent permitted under regulations issued by the Internal Revenue Service.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded when paid.

Operating expenses

All expenses of maintaining the Plan are paid by the Company.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs are those that are observable, either directly or indirectly, for the asset or liability other than quoted prices included in Level 1; and Level 3 inputs, which are unobservable, are used when level 1 and 2 inputs are not available. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used to measure investments where the underlying assets are directly observable to unadjusted quoted prices in active markets. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 3 inputs for the year ended December 31, 2024.

Level 1 fair value measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

**6. GUARANTEED INVESTMENT CONTRACTS**

The guaranteed investment contracts ("GICs") are invested in contracts with Standard Insurance Company ("Standard"). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GICs are fully-benefit responsive contracts and as such, are reported at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023, was \$12,095,131 and \$11,551,413, respectively. The current rate was 3.10% for 2024 and 2.95% for 2023. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan's ability to transact at contract value with Standard. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their matching contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their accounts.

**8. RELATED PARTY TRANSACTIONS**

The Plan recordkeeper is Transamerica Retirement Solutions, who is also considered a party-in-interest to the Plan and is responsible for the day-to-day administration and operation of the Plan. As of December 31, 2024 and 2023, total administrative fees paid by the Plan to Transamerica Retirement Solutions totaled \$425,408 and \$370,602 respectively.

**9. TAX STATUS**

The Plan is placing reliance on an opinion letter dated March 31, 2014, received from the Internal Revenue Service indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since the date of the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

**10. RISKS AND UNCERTAINTIES**

The Plan's investments are subject to certain conditions contained in the market place such as the volatility in share prices, consumer confidence, and the overall health of the economy. These conditions, as well as other conditions not in the direct control of the Plan, could have a material effect on the value of the Plan's investments.

**11. SUBSEQUENT EVENTS**

Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
