**NOTE A - DESCRIPTION OF PLAN**

The following description of the INTERNATIONAL COATINGS CO., INC. ("Company") 401(K) Plan ("Plan") is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was effective July 7, 1964 and amended and restated most recently effective January 1, 2022.

The Plan is sponsored by Insta Graphics Systems, International Coatings Co, and International Coatings Co Georgia (the "Plan Sponsor"). Information about the Plan's agreements, vesting and benefit provisions, is contained in the Plan's Summary Plan Description. Participants should refer to the Plan's Summary Plan Descriptions for more complete information. Copies of these documents for the Plan are available at the corporate office of the Plan Sponsor.

*General*

The Plan is a defined contribution plan covering all employees of the Company. The Plan excludes union employees and employees that are not common law employees. For employee contributions, participants must be age 21 and have completed three (3) consecutive months of service. For employer contributions, participants must be age 21 and have completed one (1) year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is governed by the International COatings CO IncAdministrative Committee ("Committee"). The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Directors.

*Contributions*

Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes an employer match of the lesser of 25 percent of the first 3 percent of base compensation or 25 percent of the amount the participant contributes to the Plan, on a per payroll basis. At the discretion of the Board of Directors, the Company makes a discretionary profit sharing contribution to the Plan as well. For the year ended December 31, 2024, the Company made a \$125,000 profit sharing contribution to the Plan. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and Company matching contributions as well as allocations of Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts, the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participants' account and bear interest at rates of 4.25% and 9.50%. Principal and interest is paid ratably through weekly payroll deductions.

*Payment of Benefits*

On termination of service due to death, disability or retirement, or termination of service due to other reasons, a participant may receive a lump-sum or direct transfer amount equal to the value of the participant's vested interest in his or her account. Amounts totaling \$1,260,272 represent accounts of participants that have withdrawn from the plan but have not been paid as of December 31, 2024.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are fully vested when their employment terminates by reason of normal retirement, death or disability. Other than the aforementioned reasons, vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

*Forfeited Accounts*

Forfeited amounts totaled \$1,639 and \$2,147 for the years ended December 31, 2024 and 2023, respectively. Forfeitures were held to reduce future administrative fees. No forfeitures plus earnings were credited back to a participant for excess forfeited amounts during the year.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the modified cash basis of accounting; investments are reported on the cash basis and receivables on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

*Investment Valuation and Income Recognition (Continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded as received. Net increase (decrease) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and expensed when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

*Payment of Benefits*

Benefits are recorded when paid.

*Administrative Expenses*

Administrative expenses of maintaining the Plan are paid by the company or from forfeitures except for withdrawals, distributions and loan origination fees associated with notes receivable from participants; those are charged to the participants account.

*Subsequent Events*

As a result of the spread of COVID-19 coronavirus, economic uncertainties have arisen which have resulted in volatility in the investment markets. The duration of these uncertainties and the ultimate financial effects cannot be reasonably estimated at this time. No other subsequent events were identified through July 14, 2025, the date these financial statements were available to be issued.

**NOTE C - CERTIFIED INVESTMENTS (UNAUDITED)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company (the custodian of the Plan).

During 2024, the Plan's investments (including gains and losses from registered investment companies bought and sold, as well as held during the year) appreciated in value by \$1,268,931.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Insurance contracts:* Valued using contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

**NOTE E - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL) totaling \$727,685 for 2024 and \$726,410 for 2023. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.75%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by National, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**NOTE E - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Matrix Trust Company. Matrix Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Matrix Trust Company for investment management services are included as administrative expenses on the Statement of Changes in Net Assets Available for Benefits. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE H - TAX STATUS**

The Internal Revenue Service has determined and informed the Trustee by the latest letter dated December 22, 2009 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for tax years prior to 2021 for federal.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As a result of COVID-19, there has been heightened market risk and volatility associated with the pandemic, and this could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits. Because of the uncertainty of the markets during this time, Plan management is unable to estimate the total impact the pandemic will have.
