### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Denver Broncos Team 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Plan Description

The following description of Denver Broncos Team 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Denver Broncos Team, LLC (the "Company") who have completed three months of service and are age 21 or older. An eligible participant is entered into the Plan immediately upon meeting the eligibility requirements unless they affirmatively elect not to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees of the Company are considered eligible for participation, except for: (1) nonresident aliens with no U.S. source income; (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan; (3) leased employees; (4) independent contractors; (5) part-time/temporary/seasonal employees, unless at least 1,000 hours of service are completed during the plan year; (6) employees classified by the Company as a player; (7) employees engaged by the Company pursuant to an agreement providing that the employee is not eligible to participate in the Plan; or (8) employees who are residents of Puerto Rico.

An employee will also receive service credit hours to be eligible to participate in the Plan from the following predecessor employers: The National Football League (NFL); NFL Productions, LLC fka NFL Films, Inc; NFL Properties, LLC; NFL Enterprises L.P.; NFL Management Council; any NFL scouting organization affiliated with any current or previous NFL club; a NFL club except with respect to service rendered for any such club as a player unless the player, upon ceasing to be a player, became employed in another capacity with the club; and any other entity designated by the Company.

If an employee terminates employment or is transferred to another club or other NFL organization, they will not be able to continue to contribute to the Plan even if they are receiving deferred compensation from the Company.

#### **Administration**

The Company is the sponsor of the Plan and serves as the plan administrator. Empower Trust Company, LLC and Empower Annuity Insurance Company of America serve as trustees, manage plan assets, and maintain the Plan's records. The investment committee determines the appropriateness of the Plan's investment offerings and monitors the investment performance.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employees are automatically enrolled at a deferral rate of 3 percent of eligible compensation unless they make an election not to defer or defer a different percentage. Automatic enrollment deferral contributions are increased by 1 percent each year subsequent to enrollment up to 10 percent.

The Company may make a discretionary matching contribution. For the plan year ended December 31, 2024, the Company's match was 100 percent of the salary deferral contribution on the first 5 percent of eligible compensation deferred up to \$7,500. The Company may elect to deposit the matching contribution to the Plan during the plan year or as of the end of the plan year. Catch-up contributions are eligible for the discretionary matching contribution.

### Note 1 - Plan Description (Continued)

The Company may also make an annual nonelective contribution to the Plan. For the plan year ended December 31, 2024, the Company provided a nonelective contribution based on length of service. For participants with less than 5 years of service, the Company provided a nonelective contribution of 4 percent of eligible compensation. For participants with 5 to 9 years of service, the Company provided a nonelective contribution of 5 percent of eligible compensation. For participants with 10 to 14 years of service, the Company provided a nonelective contribution of 6 percent of eligible compensation. For participants with 15 or more years of service, the Company provided a nonelective contribution of 7 percent of eligible compensation. The eligible compensation for any nonelective contribution is capped at the annual compensation limit under IRS Code §401(a)(17). For the plan year ended December 31, 2024, that limit was \$345,000.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through bimonthly payroll deductions.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants' contributions, the employer discretionary matching contribution, if any, and the nonelective contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### ***Benefit Payments***

On termination of service due to death, disability, retirement, or termination a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$7,000, their vested balances may be automatically rolled into an IRA unless otherwise elected.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the Company.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

#### ***Related Party and Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Annuity Insurance Company of America (Empower Annuity) or its affiliates. Empower Annuity is a trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

#### ***Revenue Sharing***

The Plan has a revenue-sharing agreement where participants receive a credit against their expenses for investing in the custodian's investment options. During the year ended December 31, 2024, the Plan received \$56,037 in revenue credits from the custodian, which is included in net realized and unrealized gains on investments on the statement of changes in net assets available for benefits.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

**Subsequent Events**

The financial statements and related disclosures include evaluation of events up through and including September 26, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, the "Trustees") hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 6 - Investment Contracts**

The Plan has a benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium- to long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 0 percent. When establishing interest crediting rates for this product, Empower Annuity considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 60 days or, in rare circumstances, contract value paid over time, as stated in the contract. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 75 days or over time.

**Note 7 - Plan Merger**

Effective December 31, 2024, the Stadium Management Company 401(k) Savings Plan was merged into the Plan. Accordingly, assets of \$9,929,878 were transferred into the Plan in 2024. At December 31, 2024, investments of the Stadium Management Company 401(k) Savings Plan had been liquidated and were in transit to the Plan. Related assets were received and deposited in the Plan in January 2025.
