Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Heller 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Heller 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the Heller 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan was restated effective January 1, 2015. The Plan’s original effective date was January 1, 2007.

General

The Plan qualifies under Internal Revenue Code Section 401(k) as a defined contribution plan covering all employees of Heller Ford Sales, Inc., the Plan Sponsor, and also employees of certain related businesses. The Plan was established January 1, 2007, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Income Tax Status

An opinion letter dated March 31, 2014, was received from the Internal Revenue Service stating that the prototype the Plan has adopted is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. There have been amendments to the plan after the original opinion letter, and management believes the plan is still in compliance.

Participation in the Plan

Employees are eligible to make salary deferral contributions to the Plan after attaining the age of 21, and completing three months of service. Employees are eligible for employer matching contributions after attaining the age of 21 and completing three months of service. Employees covered under collective bargaining agreements, non-resident aliens and drivers (porters) are ineligible to participate in the Plan. Once eligible, an employee is enrolled in an automatic salary deferral of 5%. An employee has 90 days to opt out of the automatic deferral. Plan entry dates occur the first day of each Plan quarter.

Contributions

Participants may contribute up to \$23,000 of their pre-tax compensation for the calendar years 2024 or up to \$30,500 for the calendar year 2024, for those participants age 50 and older, as provided by Internal Revenue Service Regulations (“catch-up deferrals”). Participants may also contribute amounts representing distributions (“rollovers”) from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

NOTES TO FINANCIAL STATEMENTS

The Employer's matching contribution was equal to 100% of the participant elective deferrals of up to 2% of the employee's annual compensation for the years ended December 31, 2024 and 2023. The Employer can make discretionary matching contributions and non-elective contributions. Compensation is defined as W-2 wages (plus elective deferrals).

Participant Accounts

Each participant's individual account is credited with the participant's contribution, the employer's matching contribution, and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances.

Vesting

Participants are 100% vested at all times in their elective deferrals, employee contributions, safe harbor contributions and rollover contributions. Vesting in employer matching contributions, and nonelective contributions is gradual based on years of service. A participant is 100% vested in these amounts after six years of credited service. A participant becomes 100% vested in all amounts upon death or disability.

Plan Administration

Future Plan by Ascensus is the third-party administrator of the Plan.

Participant Distributions and Payments of Benefits

On account of death, disability, or attainment of early (age 55) or normal (age 65) retirement age, participants may elect to begin distribution of distributable benefits within a reasonable period after the distribution determination date.

Participants may request a distribution, of all or any portion of the participant's account balance attributable to elective deferrals, matching contributions and non-elective contributions, including the earnings thereon, for reasons of hardship. In-service distributions are permitted from all contributions that are 100% vested upon the attainment of age 59 ½ with the exception of money purchase contributions for which the minimum age for distribution is 62.

Plan Termination

The Employer may terminate the Plan at any time by delivering to the Trustee an instrument in writing that designates such termination. Following termination of the Plan, the Trust will continue until the entire distributable benefit of each participant has been distributed.

Plan Loans to Participants

Participants may borrow from all their accounts up to 50% of their account balance up to \$50,000. The loans are secured by the vested balance in the participant's account and bear a reasonable interest rate, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. In the event of default, foreclosure on the note and attachment of security will not occur until a distributable event occurs for the participant.

NOTES TO FINANCIAL STATEMENTS

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,136 and \$9,624, respectively. These accounts will be used to pay Plan expenses and then reduce future employer contributions.

Note 2. Use of Estimates and Summary of Significant Accounting Policies

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Significant accounting policies:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Valuation of Investments and Income Recognition

The Plan’s investments are stated at fair value. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions

Participant Elective Deferrals (participants' deferred compensation) are recognized by the Plan when deducted from the participants’ salary. Employer Matching 401(k) contributions are recognized as elective deferrals are made and are based on amounts calculated in accordance with Plan provisions by the Plan's administrator.

Subsequent Event Recognition

Management has evaluated the need for subsequent event recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

Payment of Benefits

Benefits are recorded when paid.

NOTES TO FINANCIAL STATEMENTS

Administrative Expenses

Certain administrative functions applicable to the Plan are performed by employees of the Company. No such employees receive compensation from the Plan. Certain other administrative expenses are paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3. Unaudited Information Certified by the Custodian

As permitted by ERISA Section 103(a)(3)(C), the December 31, 2024 and 2023, statements of net assets available for benefits, the investment activities included on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes all assets listed on the statements of net assets available for benefits for 2024 and 2023, and additions and deductions to net assets available for benefits as reported on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Note 4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 input because they generally provide the most reliable evidence of fair value. No level 2 or level 3 inputs were utilized by the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
