### Opinion

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule H, line 4i-schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1 - Description of Plan**

The following brief description of the Oftedal Construction, Inc. Employee Stock Ownership Plan and Trust (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

Oftedal Construction, Inc. (Company) established the Oftedal Construction, Inc. Employee Stock Ownership Plan and Trust as of October 1, 2001. The Plan operates, in relevant part, as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by Oftedal Construction, Inc.'s Board of Directors. The Board also appoints the Plan's Trustees.

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed one year of service and are 19 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Employees are eligible to receive an allocation of employer contributions only if they are employed on September 30 of the Plan year and have worked at least 1,000 hours of service unless they terminate employment due to retirement at age 65, death, or disability.

### **Entry Date**

Employees may enter the Plan on the first day of January or July coinciding with or following the date they satisfy the Plan's eligibility requirements. However, if the employee has separated from service with the Company and not returned to service prior to such Plan entry date, the employee is not eligible for participation.

### **Contributions**

Contributions to the Plan are made by the Company at the discretion of the Company. The contributions are allocated according to the pro rata share of each participant's compensation to total eligible compensation. Participants must have completed 1,000 hours of service and be actively employed at September 30 of the Plan year, unless terminated due to retirement, death or disability, to receive an allocation of the contribution. In 2024, the Company made a discretionary contribution of \$2,076,044.

### **Voting Rights**

Full and fractional shares of stock in the Trust shall be voted by the Trustees. The Trustees shall follow a participant's instructions for voting of full and fractional shares of stock allocated to the participant's account with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction as may be provided in regulations.

The Trustees will vote shares of stock allocated to participant’s accounts for which instructions are not received from the participants, and stock contributed to or acquired by the Plan that is not yet allocated, in a manner that, according to the Trustees’ sole discretion, is in the best interests of the participants and that complies with the Code and ERISA.

**Put Option**

Under federal income tax regulations, the Employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited with a sum of cash or an allocation of shares of the Company’s common stock and forfeitures of terminated participants’ non-vested accounts, in such an amount as determined in the sole discretion of the Employer. Only those participants who are eligible employees of the Company will receive an allocation. Allocations are based on a participant’s eligible compensation, relative to total eligible compensation. Allocation of stock and other asset gains and losses are proportional to the respective account balances.

**Vesting**

If a participant’s employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Vesting is based on years of credited services as set forth in the following table:

Notwithstanding the foregoing, a participant’s vested percentage will be 100% upon occurrence of the following events: (1) reaching the participant’s normal retirement age, (2) separation from service due to disability, (3) death, (4) termination of the Plan, (5) partial termination of the Plan affecting the participant, or (6) complete discontinuance by the Employer of contributions.

### **Forfeitures**

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. For the year ended December 31, 2024, there was \$41,475 in forfeitures of terminated non-vested account balances allocated to remaining participants.

### **Payment of Benefits**

Beyond diversification, distributions from the Plan will not be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. As required by Code Section 409(h), participants shall be entitled to a distribution in the form of stock. To the extent distributions are not made in stock, any put option or right of first refusal provisions otherwise applicable to distributions of employer stock shall not apply.

### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments, which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In the first five years, a participant may diversify up to 25% of the Company stock allocated to their account, less any shares previously diversified. In the final year, a participant may request to diversify up to 50% of the Company stock allocated to their account. The Plan shall either: (1) distribute to the participant the portion of the participant's account covered by the election, or (2) offer the participant at least three investment options and invest the portion of the participant's account covered by the election in such investment options according to the participant's instructions.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their account. Upon termination of the Plan, the ESOP committee directs the Trustee to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Released gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year. The Plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors/trustees.

The classification of investment earnings (losses) reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

### **Payment of Benefits**

Benefits payments to participants are recorded when paid.

### **Expenses**

As provided in the Plan agreement, administrative expenses may be paid by either the Plan or the Company. The Company has historically paid the operating expenses for the Plan. Expenses paid by the Company are excluded from these financial statements.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock – Reported at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques. The appraiser took into account historical and projected cash flows and net income, financial statement ratios, market comparables, and estimated fair value of company assets and liabilities, including certain discounts.

The valuation process involves Plan management’s selection of an independent appraiser on an annual basis. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value, which Plan management, along with the ESOP Trustee, reviews in detail, discusses, and approves.

**Note 5 - Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 23, 2014, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Related Party and Party-in-Interest Transactions**

The Plan invests in Company common stock and the Company pays the Plan's expenses. These involve related party and party-in-interest transactions. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

**Note 7 - Risks and Uncertainties**

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Note 8 - Transfer to Oftedal Construction, Inc. 401(k) Profit Sharing Plan**

During 2024, several participants close to retirement elected to move part of the value of their investment in Company common stock into investments in the Oftedal Construction, Inc. 401(k) Profit Sharing Plan.

**Note 9 - Subsequent Events**

Effective January 1, 2025, the Plan was amended to increase the distribution cash-out limit to \$7,000 and clarify the beneficiary distributions in accordance with the provisions of the SECURE Act 2.0.

The Plan sponsor has evaluated subsequent events through September 30, 2025, the date which the financial statements were available to be issued.
