## **Note 1. Description of the Plan**

The following description of the Tukaiz, LLC 401(k) Plan (Plan) provides only general information. Interested parties should refer to the Plan Document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering substantially all employees of Tukaiz, LLC (Company) who have three months of service, as defined by the Plan Document and are at least 19 years of age. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

### **Contributions**

Each year participants may contribute to the Plan up to 75% of pre-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may make all or a portion of their contributions as Roth contributions to the Plan. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes a matching contribution annually in an amount specified by the Company, however, not to exceed 6% of a participant's compensation. The Company elected to contribute a matching contribution based on 10% of the first 6% of a participant's compensation, totaling \$30,795, to the Plan for the year ended December 31, 2024. The Plan currently offers various pooled separate accounts and a guaranteed interest account as investment options for participants.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's discretionary matching contributions, administrative expenses and plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The participant must secure the loan by a pledge of no more than 50% of the present value of the participant's vested interest in the Plan. The loan period cannot exceed five years, unless the proceeds of the loan are used to purchase a primary residence, in which case the loan period shall not exceed 30 years. The loans bear interest at the prime rate plus 1%. The interest rates for outstanding loans ranged from 4.25% to 9.5% at December 31, 2024. Principal and interest are paid ratably through weekly payroll deductions.

### **Vesting**

Participants are immediately fully vested in participant and rollover contributions plus the actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on continuous years of service. A participant is 20% vested in the employer match after completing two years of service and 20% vested for each subsequent year, reaching 100% vesting after six years of credited service.

### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive a single, lump-sum payment equal to the value of his or her vested account balance.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

***Forfeitures***

At December 31, 2024 and 2023, there were no forfeited nonvested accounts available for use. Such forfeited nonvested funds shall be used to reduce administrative expenses or future employer contributions to the Plan. Forfeitures used during the plan year ended December 31, 2024 were \$290.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value (except for the Guaranteed Interest Account, which is reported at contract value). Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Pooled separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There were no unfunded commitments at December 31, 2024 and 2023.

The pooled separate accounts are sub-accounts which are exclusively invested in shares of funds issued by John Hancock Variable Insurance Trust, John Hancock Funds II, or the John Hancock Funds III (proprietary underlying fund), or in portfolios of other non-affiliated trusts (non-affiliated trusts). The proprietary underlying funds may include open-ended management investment companies (commonly known as mutual funds) or common collective trusts. The non-proprietary underlying funds may include mutual funds, common collective trusts, or exchanged traded funds. Each sub-account represents net contributions from unitholders that are allocated to the underlying fund of the sub-account maintained by the Company.

The Plan's investment in the guaranteed income account is reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

**Note 3. Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with John Hancock Life Insurance Company (U.S.A.) (John Hancock). John Hancock maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive and therefore contract value is the relevant measurement. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The contract value approximates the fair value of the investment contract at December 31, 2024 and 2023.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 4. Information Certified by the Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

## **Note 5. Tax Status**

The Plan operates under an adoption agreement in connection with a non-standardized preapproved plan sponsored by Retirement Plan Consultants Inc. This has been filed with the appropriate agency and the plan sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the non-standardized pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the opinion letter. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 6. Risks and Uncertainties**

The Plan invests in various investment options. These investment options are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment options and the level of uncertainty related to changes in the value of the investment options, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their respective account balances.

## **Note 8. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are units of pooled separate accounts managed by John Hancock. John Hancock is the custodian as defined in the Plan and therefore, these transactions qualify as party-in-interest transactions. Administrative expenses of \$25,096 were paid by the Plan during 2024 for professional services rendered by parties in interest. The Company provides certain administrative services at no cost to the Plan.

## **Note 9. Nonexempt Transactions**

The Department of Labor (DOL) has established certain maximum timeframes by which participant contributions must be deposited into the participant's account. The DOL considers late deposits to be prohibited transactions requiring disclosure in the notes to the financial statements as well as in the accompanying Schedule H, Line 4a – Schedule of Delinquent Participant Contributions. During 2024, the Plan engaged in prohibited transactions

related to late deposits of employee contributions and loan repayments totaling \$2,180. Plan management corrected these late deposits in February 2025.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
