Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. As a result, the Aaren Scientific, Inc. 401(k) Profit Sharing Plan used the liquidation basis of accounting to present the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1. DESCRIPTION OF PLAN

The following description of Aaren Scientific Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Aaren Scientific, Inc. 401(k) Profit Sharing Plan was established January 1, 1998, in accordance with Section 401(k) of the Internal Revenue Code. It is a defined contribution plan for the benefit of all employees of Aaren Scientific, Inc. (the "Company"). However, the Plan was frozen and stopped receiving contributions from participants, effective January 1, 2016.

Eligible employees must be at least 21 years of age and complete 1,000 hours of service during the Plan year. The Plan's Administrative Committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has the right under terms of the Plan to terminate the Plan subject to ERISA provisions. In the event of Plan termination, participants would become 100% vested in their contributions.

Contributions

Employee contributions to the Plan (voluntary contributions) are deferrals of the employee's compensation made through a direct reduction of compensation in each payroll period. The maximum tax deferred contribution may not exceed the IRS limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Upon enrollment in the Plan, a participant may direct employee contributions in various investment options. Participants may change their options at any time. The Company may elect to make a matching contribution equal to a participant's elective deferral during the year. Also, the Company may make a discretionary profit-sharing contribution to be allocated to each participant. There were no Company matching or profit-sharing contributions in 2024.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions and employer contributions plus actual earnings thereon.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Payment of benefits

Benefits are payable to participants or designated beneficiaries upon retirement, termination, death, hardship, disability, or in-service if the participant has attained age 65. In addition, a terminated participant may also elect to transfer into an individual retirement account all amounts which qualify as a rollover under the provisions of the Internal Revenue Code of 1986, as amended. Benefits are recorded when paid.

Hardship withdrawals

Participants may withdraw their elective deferral contributions in the event of hardship as defined by the Plan agreement.

Administrative expenses

A portion of the administration costs of the Plan are paid by the Company.

Forfeitures

Amounts of nonvested matching and profit-sharing contributions revert to the Company and may be used to reduce future matching and profit-sharing contributions or pay plan expenses. No forfeitures were used to reduce Company contributions or pay administrative expenses during the year ended December 31, 2024. At December 31, 2024, there is no balance in the forfeitures account.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

As a result of the management's approval of the Plan's termination (see Note 9), the Plan adopted the liquidation basis of accounting effective May 19, 2022. This basis of accounting is considered appropriate when, among other things, liquidation of a Plan is imminent. The Plan is expected to liquidate in 2025 as all Plan assets will be distributed to participants. Effective with the Plan's termination, all participants with an account balance remaining in the Plan will become fully vested in all contribution sources.

Investment contracts held by a defined contribution plan are required to be reported at fair value under the liquidation basis of accounting. At December 31, 2024 (in liquidation) and 2023 (in liquidation), the Statements of Net Assets Available for Benefits presents the fair value of the fully benefit-responsive investment contract (see Note 4).

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of events that affect the financial statements. Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued. See Note 10 for disclosure of subsequent events.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Company of America and Empower Trust Company, LLC, the custodians of the Plan, have certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets held at December 31, 2024.

NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price, as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Guaranteed investment contract: Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract includes certain restrictions that could impact the ability to collect the full contract value. However, none of these restrictions have become applicable due to the imminent Plan termination. All participant balances are eligible for distribution at contract value. As such, the contract will be presented at fair value using Level 2 input in accordance with the liquidation basis of accounting.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. INCOME TAX STATUS

The Plan document is a Great-West Trust Company Defined Contribution Prototype Plan and Trust with an Internal Revenue Service (IRS) opinion letter dated November 14, 2022, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt and has no income subject to unrelated business income tax. The Plan's annual return /report of employee benefit plan filings for the past three years are subject to examination by tax authorities and may change upon examination.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Empower Annuity Insurance Company of America, the Plan's recordkeeper. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive investment contract (Key Guaranteed Portfolio Fund) Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. However, the contract is included in the financial statements at fair value in accordance with the liquidation basis of accounting. Contract value, which approximates fair value for this investment, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plans prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

Contract value of the Key Guaranteed Portfolio Fund as of December 31, 2024 and 2023 was \$2,078 and \$1,427, respectively.

NOTE 9. PLAN TERMINATION

On May 19, 2022, management approved a plan to terminate the Plan and determined liquidation is imminent. As a result, the Aaren Scientific, Inc. 401(k) Profit Sharing Plan used the liquidation basis of accounting to present the 2024 and 2023 financial statements.

NOTE 10. SUBSEQUENT EVENT - PLAN TERMINATION

On April 15, 2025, the Plan Sponsor approved the termination of the Plan. The Plan's termination is in accordance with the applicable provisions of the Plan document and ERISA. As of the date the financial statements were available to be issued, not all plan assets had been distributed to participants. The Plan's termination is expected to be complete in October 2025.
