Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Navy Mutual Aid Association Employee's 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

Years ended December 31, 2024 and 2023

Note A - Description of Plan

The following description of the Navy Mutual Aid Association Employee's 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective May 1, 1997 and most recently restated on January 1, 2018. Employees of the Navy Mutual Aid Association (the Association or Plan Administrator) become eligible to participate upon the participant's date of hire, and are enrolled within the Plan as soon as administratively feasible following their date of hire, as defined by the Plan document. Effective January 1, 2019, part-time, temporary or seasonal employees are not eligible for the Plan unless the individual works at least 1,000 hours of service or employment status changes to full-time. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute an amount equal to, but not less than one percent up to 100% of their eligible compensation, as defined by the Plan document, for the contribution period, subject to Internal Revenue Service (IRS) limits. Plan participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 3.5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Automatically enrolled participants have their deferral rate annually increased by 1% up to a maximum of 6% unless the participant elects to change their contribution rate. Participant contributions are recorded in the period during which the Association makes payroll deductions from the participant's earnings.

The Association makes contributions, which match the amount contributed by a participant, up to a maximum of 3.5% of the participant's annual eligible earnings. The Association may also make discretionary or qualified nonelective contributions, which would occur annually. To be eligible for the discretionary contribution, participants must be hired on or after January 1, 2018, with at least one year of service. The Association made a discretionary, nonelective contribution, at a rate of 7% of eligible compensation, in the amount of \$586,369 for the year ended December 31, 2024 and \$553,993 for the year ended December 31, 2023 for eligible participants. Participants direct the investment of the Association's contributions into various investment options offered by the Plan.

Notes to Financial Statements (Continued)

Note A - Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Association's contributions and Plan earnings or losses. Earnings or losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Participant and Association contributions are allocated as directed by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions, rollover contributions, Association matching contributions, and Association qualified nonelective contributions. Participants do not vest in Association discretionary contributions until they have attained three years of service, after which participants are 100% vested in Association discretionary contributions, subject to the applicable provisions of the Plan agreement.

Benefit Payments

On termination of service, participants with a vested account balance of \$5,000 or less will have their vested account balance automatically distributed from the plan. If the participant has not yet attained the age of 65, the Plan will automatically roll the participant's vested account less than \$5,000 balance into an IRA account. Participants with a vested account balance greater than \$5,000 may elect to receive either a single sum payment equal to the value of the vested portion of their account, a distribution in the form of lump sum, installment payments, or a combination of these payment options. Prior to termination, upon attainment of age 59½, a participant may withdraw any part of his/her vested account. In addition, a participant may withdraw vested funds, subject to Plan restrictions, in the event of a financial hardship. Distributions are subject to the applicable provisions of the Plan agreement.

Notes Receivable from Participants

Participants may borrow up to a maximum of \$50,000, or 50% of their vested account balance. The minimum amount of any loan is \$1,000. A participant may have no more than one outstanding loan at a time, and no more than two loans may be approved in any 12-month period. Participants must repay general-purpose loans within five years. Longer repayment periods are allowed for loans used to purchase a primary residence. The loans are secured by the balance in the participant's vested account and bear interest at a rate commensurate with similar loans from commercial lending institutions, as defined within the Plan agreement. Loans are considered defaulted when a participant fails to make any required loan payments of principal and interest within a 90-day grace period from their due date. Defaulted loans are recorded as distributions and excluded from the ending loan balance.

Note A - Description of Plan (Continued)

Forfeitures

Forfeited accounts are used to reduce transactions in the following order of priority: (a) first to pay Plan expenses; (b) then to reduce employer matching contributions, (c) then as discretionary additional matching contributions, if any. There were no forfeited non-vested balances as of December 31, 2024 and 2023. Forfeitures used to reduce transactions during the year ended December 31, 2024 and 2023 were \$112,267 and \$0, respectively.

Note B - Summary of Accounting Policies

Basis of Accounting and Use of Estimates

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) for benefit plans. The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Investment Valuation and Income Recognition (continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

The Plan values mutual funds based on quoted values of the shares held at year end.

Collective Trust Funds

Collective trust funds are valued based on the net asset value of the collective trust divided by the number of trust units outstanding. Investments in collective trusts are typically valued, as a practical expedient, utilizing the net asset valuations provided by the underlying private investment companies and/or their administrators, without adjustment, when the net asset valuations of the investments are calculated in a manner consistent with GAAP for investment companies. Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy and are shown as a reconciling item.

Collective trust funds consist solely of the Principal Stable Value Z Fund (Fund). The Fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The Fund has the objective of preserving capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plan or participant payments.

There are no restrictions on redemption on the collective trust funds. There are no unfunded commitments on the collective trust funds.

Pooled Separate Accounts

Pooled separate accounts are valued at net asset value (NAV) per share based on the fair values of the underlying investments when the net asset valuations of the investments are calculated in a manner consistent with GAAP for investment companies. Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy and are shown as a reconciling item.

Notes to Financial Statements (Continued)

Note B - Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition (continued)

Each pooled separate account includes a transfer restriction applicable to all participant directed transfers, which allows for one transfer per 30 day period. Once the number for allowed transfers out is met, participants are not allowed to transfer back into the same investment option until the holding period elapses.

There are no unfunded commitments on the pooled separate accounts.

Notes Receivable from Participants

Participant loans are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is reported within interest and dividend income. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Association. Expenses that are paid by the Association are excluded from these financial statements. Transaction charges for loan and benefit payment transactions are paid by the Plan by reducing the balances of those participants initiating the transactions. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has performed an evaluation of subsequent events through September 25, 2025, which is the date the financial statements were available to be issued and has considered any relevant matters in the preparation of the financial statements and notes.

Note C - Certified Financial Information

As of December 31, 2024 and 2023 and for the years then ended, the Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (Principal).

Note E - Related Party and Party in Interest Transactions

Certain Plan investments are invested with Principal, the custodian and insurance company of the Plan, or its affiliates. These transactions qualify as party in interest transactions. In conjunction with their management, certain administrative fees are paid out of plan assets to Principal and included in administrative expenses. The Plan Administrator directly pays certain other fees related to the Plan's operations. Investment related expenses are paid to Principal and are included in net appreciation of fair value of investments. Additionally, personnel and facilities of the Plan Administrator have been used to perform administrative functions for the Plan at no charge to the Plan.

Note F - Plan Termination

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive the balance of their account.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

Note H - Tax Status

The Plan adopted a non-standardized pre-approved plan that received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan Administrator believes that the Plan is qualified and therefore, the related trust is exempt from taxation. The Plan Administrator has concluded there are no uncertain tax positions as of December 31, 2024 and 2023 in accordance with GAAP.
