Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matters – Supplemental Schedules Required by ERISA***

The supplemental schedules of Schedule H, Line 4a – Schedule of Delinquent Participant Contributions and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Heritage Commerce Corp 401(k) Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established on September 1, 1994 and restated as of October 1, 2015, to provide eligible employees of Heritage Commerce Corp ("the Company" or "Employer") with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code. All employees 18 years of age or older are eligible to participate in the Plan. The Board of Directors of the Company control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: Participants may contribute up to 100% of their pre-tax salary, as defined in the Plan, subject to certain Internal Revenue Code limitations. Effective April 1, 2015, participants may contribute after-tax Roth contributions. The Company may, at its discretion, make matching contributions, discretionary profit sharing contributions, and Qualified Non-Elective Contributions ("QNEC"). Matching contributions in 2024 and 2023 were based on a dollar-for-dollar basis to a maximum of \$3,000 per participant. The Company did not make any other discretionary contributions in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts: Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution and an allocation of the Company's matching contributions, discretionary profit sharing contributions, QNEC, and plan earnings and are charged with withdrawals and an allocation of plan losses and administrative expenses. Earnings or losses of each investment fund are allocated to that fund's participants in proportion to each participant's share of fund assets. Participants are entitled to the benefit that can be provided from the participant's vested account.

Investments: Participants direct the investment of their contributions, as well as the corresponding Company matching contributions, discretionary profit sharing contributions, and QNEC, into various investment options offered by the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions, plus actual earnings thereon, and any matching contributions made by the Employer. Employer discretionary profit-sharing and QNEC contributions vest at a rate of 25% per year of service.

Notes Receivable from Participants: Participants may borrow from their vested fund accounts a minimum amount of \$1,000 up to a maximum amount of \$50,000 or 50% of their vested account balance, whichever is less. The loan term may not exceed five years except where the loan is for a home purchase, in which case the maximum term is 30 years. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at the time funds are borrowed, which ranged from 4.25% to 9.50% at December 31, 2024 and December 31, 2023. Principal and interest is paid ratably through payroll deductions.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$1,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or in installment payments over a 10-year period. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Forfeitures: The forfeiture account is used to reduce the administrative fees paid by the Plan, and then to reduce the Employer nonelective contributions. There was \$34,418 and \$14,590 in the forfeiture account at December 31, 2024 and December 31, 2023, respectively.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Costs of administering the Plan are paid by the Plan or the Company. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income/(loss) reported by the Plan. Expense credits from American Funds are reported as negative expenses in the year the credit was earned.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, liquidity, credit and market risks, including global events such as the

coronavirus pandemic. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs.

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - FEDERAL INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by American Funds Distributors, Inc. American Funds Distributors, Inc. received an opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). Plans that adopt prototype documents are no longer required to file for an individual determination letter. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income tax have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Employer, and certain others. The Plan holds shares of mutual funds managed by American Funds. American Funds is the Plan recordkeeper and, therefore, these transactions qualify as party-in-interest transactions. Payment of investment management fees to American Funds also qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 6 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation(depreciation) in fair value of investments, and interest and dividends for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company.

**NOTE 7 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 6, 2025, which is the date the financial statements were available to be issued.
