Opinion

The following description of the Pearson Dental Supplies, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document, restated effective July 1, 2022, and any amendments for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan established on January 1, 1998 by Pearson Dental Supplies, Inc. ("Company") to provide benefits to eligible employees. The plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Plan Administration and Expenses

The Company appointed a 401(k) Plan Investing Committee to manage the Plan operation. Actuarial Benefits Plan is the third-party administrator that maintains the records of participant data. Empower Annuity Insurance Company of America ("Empower") and John Hancock Life Insurance Company serve as recordkeepers of Plan assets. Certain officers of the Company serve as trustees of the Plan.

Fund operating expenses and management and administrative fees are charged directly to the fund and are factored into each fund as a reduction of investment return. Other costs incurred for administering the Plan may be paid by the Plan or the Company at the direction of the Plan Investing Committee.

C. Eligibility

The Plan covers substantially all employees of the Company age 21 or older except for leased employees, non-resident aliens, self-employed individuals and those covered by a collective bargaining agreement. Effective July 2022, employees become eligible upon completing one month of service. Plan entry is the first day of the quarter after attaining eligibility.

D. Participant Contributions

Participants may elect to have the Company contribute up to 100% of their eligible pre-tax compensation to the Plan, subject to applicable Code limits. Participants of age 50 or older may elect to make additional catch-up contributions up to \$7,500 annually for 2024. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation. Participants may make post-tax contributions as Roth contributions to the Plan. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans.

E. Employer Contributions

The Company is allowed to make discretionary matching and profit sharing contributions, as defined in the Plan. No discretionary matching or profit sharing contributions were made for the year ended December 31, 2024.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, and an allocation of Company contributions, if any, and the participant's share of Plan earnings or losses and expenses. Participant accounts are invested based solely on a participants' direction.

G. Vesting

Participants are immediately 100% vested in their contributions, rollovers and related earnings. Participants vest in Company contributions and related earnings allocated to their accounts, if any, over six years. Company contributions are vested as follows:

H. Notes Receivable from Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan is \$1,000. The interest rate will be determined from time to time by the Plan Trustee with the intention of providing the Plan with a return commensurate with the interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Until otherwise determined by the Plan Trustee, the interest rate will be the prime rate of interest published by banks as of the date of the loan plus two percent. The rate of interest will be constant throughout the term of the loan. Loans must be repaid within five years, except for loans for the purchase of a principal residence may be repaid over a period not to exceed 20 years.

I. Forfeitures

Any portion of a participant's account that is not vested shall be forfeited as of the date of distribution of the vested portion. Forfeitures will be used to reduce administrative expenses and Company contributions. At December 31, 2024 and 2023, \$1,168 and \$284, respectively, in unallocated forfeitures were held partly in cash, and the remainder in investments. There were no forfeitures in 2024.

J. Payment of Benefits

Normal retirement date under the Plan is age 65 or the fifth anniversary of plan participation. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may choose to leave his or her account balance in the Plan or to receive vested benefits in a lump sum or installments. Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Investing Committee to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Participants select how their share of plan assets will be invested among those investment vehicles made available.

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

D. Risks and Uncertainties

Plan investments include a variety of securities that are exposed to various investment risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date, which will be treated as the valuation date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments offered under the Plan are issued by the recordkeepers or their affiliates. Transactions in these funds, while considered party-in-interest transactions under ERISA regulations, are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 1, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in the financial statements.
