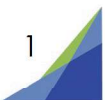
### Basis for Opinion

### Responsibilities of Management for the Financial Statements

### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

#### NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of Accounting** - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

**Investments Valuation and Income Recognition** - AFGE Employees 401(K) Plan (the Plan) investments in mutual funds are stated at quoted market values (except for fully benefit-responsive investments contracts, which are reported at contract values). Quoted market value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by its investment advisers and custodians. Purchases and sales of securities are recognized on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully benefit-responsive contracts are valued at contract value. The Plan's guaranteed income account with Mass Mutual is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less funds used to purchase annuities and pay administration expenses charged by Mass Mutual. Contract value is the amount participant would normally receive if they were to initiate permitted transaction under the terms of the Plan.

**Payment of Benefits** - Upon termination of service due to death, disability, retirement or termination of service due to other reasons, a participant or the participants' estate or beneficiary will receive a lump-sum amount equal to the value of the participants' vested interest in the participants' account or an annuity. Partial, systematic and hardship withdrawals are permitted by the Plan, subject to Plan provisions and Internal Revenue Service (IRS) guidelines.

**Loans to Participants** - Loans to participants are carried at their unpaid principal balances, plus any accrued and unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Contributions to the Plan** - Participants may elect to contribute to their participant accounts via payroll deductions; all amounts withheld as of year-end but not yet transferred to the Plan at that date, if any, are recorded as receivable.



## NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Each year, participants may make voluntary contributions to the Plan on a before tax basis up to the maximum allowed by the Internal Revenue Service (IRS). The contribution limit for 2024 under Internal Revenue Code (IRC) was \$23,000 for participants under age 50 plus a \$7,500 catch up contribution for those 50 or older.

**Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## NOTE 2. DESCRIPTION OF THE PLAN

The Plan was established June 11, 1998 by AFGE to provide a retirement plan for its eligible employees effective as of January 1, 1998. It is a single employer defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. All employees of AFGE may become participants in the Plan immediately upon employment. All employees hired on or after January 1, 2008 are automatically enrolled in the Plan, with contributions of 1% of their compensation. Any employee contributing less than 4% of their compensation will automatically have their contribution increased by 1% each year until it equals 4% or more of their compensation. Each participant may elect to contribute 1% to 15% of their earnings to the Plan. Employees may elect to opt out of the automatic enrollment and automatic increases, change the contribution amount or stop contributing at any time.

During 2014, the Plan sponsor elected to make a new contribution to the Plan to satisfy the legal requirements to be a 401(k) safe harbor plan under the IRC and automatically be treated as satisfying certain non-discrimination requirements under the IRC. This contribution was equal to 3% of each plan participant's compensation during the year.

During the year ended December 31, 2020, the Plan did allow for participants to utilize the aid from the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act). This act provided for Coronavirus-related distributions, increases in loan limits, loan payment suspensions, and changes to the required minimum distribution administration. The Plan adopted Coronavirus-related distributions up to \$50,000, increased loan limits to \$100,000 or 50% of participants vested balance, suspended participant loan payments on outstanding loans and suspended minimum distribution payments in response.



## **NOTE 2. DESCRIPTION OF THE PLAN (CONTINUED)**

Each participant is fully vested with respect to the safe harbor contributions made on his or her behalf. The total amount of safe harbor contributions made during December 31, 2024 and 2023 was \$1,170,092 and \$1,105,183, respectively. The Plan sponsor separately matched employee deferrals to the Plan totaling \$507,469 and \$486,601 during December 31, 2024 and 2023, respectively.

Participants are always 100% vested as to all elective deferrals, rollover contributions, safe harbor employer contributions, employer matching contributions and non-safe harbor discretionary employer contributions. For other contribution types, participants are vested after five years of vesting service. Benefits are generally payable under this plan upon a participant's retirement, death or termination of their employment with AFGE.

Contributions to the Plan are invested as directed by the participant. Participants must evaluate their own investment goals and objectives and choose the mutual funds best suited to achieve those goals and objectives. Poor investment performance by investment vehicles selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Participants may elect to borrow the lesser of 50% of their account balances or \$50,000 from the Plan; these loans are secured by the value of the participants' vested benefit. Such loans must generally be repaid within five years. Each loan is treated as a directed investment of the participant who receives the loan proceeds, and all loan repayments received by the Plan are credited to that participant's account. The loans bear interest at rates established by the Plan administrator, based on a review of prevailing interest rates.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$16,239 and \$12,291, respectively. These accounts will be used to reduce future Sponsor contributions. During the year ended December 31, 2024, \$-0- was used to reduce Sponsor discretionary profit-sharing plan contributions.

Participants should refer to the Summary Plan Description for more complete information.

## **NOTE 3. PRIORITIES UPON TERMINATION**

It is the expressed intention and expectation of the sponsor that it will continue the Plan in full force and effect. However, in the unlikely event of termination, the interests of participants under the Plan shall be non-forfeitable to the extent funded. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the beneficiaries and participants. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.



## NOTE 4. TAX STATUS

In a letter dated February 20, 2015, the IRS stated that an employer who adopts this plan will be considered to have a plan qualified under IRC Section 401 (a). The Plan has been amended since the receipt of the determination letter; Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. As of December 31, 2024, the statute of limitations for tax years 2021 through 2023 remains open with the U.S. federal jurisdiction in which the Plan files returns.

## NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted market price of shares held by the Plan at year end.

## NOTE 6. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan invests in a fully benefit-responsive guaranteed investment contract with MassMutual Retirement Services (MMRS). The fully benefit-responsive investment (SAGIC) is held by MMRS in a separate account. The SAGIC is a general investment account guarantee that provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market and that is backed by MMRS. SAGIC is a fully benefit-responsive general investment account contract. Under the contract a crediting rate is established for a six-month period of time and all assets invested in the account are credited with that rate. At the expiration of each rate period, a new crediting rate is declared. Mass Mutual assumes market, credit, and interest rate risks for the assets supporting the account.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by MMRS, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract with participants are unlikely to occur.

MMRS is an affiliate of the Trustee, as defined by the Plan and, therefore, transactions between Mass Mutual and its affiliate qualify as party-in-interest transactions.

## NOTE 8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
