## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Hornblower Group Contracted Employees 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Hornblower Group Contracted Employees 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedule Required by ERISA**



## **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023**

### ***Note 1*** **Description of Plan**

The following description of the Hornblower Group Contracted Employees 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### **General**

The Plan was established effective June 1, 2020, and is a defined contribution and profit-sharing plan that covers certain eligible employees of Hornblower Group, Inc. and certain affiliates as defined in the Plan document (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan transfers occur in the normal course of plan operations between the Plan and Hornblower Group, Inc. and all Affiliates 401(k) Plan due to changes in employee's union and non-union status.

#### **Administration**

Fidelity Management Trust Company (Fidelity) is the Plan's trustee, custodian, and third-party administrator.

#### **Employee Participation**

An employee is eligible to participate in the Plan on the first day of the month following completion of a 3-month consecutive period of employment with the Company and having attained the age of 21. The Plan excludes employees who are non-resident aliens, leased employees, and employees covered under the Hornblower Group, Inc. and all Affiliates 401(k) Plan. The Plan was amended effective June 1, 2023, to update Plan eligibility to include interns.

For purposes of Prevailing Wage Contributions, any Government Contract employee is eligible to participate on the date of hire and will enter the Plan on that date.

#### **Contributions**

Under the provisions of the Plan, eligible participants may contribute up to 100% of their compensation as defined in the Plan document in the form of pre-tax or Roth contributions, subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions to the Plan. Employees will be automatically enrolled in the Plan upon meeting eligibility criteria with an initial pre-tax deferral contribution of 3%.

The Company makes matching contributions for certain employees covered under collective bargaining agreements. For the year ended December 31, 2024, the matching contribution for Deckhands and Captains was 4% and 3%, respectively.

### ***Note 1* Description of Plan - Continued**

#### **Contributions - Continued**

The Company may make discretionary matching contributions. The Company did not make any discretionary matching contributions for the year ended December 31, 2024.

The Company may make discretionary nonelective matching contributions subject to additional service requirements. The Company did not make any discretionary nonelective matching contributions for the year ended December 31, 2024.

The Company will make a nonelective prevailing wage contribution on behalf of each participant who performs services subject to the Service Contract Act, Davis-Bacon Act or similar Federal, State, or Municipal prevailing wage statute. The prevailing wage contribution shall be equal to a dollar amount to be determined each year under Prevailing Wage Law.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, and investment earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is equal to the value of the participant's vested account balance.

#### **Vesting**

Participants are immediately vested in their elective, rollover, and prevailing wage contributions, plus actual earnings thereon.

Vesting in the Company's matching contributions for certain employees covered under collective bargaining agreements vary. A participant is 100% vested upon: (1) disability; (2) death; or (3) normal retirement at age 65. If a participant's employment with the Company is terminated before age 65 for any reason other than disability or death, the participant shall be entitled to an amount equal to the "vested percentage" of their account balance. A participant shall have a vested and nonforfeitable interest in the employer's contribution portion of their account balance determined by the number of years of credited service. Captains are 100% vested immediately while Deckhands are subject to the following vesting schedule:

#### **Vesting - Continued**

Vesting in the Company's discretionary matching and discretionary non-elective contributions is based on years of continuous service. A participant shall have a vested and nonforfeitable interest in the employer's contribution portion of their account balance determined by the number of years of credited service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
1	33%
2	66%
3 or More	100%

#### **Payment of Benefits**

The Plan provides for normal retirement benefits upon reaching the age of 65 and has provisions for in-service, hardship, disability, death, and termination benefits for those participants who are eligible to receive such benefits. The plan also allows required minimum distributions upon attaining age 73. In general, a participant's account shall be distributed to the participant as a lump sum or installment payments. If the value of the terminating participant's vested account balance does not exceed \$7,000, the participant's balance will be distributed automatically at that time.

#### **Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the excess of the highest outstanding loan balance in the previous 12 months or (b) 50% of their vested account balance. The notes are secured by the balance in the participant's account. The interest rate paid by the participant is determined by the Administrator based on the prevailing interest rate. General purpose loans have terms of up to five years. Loans for a participant's principal residence have terms of up to 15 years. Loans are repayable in installments through payroll deductions or in accordance with procedures provided by the Plan Administrator. A participant may not have more than one loan outstanding at any time.

#### **Forfeited Accounts**

As permitted by the Plan document, forfeiture accounts will be used to reduce plan expenses or reduce employer contributions other than prevailing wage contributions. During the year ended December 31, 2024, no forfeitures were used to pay plan expenses or reduce employer contributions. Forfeited non-vested accounts totaled approximately \$6,711 and \$3,850 at December 31, 2024 and 2023, respectively.

#### **Administrative Expenses**

Expenses of the Plan can be paid directly by the Company or by the Plan.

### ***Note 2* Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Notes Receivable from Participants**

Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Risks and Uncertainties**

The Plan invests in investment securities which are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as inflation, a pandemic, or international conflict. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Subsequent Events**

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.

### ***Note 3* Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

### ***Note 3* Investment Valuation and Income Recognition - Continued**

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: These investments are valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

Common/Collective Trusts: Valued at NAV based on the underlying assets of the trust. The NAV is used as a practical expedient to estimate fair value. The fair value of the underlying assets is obtained from information provided by the investment advisor using the audited financial statements of the common/collective trust at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023**

### ***Note 4*** **Tax Status**

The Plan adopted a non-standardized pre-approved plan sponsored by FMR LLC. FMR LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, as to the pre-approved plan's qualified status. The opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***Note 5*** **Certified Information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4I – schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity (including interest and dividend income and net appreciation in fair value of investments), and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### ***Note 6*** **Party-In-Interest**

Certain Plan investments are managed by an entity related to Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, transactions involving these assets qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

### ***Note 7*** **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes 100% vested and the net assets of the Plan will be distributed as prescribed by ERISA.

### ***Note 8*** **Bankruptcy**

On February 21, 2024, Hornblower Holdings LLC, a California corporation, and its subsidiaries (collectively, the Debtors), commenced cases under Chapter 11 of Title 11 of the United States Code (the Bankruptcy Code) in the U.S. Bankruptcy Court for the Southern District of Texas. On March 18, 2024, the Debtors filed the Fifth Amendment Joint Plan of Reorganization of Hornblower Holdings LLC and its debtor affiliates pursuant to Chapter 11 of the Bankruptcy Code (the Bankruptcy Plan). On June 7, 2024, the Debtors entered their findings of fact, conclusions of law, and order (I) approving the Debtors' disclosure statement of a final basis and (II) confirming the Third Amendment Joint Chapter 11 plan of reorganization of Hornblower Holdings LLC and its debtor affiliates, which approved and confirmed the Bankruptcy Plan. On July 3, 2024, the Debtors completed their financial restructuring process and emerged from their Chapter 11 bankruptcy. On September 3, 2024, the Bankruptcy Plan became effective in accordance with its terms and the Debtors emerged from the Chapter 11 cases.
