Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Buffini & Company 401(k) Profit Sharing Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

(1) Description of the Plan

The following description of the **Buffini & Company 401(k) Profit Sharing Plan** (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The **Buffini & Company 401(k) Profit Sharing Plan** was established on January 1, 1999, to enable eligible employees to share in the Company’s earnings and permit employees to make pre-tax contributions to the Plan; thereby, providing employees with an opportunity to accumulate funds for their retirement.

The Plan is a defined contribution plan established and sponsored by **Buffini & Company** (“Company”). The Plan covers substantially all employees of the Company and is administered by the Company.

Participants in the Plan may choose to have their voluntary and employer contributions allocated among twenty-five investment alternatives. There are no non-participant directed funds.

Eligibility

An employee is eligible to participate in the Plan upon completing six consecutive full calendar months of employment, as defined in the Plan agreement. Eligible employees are automatically enrolled at the beginning of each quarter.

Contributions

Each participant may elect to contribute to the Plan up to the lesser of 1% to 99% of eligible compensation or the maximum allowed by the Internal Revenue Service for the portion of the Plan year in which the employee was a participant.

The Company makes a discretionary contribution in an amount equal to 50% of the participant’s elective deferral, with the contribution not to exceed 5% of the participant’s eligible compensation. The Company suspended the employer match contribution effective January 1, 2024.

In any year that a discretionary contribution is made, the contributions are allocated pro rata as a uniform percentage of participant compensation. A participant is eligible to receive a discretionary contribution if the participant is employed with the Company on the last day of the Plan year and has completed 1,000 hours of service during that year.

Notes to Financial Statements

(1) Description of the Plan, Cont'd

Vesting

The portions of the participant's account attributable to elective deferral contributions and rollover contributions are 100% vested and non-forfeitable. A year of service is defined as a twelve-month computation period during which 1,000 hours of service are performed. Employer contributions vest 20% after one complete year of service, as defined in the Plan agreement, and an additional 20% for each complete year of service thereafter until fully vested. Non-terminated participants become fully vested at their normal retirement date, upon their death or disability.

Forfeitures

Unvested amounts forfeited by terminated participants may first be used to pay administrative fees of the Plan. Any remaining amounts are applied to future employer contributions. During the Plan year ended December 31, 2024, there were approximately \$17,900 of forfeitures used to reduce employer contributions. During the Plan year ended December 31, 2023, there were approximately \$18,700 of forfeitures used to reduce employer contributions.

Allocations

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Allocations are based on the ratio that each eligible participant's elective deferral bears to the total elective deferrals of all eligible participants subject to certain limitations. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant loans

The Plan allows participants to borrow against their vested balances. Loans may not be made for less than \$1,000 and may not exceed the lesser of \$50,000 or 50% of a participant's vested balance. Loan repayment periods may not exceed five years except loans used to acquire a principal residence. In such case, the loan repayment period will be determined by the Plan administrator.

The Plan's administrator determines the loan interest rate based upon the prime rate (as specified in the Wall Street Journal) plus 1%. Principal and interest payments are paid to the borrower's account through after-tax payroll deductions.

Benefit payments

The Plan provides for benefits to be distributed in a lump sum, or installments over a certain number of years, upon termination, at death, or the normal retirement age of 65, as soon as administratively practical after severance from employment. Benefits are recorded when paid.

Participants may withdraw any or all of their contributed account balances at any time during the Plan year provided certain hardship conditions, as defined in the Plan, have been met.

(1) Description of the Plan, Cont'd

Plan expenses

Plan expenses may be charged against forfeitures. The remainder of expenses is then paid by the Company. No administrative expenses were paid from forfeitures during the Plan year.

Plan termination

While the Company has not expressed any intent to terminate the Plan, in the event of such a termination, the Plan agreement provides that the participants' accounts become fully vested and non-forfeitable upon termination of the Plan, and then will be distributed.

(2) Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Basis of accounting

The Plan uses the accrual basis of accounting in conformity with U.S. generally accepted accounting principles ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for the Stable Value Fund which is reported at net asset value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(2) Summary of Significant Accounting Policies, Cont'd

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation and participant compensation is earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to measurement.

(3) Fair Value Measurements, Cont'd

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Stable Value Fund is valued at NAV. A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Investment income

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the value of its investments which consists of the realized gains or losses on sale of investments and the unrealized appreciation or depreciation of those investments. Interest income is recognized when earned. Dividend income is recorded on the ex-dividend date.

(4) Information Prepared and Certified by the Plan's Trustee (Unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Trustee

At December 31, 2024 and 2023, Plan assets were held by Ascensus Trust Company (the "Trustee") who is responsible for the maintenance of all accounting records and the preparation of reports of activity related to those assets. The Trustee has certified to the Plan administrator the completeness and accuracy of the financial information and data presented in December 31, 2024 and 2023 statements of net assets available for benefits and in the statement of changes in net assets available for benefits for 2024. Financial information included in the accompanying financial statements is based on the information provided by the Trustee.

Investments

Total investments as of December 31, 2024 were \$33,103,224.

Dividend income

Dividend income was \$593,141 for 2024.

Notes receivable from participants

Interest income from notes receivable from participants was \$11,019 for 2024. The outstanding balance of notes receivable from participants was \$137,799 and \$156,250 as of December 31, 2024 and 2023, respectively.

Net appreciation of investments

The value of the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated \$3,574,502 during 2024.

(5) Tax Status

The Plan is a non-standardized prototype plan. The non-standardized prototype plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, indicating that the Plan and related Trust satisfy the requirements of Section 401(a) and 501(a), respectively, of the Internal Revenue Code of 1986, as amended (the "Code"). The Plan is required to operate in accordance with the Code to maintain its tax qualification. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan's financial statements prior to 2019 are no longer subject to examination.

(6) Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Vanguard Fiduciary Trust Company. Vanguard is the custodian of the Plan and therefore, these transactions qualify as party-in-interest transactions.

Certain Plan assets are invested in Trustee accounts. Certain members of management are fiduciaries of the Plan and are also participants in the Plan. These transactions qualify as party-in-interest transactions.

(7) Pending Distributions

There were no Plan assets allocated to participants who had elected to withdraw from the Plan as of December 31, 2024.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

(9) Subsequent Events

The Company has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

Effective January 15, 2025, the Company reinstated the employer match contribution.
