Opinion

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations (prepaid) of The Tatitlek Corporation Health & Welfare Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits and changes in plan benefit obligations (prepaid) for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTE 1 - Description of the Plan

The following description of The Tatitlek Corporation Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established on December 1, 2012 to provide health and other benefits to eligible participants. The sponsoring employer, The Tatitlek Corporation, has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, life and supplemental accident benefits for eligible participants and their dependents. The Plan provides many of these benefits with 3rd party insurance companies contracts and on a self-funded basis. The Plan carries a stop-loss insurance policy, which covers both specific claims in excess of the deductibles as specified in the contract. The Plan also provides Health Reimbursement Arrangement (HRA) benefits. The HRA benefit is self-funded and allows employees to be reimbursed for certain out of pocket health benefits incurred by participants.

Eligibility rules under the Plan require all employees hired as active employees to receive coverage the first of the month following one month of continuous employment on a fringe contract. Benefits terminate on the last day of the month in which a participant's employment terminates.

Eligible employees will receive an allocation to a separate retirement plan with the remaining rate after deducting \$4.41 from the fringe rate. Eligible employees who waive medical and/or ancillary benefits will receive an allocation at a rate ranging from \$0.13 to \$3.78 and from \$0.30 to \$3.93 per hour worked for December 31, 2024 and 2023, respectively. These retirement contributions are reported as contribution income and then deducted as an expense.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

Concentration of credit risk for cash:

For business purposes, the Plan maintains cash balances at Partners Bank of California, which exceed the \$250,000 insurance provided by the Federal Deposit Insurance Corporation. Amount in excess of the \$250,000 insurance limit as of December 31, 2024 and 2023 were \$204,591 and \$130,055, respectively. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Benefit Claims Payable

The obligation for benefit claims payable is an estimate for self-funded benefits incurred on or prior to December 31, but paid after December 31. The estimate was calculated based on a review of actual claims paid subsequent to year-end, with incurred and received dates of December 31, and prior.

Benefit Claims Incurred, But Not Reported

The obligation for benefit claims, incurred but not reported is an estimate for self-funded benefits incurred on or prior to December 31, but reported to and paid by the Plan after December 31. The estimate was calculated using available claims experience data and projected future claims.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through September 2, 2025, the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Excess Loss Indemnity Policy

The Plan has entered into an excess loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan maintained an insurance policy with Fidelity Security Life Insurance Company during the year ended December 31, 2024 and 2023. The policy contains two excess loss provisions. The first of which applies to individual participant claims, whereby when the claims paid on behalf of an eligible participant or dependent exceeds \$100,000, during a policy year, respectively, the insurance carrier will reimburse the plan for 100% of the excess. The second provision involves aggregate plan claims, whereby when the total aggregate claims paid on behalf of all eligible participants or dependents exceed a specified amount based on the number of eligible participants and rate factors ("funding factor"), the insurance carrier will reimburse the Plan 100% of the excess up to a maximum aggregate amount of \$1,000,000, less the amount reimbursed for individuals under the specific individual policy noted above. During the year ended December 31, 2024, there were reimbursements from the insurance company in the amount of \$75,457.

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processor pay claims directly to or on behalf of participants which are funded by the Plan up to the funding factor and thereafter by the excess loss carrier as noted above. Despite the Plan's utilization of their-party claims processors, ultimate responsibility of payments to providers and participants is retained by the Plan.

Due to Stop-loss Insurance Carrier

During 2024, the Plan received advanced funding for aggregate claims that exceeded the employer funding factor amounts to cover current claims. At the end of the policy run out period, the plan may only retain those advance for eligible claims paid in excess of the plan's funding factor. As a result of these advance, it is estimated that the plan will refund the insurance carrier \$30,000.

NOTE 4 - Health Reimbursement Arrangement (HRA) Benefits

The Plan provides health reimbursement arrangement (HRA) benefits to eligible participants. A participant's account balance is funded by employer contributions and allows employees to be reimbursed for eligible out of pocket health benefits incurred by participants. Included in the accompanying statement of net assets are amounts available to provide HRA benefits as of December 31, 2024 and 2023, both totaling \$0. HRA benefits terminated in 2023 and the runout for processing prior year claims ended on March 31, 2023.

NOTE 5 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. receives commissions and reimbursement of administrative fees from the Plan's insurance carriers of approximately \$89,468 and \$77,280 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.

NOTE 6 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax years ended 2024 or 2023, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
