Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Triangle Manufacturing Co., Inc. Savings and Investment Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Triangle Manufacturing Co., Inc. Savings and Investment Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Triangle Manufacturing Co., Inc. Savings and Investment Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 Description of the Plan

The following description of the Triangle Manufacturing Co., Inc. Savings and Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Triangle Manufacturing Co., Inc. (the “Company” or “Employer”) who have attained age 18 and have one month of service. The Plan pays retirement benefits based on participants’ contributions and contributions from the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Employee and Employer Contributions

Each employee (also referred to herein as “Participant”) of the Company, who has met eligibility requirements, as defined, may contribute to the Plan and elect to defer a percentage of their compensation, as defined, on a pre-tax basis (“Elective Deferrals”) or after-tax basis (“Roth Elective Deferrals”), not to exceed the maximum allowable under the Internal Revenue Code (“IRC”) for any plan year (\$23,000 for 2024). Participants who have attained the age of 50 before the end of the plan year are eligible to make a catch-up contribution of \$7,500 for 2024. Unless an opt-out form is filled out, each employee who has met eligibility requirements, as defined, will be automatically enrolled into the Plan at 4%. Additionally, the Plan will increase deferrals by 1% of compensation up to a maximum of 10% compensation for participants who are automatically enrolled. The increase will be applied as of the first period that begins after the period in which the initial deferral amount was withheld and the first day of each calendar year thereafter. At the discretion of the Plan Administrator, participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans and individual retirement accounts.

The Company determines, on an annual basis, a discretionary employer matching contribution to the Plan. For the year ended December 31, 2024, the Company matched 50% of the amount contributed by employees with a limit of 6% of the participants’ eligible compensation, as defined, on a pay period basis. Participants are eligible to receive a matching contribution after they have completed one month of service.

In addition, the Employer may make discretionary profit-sharing contributions to the Plan. Employer discretionary contributions are allocated based on compensation in relation to all eligible participants. Participants are eligible to receive a profit-sharing contribution after they have completed one year of service. The Company did not make discretionary profit-sharing contributions to the Plan for the year ended December 31, 2024.

Note 1 Description of the Plan (continued)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants become vested with respect to employer matching contribution and profit-sharing contribution in accordance with the following schedule:

Investment Options

The participants' contributions and the Company's matching contributions are allocated to the various investment options offered by the Plan as the participant directs. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the employer matching contribution, profit sharing contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50% of their vested account balance or (b) \$50,000. The maximum number of loans that a Participant may have outstanding at one time is one. Note repayments are made ratably through bi-weekly payroll deductions, with repayment terms ranging from up to 5 years or up to 30 years if for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at a reasonable rate determined by the Plan Administrator by reviewing the rates charged for similar types of loans by other lenders. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024 and 2023, the annual interest rates ranged from 4.25% to 9.50%.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant may elect to receive benefit payments either in one lump-sum or partial withdrawals equal to the value of the participant's vested interest in his or her account. If the value of the vested account balance is less than \$5,000, the Plan may automatically distribute it.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Except for insurance company general account, the Plan’s investments are reported at fair value as reported on the last business day of the Plan year. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as a benefit payment, reducing the notes receivable from participants balance, based upon the provision of the Plan Document.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Expenses incurred in the operation of the Plan are paid from the Plan unless allocated to and paid by the Company. The expenses are allocated among the accounts of all participants in the Plan. Expenses that are paid by the Company are excluded from the Plan’s financial statements. The cost to set up loans, distributions, and maintenance are charged to the Participants’ account. Certain investment-related expenses are included in net appreciation of fair value of investments.

Note 3 Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023.

The following is a description of the valuation methodology used for assets measured at fair value.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common collective trust: Valued based on NAV of the units held by the Plan at year end, which is used as a practical expedient to approximate fair value. The NAV per unit is calculated daily and is based on the underlying investment held by the trust.

Note 3 Fair Value Measurement (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 Information Prepared and Certified by the Custodian and Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, Reliance Trust Company.

Note 5 Tax Status

The Plan is an adoption of the ADP, LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/ CODA Plan for which the Internal Revenue Service ("IRS") has determined and informed ADP, LLC by an opinion letter dated October 6, 2020, that the Pre-Approved Plan was designed in accordance with the provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan has not taken any uncertain tax positions during the year ended December 31, 2024.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances including employer contributions and the net assets will be allocated as prescribed by ERISA.

Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 Party-In-Interest Transactions

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, certain fees are paid from the Plan’s assets and therefore qualify as party-in-interest transactions. Certain Plan investments are shares of mutual funds and common collective trust managed by Reliance Trust Company. Reliance Trust Company is the Trustee and ADP Retirement Services (“ADP Retirement”) is the recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. If the revenue received by ADP Retirement for investment management services from mutual funds exceeds the fees due under the Master Plan Services Agreement between the sponsor and ADP Retirement, ADP Retirement remits the excess to the Plan’s trust. Those amounts may be applied to pay Plan administrative expenses or allocated to participant accounts.

The Plan makes loans to participants and therefore, these transactions qualify as party-in-interest transactions.

Note 9 Reconciliation of Financial Statements to Form 5500

The Plan files its Form 5500 on the cash basis of accounting.
