## **INDEPENDENT AUDITOR’S REPORT**

### **The Administrative Committee of The Hydrogen Group, LLC 401(k) Plan**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Hydrogen Group, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements. (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the 2024 Financial Statements section-

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of The Hydrogen Group, LLC. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General: The plan is a single employer defined contribution plan covering all full-time employees of The Hydrogen Group, LLC (the Company) and its wholly owned subsidiaries who have one year of service, minimum age 21, and minimum 1,000 hours of service annually. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was established on September 1, 2020. All investments are participant directed.

Participant Contributions: Each year, eligible participants may contribute to the Plan up to 90% of pre-tax annual compensation, up to a maximum amount determined by the Internal Revenue Service (\$23,000 for 2024 and \$22,500 for 2023). The Plan allows all participants who have attained age 50 before the end of the Plan year to make catch-up contributions in accordance with Section 414(v) of the Internal Revenue Code (\$7,500 for 2024 and 2023). The Plan allows participants to make two kinds of contributions; pre-tax elective deferrals and Roth elective deferrals. Participants may also contribute amounts representing distributions, or roll-overs, from other qualified retirement plans.

Company Contributions: The Company may make voluntary matching contributions to the Plan at the discretion of the Company's Board of Directors. Eligible participants must make elective deferrals to the Plan to receive matching contributions. Additionally, the Company may, at the discretion of its Board of Directors, make a nonelective contribution to the Plan. The nonelective contribution is allocated to all eligible participants.

Participant Accounts: Each eligible participant's account is credited with the participant's salary reduction contributions and allocations of the Company's contributions, if any, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their fund accounts, a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in The Wall Street Journal on the 14<sup>th</sup> of each month, plus two percentage points. Principal and interest are paid through payroll deductions over a period not to exceed five years unless the loan is used to purchase a primary residence. Loans used to purchase a primary residence must be repaid within a period of no more than thirty years.

Vesting: Participants are 100% vested attributed to the salary deferrals including Roth 401(k) deferrals, employer matching contributions, and employer profit sharing contributions and rollover contributions. Upon termination for any reason other than death, disability or retirement, a participant shall be entitled to entire amount of his account balance derived from profit sharing contributions, including employer contribution.

Payment of Benefits: Upon termination of employment, participants with vested portion of their accounts account balances less than \$5,000 will receive their distribution in a lump sum as soon as administratively feasible. If upon termination of employment with a vested account balance that exceeds \$5,000, the Plan will commence distributions to the participant in the manner elected by the participant and allowed by the Plan. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installment amounts equal to the participant's vested interest in his or her account.

On termination of service upon retirement at age 65, and five years of credited service, a participant with an account balance over \$5,000 may elect to receive either a lump sum amount equal to the participant's vested interest in his or her account, installment payments or monthly annuity payments. If the participant's account balance does not exceed \$5,000, it will be distributed in a lump sum.

The Plan allows financial hardship distributions caused by certain events as defined in the Plan.

Forfeited Accounts: Participants who terminate their employment forfeit their unvested balances to the Plan. At December 31, 2024 and 2023, there are no forfeited non-vested accounts.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Such estimates relate primarily to the valuation of investments not traded on an established market. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Cash Equivalents: All highly liquid investments with a maturity of six months or less are considered to be cash equivalents.

Investments Valuation and Revenue Recognition: Investments are reported at fair value, except for fully-benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

**NOTE C – FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal market for the asset or liability in an orderly transaction between market participants on the measurement date. U.S. GAAP establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

U.S. GAAP prescribes three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets or liabilities, which are considered to be most reliable.

Level 2 - Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 - Unobservable inputs reflecting the reporting entity's own assumptions, which require the most judgment.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are traded on a national securities exchange and are stated at the last reported sale or settlement price on the day of valuation.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan at any time subject to the provisions set forth in ERISA and the Internal Revenue Code. Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.

Administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses for the Plan are paid directly by the Company.

**NOTE F – INCOME TAX STATUS**

The Plan has adopted a prototype plan which received an advisory letter from the IRS which stated that the prototype plan is designed in accordance with the applicable section of the IRC. In Accordance with Revenue Procedures 2017-6 and 2011-49, the Company has determined that it is eligible to and has chosen to rely on the current advisory letter. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, is exempt from federal income taxes.

**NOTE G – SUBSEQUENT EVENTS**

In preparing the financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 2, 2025, the date that the financial statements were available to be issued.
