We have performed audits of the financial statements of San Antonio Wings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE A – DESCRIPTION OF PLAN

The following description of the San Antonio Wings, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: San Antonio Wings, Inc. 401(k) Plan is a defined contribution plan which was formed and became effective on January 1, 2017. The Plan covers virtually all employees of San Antonio Wings, Inc. (the Plan Sponsor) who have one year of service and have attained age 21. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan Amendment: The Plan has operationally adopted certain provisions allowed by the Bipartisan Budget Act of 2018, the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act), and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act). These provisions changed the Plan to, among others, allow participants receiving hardship withdrawals to immediately continue their elective deferral contributions to the Plan, allow certain eligible individuals to receive coronavirus-related distributions, suspend required minimum distributions, and delay the commencement date for required minimum distributions. Written amendments to the Plan to reflect these operational changes were formally adopted in July 2023.

The Plan sponsor changed custodian and third-party administrator and adopted a Plan with ADP Retirement Trust Services, LLC on November 1, 2024. The Plan updated some provisions, as noted below.

Contributions: Participants may contribute to the Plan as allowed by the Internal Revenue Code and the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor may elect to contribute a matching contribution, the amount of which is determined by the Board of Directors and allocated based on each participant's contributions. Participants also direct the investment of any matching contribution received. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts, plus actual earnings thereon is based on years of service. A participant is 100% vested after three years of credited service.

Forfeitures: Forfeitures are retained in the Plan and may be used to pay for administrative expenses, allocated to the remaining participants or used to offset employer contributions. Forfeited non-vested accounts totaled \$24,022 at December 31, 2024 and \$21,725 at December 31, 2023.

Participants' Notes Receivable: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan at a time. Loan terms range from 1 month to 5 years, unless for purchase of a primary residence, in which case loan term is 30 years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: On termination of service a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of time as detailed in the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Secure 2.0 Act: The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. The Plan Sponsor is evaluating the provisions and has not amended the Plan as of the date of these financial statements other than the amendment of January 1, 2023 which added auto-enrollment and auto-escalating deferrals.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of San Antonio Wings, Inc. 401(k) Plan (the "Plan") are prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Investment Valuation and Income Recognition: Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian.

Investments in the guaranteed interest contracts (collective investment trusts) are carried at contract value which represents net contributions plus interest at the contract rate. The contracts are fully benefit-responsive.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefit payments are recorded when paid.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE C – INVESTMENTS CERTIFIED BY THRID PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, plan investments at December 31, 2024 and 2023, and the related investment earnings for the years then ended, were certified and held by ADP Retirement Trust Services, LLC and Nationwide Financial Services, Inc., the Trustees, and were not audited by the independent auditor.

NOTE D – INCOME TAX STATUS

The Plan received its most recent favorable opinion letter from the Internal Revenue Service on October 6, 2020, and although it has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified for tax exempt status. The Plan Administrator is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

As of the date of the audit report, the Plan has not completed its required discrimination testing for the year ended December 31, 2024.

NOTE E – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan includes certain investments managed by ADP Retirement Trust Services, LLC., the Plan Custodian. Therefore, these transactions qualify as party-in-interest transactions. The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed for in the Plan document. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE G – PROHIBITED TRANSACTIONS

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan had contributions from 2024 totaling \$6,384, all of which represented employee salary deferrals, that were not remitted timely. These contributions are considered prohibited transactions. The Plan Sponsor will calculate lost earnings and expects to reimburse the Plan for the lost earnings in 2024.

NOTE H – GUARANTEED INTEREST CONTRACT

The Plan held group fixed annuity contracts in the Invesco Stable Asset Fund (Invesco Fund) and the Nationwide Fixed Account (Nationwide Fund) as of December 31, 2024 and 2023. Contract value of the Invesco Fund was \$35,820 at December 31, 2024 and \$0 at December 31, 2023. Contract value of the Nationwide Fund was \$0 at December 31, 2024 and \$13,273 at December 31, 2023. Both funds maintain contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed interest contracts are fully benefit-responsive and are stated at contract value, the relevant measurement. Contract value, as reported to the Plan by the funds, represents contributions made under the contract, plus earnings less participant withdrawals. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact a contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan Sponsor that cause a significant withdrawal from the Plan, or (3) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring. The contract will continue in force until all assets have been distributed, or no further payments are due.

NOTE I – FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
